## HOUSE BILL NO. 250 RELATING TO FARM TO SCHOOL PROCUREMENT

Chairperson Woodson and Members of the Committee:

Thank you for the opportunity to testify on House Bill 250. The bill facilitates the increase of locally grown and locally raised food products from Hawaii farmers, ranchers, and food producers and will allow school complexes to regionalize their menus. The Department offers comments.

The 2008 Farm Bill allowed child nutrition program operators to use a geographic preference when procuring locally grown and locally raised unprocessed agricultural products. The Department comments that HB 250 aligns with our call-to-action "Buy Local, It Matters" campaign that leads to farmers, ranchers and producers scaling up to meet the demand this bill intends to create. However, the 2008 Farm Bill provides that the schools define what is local for schools using a geographic preference when sourcing food for the federal child nutrition program.

As such, the Department defers further comment to the Department of Education. Thank you for the opportunity to testify on this measure.

The Administration of the Office of Hawaiian Affairs (OHA) will recommend to the Board of Trustees <u>SUPPORT WITH AMENDMENTS</u> for HB250, which would require the Department of Education to adopt rules for the procurement of goods and services related to the administration of food programs at public schools that incorporate geographic preference for unprocessed locally grown and locally raised agricultural products. OHA offers its recommendation to enhance this measure by incorporating an 'ai pono (healthy eating/lifestyle) requirement as an instrument to further address disparities faced by Native Hawaiian students in the State's institution of education.

Nā Pou Kihi ("The Corner Posts") is a Hawaiian framework for achieving social and health equity<sup>1</sup> at a time of ever-worsening health inequities and disparities faced by the Native Hawaiian people.<sup>2</sup> Native Hawaiians are afflicted with chronic disease at a rate three times higher and a decade earlier than the general population of Hawai'i.<sup>3</sup> Native Hawaiians have the shortest life expectancy in their own homeland.<sup>4</sup> The four interconnected corner posts of Nā Pou Kihi are Ke Ao 'Ōiwi (Indigenous Cultural Space), Ka Mālama 'Āina (Environmental Stewardship), Ka Wai Ola (Social Justice), and Ka 'Ai Pono (healthy consumption) – together, they support an interwoven protective canopy over a collection of ideals that give hope to a people in great need; ideals, like food sovereignty, cultural relevance, and increased access to our traditional foods.

OHA is the principal public agency in the State responsible for the performance, development, and coordination of programs and activities relating to Native Hawaiians.<sup>5</sup> OHA supports the thrust of this measure to "facilitate the increase of locally grown and locally raised food products from Hawai'i farmers, ranchers, and food producers[, while allowing] school complexes to regionalize their menus" and offers this recommendation to advance this measure even further as a mechanism of much needed socio-economic change

### ``§302A - Food program; procurement; geographic preference;

<u>exemption.</u> (a) The department shall adopt rules pursuant to chapter 91 for the procurement of goods and services related to the administration of food programs at public schools that incorporate a geographic preference for unprocessed locally grown and locally raised agricultural, and traditional agricultural products.

For Native Hawaiian health and well-being to vastly improve, positive systemic change must occur, because the systems that have negatively impacted our existence, are often beyond our sole control. Even smallest adjustments have the capacity to open pathways for monumental change.

OHA appreciates this opportunity to **support with amendments HB250** and **asks the** Legislature to consider our recommendation for the betterment of the health and well-being of the Native Hawaiian people. Mahalo nui loa.

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> House Bill No. 250, RELATING TO FARM TO SCHOOL PROCUREMENT.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This measure, as received by your Committee, would require the Department of Education (DOE) to adopt rules for the procurement of goods and services related to food programs at public schools that incorporate geographical preference for unprocessed, locally grown and locally raised agricultural products.

Because the State purchases so much food for the daily operations of public schools, it is prudent and essential for government to spend its limited resources within the State to ensure that these funds are circulated through local businesses and communities. The COVID-19 pandemic has greatly exacerbated the need for a bill like this. Our over-reliance on tourism has weakened our ability to respond to unforeseen economic downturns. The only way for us to protect ourselves from the next global pandemic or catastrophe is for Hawaii to diversify its economic base and become more self-sufficient. On behalf of the North Shore Economic Vitality Partnership (North Shore EVP), I would like to extend support for HB 250, which will facilitate the increase of locally grown and locally raised food products from Hawaii farmers, ranchers, and food producers and allow school complexes to regionalize their menus.

Since 2016, North Shore EVP has been working to prepare farmers to fully and equitably participate in Hawaii's commercial and institutional markets by providing food safety training and certification through our USDA GroupGAP program. Although the Department of Education (DOE) currently does not have procurement guidelines for locally sourced produce, food safety certification should be a qualifying criterion for any farm selling products to our schools. Currently less than 2% of Hawaii's farms have obtained food safety certification and in some regions of the state the DOE would be hard pressed to identify growers that could provide the quantity and consistency of products needed to fulfill the geographic preferences identified in this bill.

We support the intent of this bill but ask that the procurement policies and procedures created under this bill provide adequate time for farms to acquire the necessary food safety certification that may be required for them to participate in the farm to school program

Aloha Chair Woodson, Vice-Chair Marten, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HB 250,** which requires the department of education to establish rules for the procurement of goods and services related to the administration of food programs at public schools that incorporate a geographic preference for unprocessed locally grown and locally raised food products.

HFB strongly supports the increased use of locally grown agricultural products, fruits, vegetables, meats, dairy, and poultry products in our schools.

In 2009, the State enacted ACT 175 which gave Hawai'i agricultural products a price preference and included Hawai'i agricultural products under the State's procurement code. HFB believed that agricultural producers' price preference for bidding presented a competitive advantage. This included enjoyment of the small business preference rule that permits an agency to identify certain contracts for competition among small businesses or requires a large business to subcontract with small businesses to provide the products. We believed that the preference helped cultivate a level playing field with out-of-state bidders and created additional market opportunities for Hawai'i's farmers and small businesses.

HFB suggested the changes because farmers and ranchers were having a difficult time entering into state supply contracts. During our involvement with this process, it became clear that education at all levels, not just within our group of farmers and ranchers, but even within the procurement office, was needed. Although HFB attempted to move everyone in this direction, the training was never accomplished. In previous sessions, there have been measures proposed to remove the preference and ease the process required for governmental bodies to acquire local agricultural commodities by exempting Hawai'i agricultural producers from the procurement code. This would change the current code back to where it was before HFB's requests to the Legislature modified the language, resulting in the current code. When bills were introduced that would revert to exempting locally-grown agricultural products from the procurement code, HFB requested clear metrics to help determine the success of the procurement code with the exemption.

Many formal and informal studies have been done addressing farm-to-school programs. Our farmers and ranchers have tried to work with the procurement system and can speak to the shortcomings of the system. For example, supplying a school or schools within a geographic area is feasible. Providing to the entire school system is not. The focus should now be on working with the procurement system to make institutional markets accessible while considering the capacity of farmers and ranchers in Hawai'i. Assistance to farmers on how to navigate the system should also be a priority.

The proposed geographic preference will provide the flexibility that should help increase the purchase of more locally-grown agricultural products, fruits, vegetables, meats, dairy, and poultry products for our Farm to School program.

HFB is committed to working with the department of education to implement a procurement program that will allow Hawai'i farmers and ranchers to source more products for Hawai'i's Farm to School program.

I work as a newly hired Farm to Early Childhood Education (ECE) Coordinator for the statewide Farm to School Hui. As part of my job, I am in regular conversation with preschool providers, administrators, ohana (including kūpuna), farm hub directors, food producers and farmers - and by virtue of this work, have a special vantage point on the importance of the mandates included in the HB250 law.

The geographic preferences written into this law are vital for ensuring local food production and consumption in our state. It is a major step toward weaning ourselves from dependence on imported food and can boost local food systems in myriad economic and cultural manners.

Additionally, in order for the requirements of Act 175 to be satisfied, for HIDOE to procure at least 30% of its food for keiki from local sources by 2030, HB250 is essential legislation that gives the mechanism for that goal to be attained. Without it, "local" could be defined without honoring geographic proximity and, therefore, actual local, place-based food production.

Lastly, as an educator and advocate, it is clear to see the need for healthy, fresh and sustainably raised/prepared food sources for our keiki. Local food based on geographic preferences inherently means less processed food, fresher food, and food that is borne out of our island's traditions and hard work.

I implore you to pass this Bill and demonstrate leadership in returning food soveriegnty and security to the farmers, tradition-keepers, and families of Hawai'i.

Additionally, this bill requires the Hawai'i Department of Education (HIDOE) to post all the contracts rewarded for local food procurement on its website. This requirement is critical in determining the department's compliance with Act 175. Increased procurement of locally grown and raised foods for consumption by Hawai'i's students will positively impact the health of our keiki and the development of s Hawai'i sustainable food systems.

#### Geographic preferences support local farmers.

This bill will enable school complexes to regionalize their meals, supporting local food producers and suppliers on each island. Act 175 requires that the Department of Education procure 30% of the food it serves from local sources by the year 2030. According to the report they submitted to this body last month, they are currently at 6.2%.<sup>iii</sup>

HIDOE cannot reach the 30% goal alone. This project needs to have statewide collaboration to achieve success. Local farmers and

distributors need procurement rules to produce adequate harvests to deliver the volume of locally grown and raised foods to serve the 130,000 plus meals that the HIDOE serves daily.

Dear Chair Woodson, Vice Chair Marten, and members of the Committee:

Thank you for the opportunity to provide testimony in support for **H.B. 250**, which would require the Hawai'i Department of Education (HIDOE) to adopt procurement rules relating to the administration of food programs at public schools that incorporate a geographic preference for unprocessed locally grown and locally raised agricultural products.

The 2021 Hawai'i legislature passed Act 176, SLH 2021, which establishes a farm to school program in HIDOE. House Bill 250 attempts to address a significant concern around achieving the goals set forth in this legislation, by requiring that the Department take advantage of what's known as a "geographic preference" to solicit bids for ingredients for their school meal programs.

The HIDOE breakfast and lunch menus are developed a year in advance to allow time for procurement, which can be a lengthy process. However, there is only one statewide menu for each program, which does not take into account the many regional and cultural food preferences of the children that the HIDOE serves. As a result, the Department currently only solicits and awards bids on a statewide basis to accommodate the statewide menu, precluding the opportunity to source from smaller local farms and vendors, who may not have the ability to supply ingredients for the entire statewide school system.

Thank you for considering these comments in your deliberation of H.B. 250. Hawai'i Appleseed is in full support of the HIDOE farm to school program, as we believe in the importance of good quality food served through our federally-subsidized nutrition programs. We sincerely believe that this legislation will help achieve the intended effect of reaching the state's farm to school goals.

Our family has been on a journey to eat more local food products for many years but during the pandemic, we increased our speed tenfold. We now maintain our own vegetable garden and purchase the remainder of our produce from local farmers markets. Our groceries are down to only about 30% imported. I can tell you that eating unprocessed locally grown and locally raised food products has kept us all healthier and vibrant. The foods we eat are alive and full of mana, not shriveled and half dead from traveling thousands of miles from the continent or South America. We are supporting our neighbors (and the local economy) by buying local farmers' produce, saving the earth the cost of all the fossil fuels burned to fuel the transport of imported foods, avoiding all the plastic packaging that imported foods travel in, and helping to create a more sustainable Hawaii. Its not always convenient or easy, and sometimes it is more expensive, but it is well worth it.
