The Office of Hawaiian Affairs (OHA) offers its <u>SUPPORT WITH AMENDMENTS</u> for HB275 HD1, which would establish a grant program to assist kalo farmers in their kalo operations. OHA asks that the Legislature also require the State of Hawai'i Department of Agriculture, in its adoption of rules for this program, to also take into special consideration the inequities and disparities faced by "socially disadvantaged farmers in Hawai'i," like Native Hawaiian mahi'ai (farmers), and their unique funding needs.

The United States Department of Agriculture (USDA) defines socially disadvantaged farmers and ranchers (SDFR) "as those belonging to groups that have been subject to racial, ethnic, or gender prejudice."<sup>1</sup> The USDA has affirmed that Native Hawaiians are recognized under the SDFR characterization<sup>2</sup> and a number of financial support instruments exist through the USDA for SDFRs.<sup>3</sup> While this distinction and the needs of those within this designation exist at the federal level, the State of Hawai'i has yet to adopt the necessary policies and mechanisms to address inequities and disparities faced by socially disadvantaged farmers and ranchers, like Native Hawaiian mahi'ai. As the principal public agency in the State responsible for the performance, development, and coordination of programs and activities relating to Native Hawaiians, OHA asks this legislature to ensure that Native Hawaiian farmers and ranchers are provided equitable farm assistance opportunities, such as the grants proposed through this measure.

OHA appreciates this opportunity to offer its support with amendments on this measure. Mahalo nui loa.

> HOUSE BILL NO. 275 HD1 RELATING TO TARO

Chair Yamashita and Members of the Committee:

Thank you for the opportunity to present testimony on House Bill 275 HD1. This bill appropriates funds to the Department of Agriculture (Department) to provide grants to Hawaii farming groups to be dispersed to taro farmers. The Department supports this measure and offers the following comments.

The Department respectfully requests deleting the language attributing the finding to the Department on page 2, lines 4 to 6, since it has not published nor issued any statement to that effect. Additionally, on lines 19 to 20, the statement that "taro imports are estimated to soon exceed local production" should be deleted. Current data suggests that imported taro (fresh, chilled, frozen, or dried) in 2021 amounted to only 334,000 pounds. In 2019, pre-pandemic, a total of 454,262 pounds of taro were imported. These amounts are less than 12 percent of local production, and taro imports are statistically unlikely to exceed local production in the near future.

Additionally, the Department respectfully recommends that language on page 4, lines 12 to 14 be amended by deleting "five years" and replacing it with "one year" so

that all taro farmers (new or veteran) have an equal opportunity to access the proposed grant funding.

Finally, the Department supports this measure, so long as it does not adversely impact the priorities identified in our Executive Budget request.
