Chairs Gates and Holt, Vice Chairs Kahaloa and Lamosao, and Members of the House Committees on Agriculture & Food Systems and Economic Development:

The Office of Planning and Sustainable Development (OPSD) **supports** HB 305, which updates the Hawai'i State Planning Act by removing references to the sugarcane and pineapple industries.

When the Hawai'i State Plan was first enacted in 1978, sugarcane and pineapple were the dominant agricultural crops and a significant part of Hawaii's economy. The predominance of these industries was reflected in the Hawai'i State Plan's economic objectives and policies for agriculture, and in the economic priority guidelines. However, sugarcane and pineapple production in Hawai'i has declined significantly since then, but the State Plan has not accounted for this change. By deleting references to sugarcane and pineapple, HB 305 will result in the State Plan better communicating our collective interest in promoting diversified agriculture.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai i Farm Bureau supports HB 305, which updates the Hawaii State Planning Act's economic agricultural objectives and policies and priority guidelines by removing references to the sugarcane and pineapple industries.

The State's Agricultural Functional Plan was last updated in 1991. Since it was last updated, Hawai'i's agricultural industry has transitioned from plantation agriculture to a more diversified agriculture sector. Diversified agriculture in Hawaii includes flowers and nursery products, vegetables and melons, macadamia nuts, cattle, milk, fruits poultry, eggs, forest products, hogs, coffee, taro, ulu, mamaki, cacao, other livestock, and aquaculture.
