HB 396 - RELATING TO HAWAII TECHNOLOGY DEVELOPMENT CORPORATION

Chair Holt, Vice Chair Lamosao, and Members of the Committee:

The University of Hawai'i (UH) supports this bill that appropriates funds to support the Manufacturing Assistance Program (MAP) at the Hawai'i Technology Development Corporation (HTDC).

HTDC's MAP offers Hawai'i-based manufacturers up to a 20 percent reimbursement of up to \$100,000 on qualified expenses to help them become globally competitive. These expenses include: equipment purchases, training, energy efficiency projects, and manufacturing feasibility studies.

The University of Hawai'i shares a similar vision with HTDC to help establish a thriving innovation-based sector to boost the local economy, create jobs and to develop a highly skilled technical workforce. Manufacturing is an important component of this process to help keep these businesses in Hawai'i.

We purchased in 2021 a 3 ply mask machine capable of producing 120 masks per minute which is still in the crate in the FTZ warehouse we are still accumulating cost . Along with a packaging machine and raw material for making 1.5 million masks all for \$105K. However, I did not factor in the impact Covid had on the supply chain issues added with skyrocketing labor and shipping costs due to covid thus our delay.. We just completed putting up a new warehouse which added an additional 100K cash for manufacture after the FTZ no longer allowed manufacturing in its facility. This 20% reimbursement bill would greatly help to get our operations started. Covid will be around for a while and we feel our company is aligned to keep Hawaii safe.

Aloha Chair Holt, Vice-Chair Lamosao, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai**'i **Farm Bureau supports HB 396,** which appropriates funds to the Hawai'i Technology Development Corporation for its manufacturing assistance program.

As expenses rise, increases in farm revenues and profits are critical to the continued viability of farms and ranches. One way farmers can do this is by "adding value" to raw agricultural crops. Currently, off-grade and excess production is sometimes wasted due to market conditions. Converting them into value-added products will not only increase farm revenue but also provide new business opportunities, increase employment opportunities, and address Hawai i's goals of increased self-sufficiency and sustainability.

High production costs are a major driver of narrow profit margins for Hawai'i's farmers and value-added food producers. Labor, taxes, land, transportation, utilities, and supplies are all costs of doing business that often results in value-added food producers just being able to break even.

Hawai'i is potentially losing millions of dollars because of the cost to process agricultural crops into value-added products. HFB supports any program that supports the production of value-added products so that farmers can increase their income while allowing locally produced value-added goods can compete with imported products, strengthening our local economy.

The strength of Hawai'i's economy is dependent upon a diversity in commerce that is resilient to economic downturns and aggressive in creating new growth opportunities. The HTDC manufacturing assistance program supports this goal.

Makai Ocean Engineering, Inc. **STRONGLY SUPPORTS HB396** that makes an appropriation to HTDC to provide grants to businesses through the manufacturing assistance program.

Makai Ocean Engineering, Inc. is a locally-owned and operated technology company based in Hawaii for 50 years. While Makai has historically been an engineering services provider, with the help of the State's manufacturing assistance program, Makai has been able to diversify into lowvolume manufacturing. Makai has been involved in marine-related engineering in Hawaii for 50 years, and began a heat exchanger R&D program in 2009. Now, we are ramping up production from a small manufacturing plant for heat exchangers on the Big Island of Hawaii, which is sustaining approximately 6 highly-skilled, high-paying STEM / engineering jobs in rural Kona. We have a strategic advantage for developing and manufacturing low-volumes of these components in Hawaii for two reasons: the U.S. Navy and Air Force's presence in Hawaii, and Makai already owns and operates a marine heat exchanger test facility and marine corrosion lab on the Big Island. As an example, Makai has been awarded contracts by the U.S. Air Force, U.S. Army, and U.S. Department of Energy to design new heat exchangers for vehicle cooling and renewable energy applications. We hope to continue and scale-up manufacturing units over the coming years.

The program limits reimbursement to 20% of qualified expenses capped at \$100,000. Because they are matching funds, a manufacturer is eligible only if they are already making an investment in the local community and providing jobs. The program amplifies these efforts, and shows the State's support for local manufacturers willing to make the investment and commitment to adding jobs, and growing their businesses and the industry in Hawaii.

This is why we **STRONGLY SUPPORT HB396**, which would provide the state matching funds for manufacturing assistance to enable companies to build a manufacturing base in the islands. Not only would this expansion of funding enable our tech industry to advance manufacturing within the State, it would provide highly-skilled manufacturing jobs for our keiki here at home.

HTDC supports initiatives aimed at growing tech and innovation jobs. The Manufacturing Assistance Program (MAP) provides matching grants and wrap-around support services to local manufacturers who are increasing their capacity to manufacture within the State. The companies provide diverse job opportunites in the State, strengthen our resilience, decrease our dependence on imports, and increase our export capacity. The goals of the program are to increase the number of Hawai'i manufacturers, increase their revenues, and increase the number of jobs in the State.

HTDC has been providing MAP matching grants to manufacturers since FY16. A summary of the awards made by the matching grant program is listed below:

Every year, there have been more qualified applicants than available funds. The funding awarded to companies provides a partial reimbursement (20%) for equipment upgrades and other eligible expenses. Through our federally funded INNOVATE Hawai'i program, HTDC provides

wrap-around support services for the matching grants to help Hawai'i manufacturers become more globally competitive.

In HTDC's economic impact survey conducted in 2019, 54 MAP grant companies reported \$748 million of economic impact with \$425 million of revenue, and 2,387 jobs in Hawai'i.

For the past 16 years I have been part of my family business called La Tour Bakehouse where we provided fresh baked goods for the people of Hawaii. The manufacturing business is tough, with hard manual labor, and razor thin margins, but we understand the importance of having locally made, fresh, quality products available.

In order to thrive we invested in automation to increase our output, which allowed us to compete for large customers like Costco and Hawaiian Airlines. The MAP Grant funding we received allowed us to grow into one of the largest bakeries in Hawaii.

Since then I have become an automation consultant, tasked with helping other small businesses grow, and I see similar hurdles. For a lot of these companies, they cannot find people to do the manual labor so their options are to shut down their business, move to the mainland, or invest in automation. The MAP grant helps de-risk the investment in automation equipment so that companies can stay open and in Hawaii.

The increased sales and profits from these small businesses means the State of Hawaii benefits from both increased GET and State Tax collected. Funding the MAP Grant is a sound decision that helps local companies thrive and provides a solid return on investment to the State of Hawaii.

This program shows the State's support for local manufacturers who are trying to scale their businesses in Hawaii and helps to grow the industry. We are beneficiaries of this service, and it has made us a true force in the bakery industry on Kauai. Since our inception in 2013, we have grown to be the premier cake supplier on Kauai and many businesses and individuals are supported through our efforts. #### In consideration of HB396 RELATING TO HAWAII TECHNOLOGY DEVELOPMENT CORPORATION

Mana Up **supports** HB396 that appropriates funds for the small business innovation research program under the Hawaii technology development corporation–appropriating the sum of \$2,000,000 or so and the same sum or so much thereof as may be necessary to the Hawaii Technology Development Corporation for the **Hawaii Small Business Innovation Research Program** to fund the matching grant for Phase II and Phase III awards to assist companies in getting their product to market.

This bill also appropriates funds for the **Manufacturing Assistance Program**. According to the National Association of Manufacturers, Hawaii has an average of 11,000 manufacturing employees working at 750 manufacturing firms with an output of \$1.66 billion. The MAP grant limits reimbursement to 20% of qualified expenses capped at \$100,000. The program shows the State's support for local manufacturers who are trying to scale their businesses in Hawaii and helping to grow the industry.

This bill also appropriates funds for the **accelerator grant program**. The state has partnered/co-invested/sponsored many of the private sector accelerator programs. This model is an extremely cost-effective way of providing support to emerging Hawai'i businesses. Before the accelerator programs were established in Hawai'i, entrepreneurs had to leave the state to receive this type of capital and business support.

Mana Up is an accelerator and venture fund for Hawai'i-based products growing to markets globally, with the mission to increase economic opportunity and jobs for the

people of Hawai'i. Since launching Mana Up in 2018, we have helped 74 local companies graduate from our six-month accelerator program that provides expansion opportunities and helps solve business challenges. In 2021, we found that over 70% of our Mana Up portfolio companies manufacture their products locally, meaning that a large number of these companies could benefit from this funding.

Investing in HB396 will help Hawaii-based innovators and small local businesses alike to develop new products that can reach global markets. This then creates an opportunity to potentially attract 20x the investment in federal dollars to the State, which can help contribute to further diversifying and expanding our local economy through job creation and dollars generated within the State. In 2021, we found that over 60 of our portfolio companies headquartered here in Hawaii collectively contributed \$60 million to the state economy in annual revenue (generated from their product businesses) and created 415 jobs for locals. This being said, we fully support HB396.
