DEPARTMENT'S POSITION: The Office of Youth Services (OYS) supports this measure and offers comments.

PURPOSE: The purpose of this bill is to establish a pacific youth programs coordinator within the Office of Youth Services. The measure appropriates moneys for one FTE position and programs costs.

The Office of Youth Services manages the Hawaii Youth Correctional Facility (HYCF) and provides and coordinates a continuum of programs and services statewide for at-risk youth and their families to prevent delinquency and reduce recidivism. The OYS manages approximately 60 contracts with community-based organizations, including ten for project-based cultural programs. Most of these contracts prioritize program eligibility to marginalized youth involved in our child-serving systems: including the child welfare and juvenile justice system.

The OYS also manages the National Office of Juvenile Justice and Delinquency Prevention's (OJJDP) Title II State grant. One of the focusses of this grant program is to research and facilitate system changes related to racial and ethnic disparities within our juvenile justice system. Research shows that Pacific Islander youth are overrepresented within our social, behavioral and health systems, including the juvenile justice system and the Hawaii Youth Correctional Facility.

The OYS acknowledges that there is a lack of awareness of, and coordination of, programs and services that exists within our communities, especially for programs working with pacific islander youth and their families. In 2019, to address the lack of awareness of existing programs, the OYS procured a contract for a statewide youth services directory. However, due to budget cuts this contract was terminated in 2020. The OYS did not have the staffing to

further coordinate between these programs on the directory, nor facilitate awareness outreach efforts so that youth, their families, and communities knew where to get assistance. The passing of this measure will address these gaps and provide needed service coordination.

The Office of Youth Services respectfully requests \$218,556 for one FTE Children and Youth Program Specialist V, and program and administrative costs to re-activate a youth services directory and facilitate statewide coordination.

My name is Agnes Malate and I am in full support of House Bill 438 to appropriate moneys and establish one Pacific youth programs coordinator position within the Department of Human Services Office of Youth Services. I immigrated to Hawai'i from the Philippines with my parents and have experienced first hand the challenges adjusting to a new culture and environment. I have also been actively involved with advocating for and providing services to immigrants and migrants from all points of the world, especially during the pandemic.

While working at the University of Hawai'i at Hilo and the University of Hawai'i School of Medicine's 'Imi Ho'ola Post-Baccalaureate Program, I became acutely aware of the severe lack of resources available to Pacific Islander youth and their families. As the Principal Investigator of the GEAR-UP Mānoa project in the early 2010s, I recall meeting with Dole Middle School administrators and how concerned they were about not having the capacity, knowledge, understanding, and resources to meet the needs of the growing number of students and their families.

Having a coordinator to work with Pacific youth is much needed and I ask for your consideration in passing SB 438.

Dear Chair Mizuno, Vice Chair Amato, and Members of the Committee,

The Hawai'i Coalition for Immigrant Rights is in **full support of HB438**, which appropriates funds and establishes one Pacific youth programs coordinator position within the Department of Human Services Office of Youth Services.

HB438 recognizes the critical need for support and services for at-risk youth in Hawai'i. With high rates of youth suicide and dropout, as well as interactions with the criminal justice system, it is evident that the youth of Hawai'i face numerous challenges that requires immediate attention.

Recent reports by Civil Beat and scholars at the University of Hawai'i have found that youth from COFA nations face outsized discrimination and structural barriers to success at school and in the workforce.¹ In order to address these systemic challenges the state must make structural changes that address these inequities and focus resources on the nonprofits and programs that are working directly with the population.

The establishment of a Pacific youth program coordinator within the Office of Youth Services will provide a permanent and dedicated resource to support at-risk youth, especially those from various Pacific Island nations. With this position in place, our State will have a clear point person to coordinate and provide services for our young people and ultimately help to prevent delinquency, reduce the incidence of recidivism, and provide a bright future for our youth from various Pacific Islands.

I am strongly in support of this bill. Pacific Islanders, and Micronesians in particular, have had some major difficulies in our public schools and this bill will try to address some of the issues and problems and problems and problems of alientation that many of these students have experienced.

I have served on the Board of The Legal Clinic with Shanty Asher for a couple of years. She has told me stories of her talks with Micronesian students that have been emotionally very difficult to listen to. Boys have been told that they would not need much of an education because they would just end up being garbage men. Conversely, Micronesians who have done well in school have been told they are too smart to be Micronesian. If the committee has the time and not already done so, I would highly recommend looking up a poem read by Kathy Jetnil-Kijiner, a young Marschallese woman who lived in Hawaii for 17 years. It is entitled, "Lessons from Hawaii," and is readily brought up on YouTube. It is raw, emotional, and leaves one wondering how can this be happening in Hawaii. How much Aloha has been shown to these fellow Pacific Islanders?

This bill will continue the efforts to better integrate our Micronesian brothers and sisters who live in our communities. Positive steps are being made but this bill will give this effort additional momentum and has the potential to make a real difference.
