## H.B. 480, H.D. 1 RELATING TO HIGHWAY SAFETY

House Committee on Finance

The Department of Transportation (DOT) would like to **provide comments** regarding H.B. 480, H.D. 1, which amends the definitions of "special interest vehicle," "street rod replica vehicle," and "street rod vehicle," for purposes of the Hawaii Highway Safety Act, to be based on the age of the vehicle or the parts used, rather than a certain year. Requires vehicles to meet the safety standards that were in effect at the time of manufacture.

The DOT recommends the definition of special interest vehicle be better defined. The DOT also recommends a committee be formed with the four counties comprised of representatives from Motor Vehicle Registration and the Periodic Motor Vehicle Inspection Program to better define special interest vehicles and its requirements.

In reviewing the bill, I find the inclusion of "steet rod vehicle" and "steet rod vehicle-replica" to make the requirements for "special interest vehicles" less clear. Consideration should be given to separating these classes of vehicles from "old cars".

A new paragraph is included as 286-26.5(d)(4) requiring that special interest vehicles "meet the safety standards that were in effect at the time of manufacture". I don't know how that can be determined for older vehicles in particular special interest vehicles manufactured prior to the National Traffic and Motor Vehicle Safety Act of 1966.
