In consideration of HOUSE BILL 562 RELATING TO PERMITS

House Bill 562 proposes to establish an exemption from applicable county permit requirements for repetitive construction projects for facilities under the control of the Department of Education, University of Hawaii, or School Facilities Authority. **The Department of Land and Natural Resources (Department) offers the following comments.**

While the Department supports the intent of the bill, we caution on potential unintended consequences of the proposed legislation. Pursuant to 44 CFR§59.24, State and county participation in the National Flood Insurance Program (NFIP) require floodplain development permits for any work encroaching within Special Flood Hazard Areas (A or V zones) identified on the Federal Emergency Management Agency's (FEMA's) Flood Insurance Rate Maps (FIRMs). Any State or county law that is not consistent with the NFIP jeopardizes our continued eligibility and participation. The unintended consequences of program suspension, include:

- No federal flood insurance can be sold or renewed in non-participating communities.
- Certain forms of Federal Disaster Assistance (including mitigation grants) will not be available in the event of a Presidential Disaster Declaration.

Furthermore, unregulated development within floodplains also increases the risk to life and property from flooding.

Subject: House Bill No. 562 Relating to Permits

The Department of Planning and Permitting (DPP) **opposes** House Bill No. 562 in its present form.

This Bill exempts repetitive construction projects of public school facilities under the control of the Department of Education, University of Hawaii, or School Facilities Authority from any applicable county permit requirements.

The Bill does not define "repetitive construction projects." If the intent is to allow for routine or minor type of work, such as replacement of windows, plumbing fixtures, classroom lighting, etc., within existing school facilities, the scope of the work should be clearly defined. Otherwise, significant projects, such as construction of multiple new classrooms, or the re-grading of different parts of a school campus for various purposes, may be considered exempt "repetitive" work.

Additionally, the Bill may potentially exempt projects subject to the counties' flood protection ordinances enacted under the National Flood Insurance Program (NFIP). The counties are required to review and issue permits to ensure all new or substantially improved development is compliant with the NFIP in order for federal flood insurance to be made available to county residents.

The proposed exemption from permit requirements for projects that may involve new construction or significant addition to buildings, or may include significant alteration of land within a floodplain, will jeopardize the counties' participation in the NFIP, and may result in higher flood insurance rates for the residents, or even suspension of the counties from the program.
