Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I support HB 606, HD1, which requires the department of agriculture, in collaboration with other state agencies, to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by non-profit food distribution services by 7/1/2025.

Across the State, various invasive species are creating havoc in agriculture as well as the ecosystems in which they exist. Maui County's Axis Deer population is a good example of nature getting out of control with populations exploding due to abundant forage following rainfall events. They continue to destroy crops and pasture lands by devouring any living vegetation as they continue to spread. Feral pigs damage crops by consuming them or by their rooting and trampling of crops. They will eat almost any crop. Feral pigs damage pasture grasses, killing desired plant species and often encouraging the growth of undesired weed species. They can also devastate orchards by consuming fruit, citrus, and nuts and their rooting can severely damage, or even kill saplings, shrubs, and vines directly or by facilitating the spread of soil-based fungal diseases. Feral pigs can also break irrigation lines, rip or tear nets, drying racks, and other agricultural structures and equipment.

These and other feral populations can pose a danger, especially as populations grow and their health is put into jeopardy due to inadequate food. Diseases that they normally tolerate will become serious debilitating illnesses that could put our domestic livestock industry in jeopardy. Such fears are not unreasonable, as incidences such as bovine tuberculosis spread from feral pigs have been documented in Molokai.

Hawai'i's farmers and ranchers are working to provide Hawai'i with an increased level of self-sufficiency, but will not be able to do so if their products are consumed or damaged by feral animals. Axis Deer, feral pigs, and other invasive species can cause major damage to property, agriculture (crops and livestock), Hawai'i's native species and ecosystems, and Hawai'i's cultural and historic resources. They can also threaten the health of people, wildlife, pets, and other domestic animals. As Hawai'i's feral animal populations continue to expand, these damages, costs, and risks will only keep rising

Current state law specifically prohibits the inclusion of meats as a donation. Wild game can be a significant source of protein for Hawai'i's residents in need. Wild game can provide a beneficial outlet for meat harvested from invasive species and provide a tool for long-term sustainable invasive management for Axis Deer and Feral Pigs.

Several states have amended their Good Samaritan laws to use them as a tool for invasive white-tail deer management programs. Wild game meat donated under this provision does not need to undergo antemortem inspection requirements as long as stated conditions are met. Conditions for donations can be specified to allow the donation of this important protein source for our neighbors in need. Utah is the most recent state that passed such a measure and can be used as a model for Hawai'i.

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on House Bill 606 HD1. The bill requires the Department of Agriculture, in collaboration with the Hawai'i Interagency Council on Homelessness; Department of Land and Natural Resources, Division of Forestry and Wildlife; and Department of Health, Food Safety Branch, in consultation with the County of Maui Axis Deer Task Force, to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by nonprofit food distribution services by 7/1/2025. The bill also appropriates funds. The Department supports the measure to promote processing and donation of meat in the state.

The Department appreciates that the implementation date of the measure was amended from the initial 7/1/2024 to 7/1/2025 because implementing a plan by 7/1/2024 may be challenging due to the multiple agencies and regulations involved. The department is hopeful this new timeline is achievable however, the department cautions it has recently taken two years to restore a state meat inspection program in another state. DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the measure's intent and provides comments. DHS defers to the Departments of Agriculture, Land & Natural Resources, Health, the County of Maui, and the Governor's Coordinator on Homelessness.

PURPOSE: The bill requires the Department of Agriculture, in collaboration with other state agencies, to develop and implement a plan by 7/1/2025 to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by non-profit food distribution services. Appropriates funds. Effective 6/30/3000.
(HD1)

The HD1 amended the measure by:

- (1) Postponing the date by which the Department of Agriculture must develop and implement the plan from July 1, 2024, to July 1, 2025;
- (2) Changing its effective date to June 30, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

DHS appreciates the Legislature's innovative proposal to increase local food production, mitigate the deer population that impacts the environment, and create a distribution process for the meat to be delivered to under-resourced communities. With food prices in Hawaii continuing to rise, Hawaii's low-income residents need access to affordable quality food. Recipients of Supplemental Nutrition Assistance Program (SNAP) benefits can access more local produce through the "double bucks" program that increases the value of SNAP benefits. In addition, HB 1248 HD1 appropriates funds to the Department of Agriculture for the continued administration of the Hawaii Healthy Food Incentive Program (HHFIP). Taken together, these measures will support low-income residents' food security.


I **support** this measure for the following reasons:

Chair Gabbard, Vice Chair Richards, and Members of the Committee:

Maui County Farm Bureau (MCFB) appreciates this opportunity to testify on this important issue. MCFB is a general agriculture advocacy organization representing farm and ranch families and organizations on the island of Maui.

MCFB STRONGLY SUPPORTS HB 606 HD1, requiring the Department of Agriculture, in collaboration with other state agencies to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by nonprofit food distribution services by 7/1/2025.

Everyone recognizes that we have an axis deer overpopulation problem. In defense, fences are being erected to protect property. However, this does not address the need to reduce populations. Concurrently, there is a public desire to utilize the animals for beneficial use. Other states have developed programs such as "Farmers & Hunters Feeding the Hungry" <https://feedingthehungry.org/> that work and can be utilized as templates for a program for Hawaii.

These programs address the gap between the hunter and distribution to the needy. The process will require coordination as well as development of sustainable funding mechanisms. This proposal seeks to develop such a working group. A side benefit from this effort will be addressing the need for additional meat processing capacity in Hawaii, especially for multi species needs of our smaller farmers and ranchers. Cattle past their prime processing time loses value. Currently ranchers often suffer significant loss waiting for processing opportunity. Maui has a hog processing plant that will cease when the current operator retires due to conditions of the land use permit. Expansion of processing capacity will help address this problem.

Covid demonstrated the need for smaller plants. Federal funding is available for CIP needs while programs such as Feeding the Hungry provide templates for long term operation. Hawaii needs a long term strategy to manage feral wildlife populations. This is a step in that direction. MCFB respectfully requests your strong support of this measure and assistance in identifying workable strategies.

HB 606 HD1 includes a very important aspect in addressing the problem which is development of grassroots support. The measure defines the process by which the program is to be developed, recognizing the role of the various parties. It additionally addresses funding needs.

Axis Deer, scientific name: axis axis, are an important species in the ecosystem of their habitat. Axis deer, which are sometimes known as chital, are native to Sri Lanka, parts of India and Nepal. This species of deer was first introduced to Hawaii as a gift from King Kamehameha in 1867. The gift-givers were from Hong Kong, then a colony of Britain. The deer were initially released on Molokai, and they multiplied quickly; some were later moved to Oahu, Lanai and, eventually, in 1959, to Maui.

Being herbivores, axis deer eats various species of plants. In some forests, green plants are held in check by this animal. Without the deer in the ecosystem, some plants might overpopulate. Like every species, the Axis Deer has an unique contribution to the earth's ecosystems. In other ecosystems other than Hawaii where Axis deer are food for another species of animals, the loss of this species would result in a decrease of a key source of food. The deer has no predators in Hawaii, either; none of the wolves, big cats, terrestrial snakes or alligators that prey on them in Asia.

Axis deer responds to the alarm calls of other animals such as the Common myna bird and langurs (a species of monkeys). The myna bird is often attracted to the deer. Langurs & the deer species have an interesting relationship. The deer benefits from the monkey's eyesight and ability to post a lookout from trees, while the monkeys benefit from the deer's strong sense of smell,

both of which help keep a check on potential danger. The deer also benefits from the fruit dropped by the monkeys from trees.

Although many people like to complain about Axis Deer and it can be labeled as an "invasive species", ROAR strongly urges the legislature to convene working groups to conduct studies about the positive impact of this species. In many international jurisdictions and here within the United States, laws & resolutions are being enacted to protect animals by recognizing animals as "sentient beings". Legally, this protects animals from abuse & exploitation. Also, as animals are being recognized by law as "sentient beings", the tendency and preexisting notion to view animals as just property or not valuable is now being challenged. Advocates from New Zealand say, this "sets a new standard for society's expectations of the ways animals are treated [by] focusing on positive welfare states and . . . enhancement". Also, jurisdictions like Quebec "took the symbolic step of lifting animals out of the property paradigm, a classification that has historically provided for their exploitation as commodities. This affirmation has ushered in a similar shift in Brussels, whose Parliament unanimously enshrined animals' sentient status. Whereas animals were once "object[s], included in the category of property and immobile goods," the ordinance has transformed them into 'living beings' endowed with sensitivity, interests of [their] own and dignity, that benefits from special protection." For these reasons, ROAR is in strong opposition of exploiting the Axis Deer for hunting purposes or for food.



Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

The Hawaii Cattlemen's Council **supports HB606 HD1** which requires the department of agriculture, in collaboration with other state agencies, to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by non-profit food distribution services.

Expanding access to processing and allowing for the donation of wild game to under-resourced communities allows us to feed these communities high quality sources of protein, while also creating an outlet for efforts to remove invasive species such as deer, goat, sheep, and pigs from the environment. Unmanaged ungulates damage our ecosystems and cause detriment to farming and ranching operations. Expanding access to meat processing will help us to meet both environmental and social needs.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I support HB 606, HD1, which requires the department of agriculture, in collaboration with other state agencies, to develop and implement a plan to expand the meat processing capacity in the State to allow for meat from axis deer and other wild game to be processed for distribution by non-profit food distribution services by 7/1/2025.

Across the State, various invasive species are creating havoc in agriculture as well as the ecosystems in which they exist. Maui County’s Axis Deer population is a good example of nature getting out of control with populations exploding due to abundant forage following rainfall events. They continue to destroy crops and pasture lands by devouring any living vegetation as they continue to spread. Feral pigs damage crops by consuming them or by their rooting and trampling of crops. They will eat almost any crop. Feral pigs damage pasture grasses, killing desired plant species and often encouraging the growth of undesired weed species. They can also devastate orchards by consuming fruit, citrus, and nuts and their rooting can severely damage, or even kill saplings, shrubs, and vines directly or by facilitating the spread of soil-based fungal diseases. Feral pigs can also break irrigation lines, rip or tear nets, drying racks, and other agricultural structures and equipment.

These and other feral populations can pose a danger, especially as populations grow and their health is put into jeopardy due to inadequate food. Diseases that they normally tolerate will become serious debilitating illnesses that could put our domestic livestock industry in jeopardy. Such fears are not unreasonable, as incidences such as bovine tuberculosis spread from feral pigs have been documented in Molokai.

Hawai‘i’s farmers and ranchers are working to provide Hawai‘i with an increased level of self-sufficiency, but will not be able to do so if their products are consumed or damaged by feral animals. Axis Deer, feral pigs, and other invasive species can cause major damage to property, agriculture (crops and livestock), Hawai‘i’s native species and ecosystems, and Hawai‘i’s cultural and historic resources. They can also threaten the health of people, wildlife, pets, and other domestic animals. As Hawai‘i’s feral animal populations continue to expand, these damages, costs, and risks will only keep rising

Current state law specifically prohibits the inclusion of meats as a donation. Wild game can be a significant source of protein for Hawai‘i’s residents in need. Wild game can provide a beneficial

outlet for meat harvested from invasive species and provide a tool for long-term sustainable invasive management for Axis Deer and Feral Pigs.

Several states have amended their Good Samaritan laws to use them as a tool for invasive white-tail deer management programs. Wild game meat donated under this provision does not need to undergo antemortem inspection requirements as long as stated conditions are met. Conditions for donations can be specified to allow the donation of this important protein source for our neighbors in need. Utah is the most recent state that passed such a measure and can be used as a model for Hawai'i.
