Department's Position:

The Hawaii State Department of Education (Department) supports HB 69, HD1, and offers comments on this measure.

The Resources for Enrichment, Athletics/Academics, Culture, and Health (REACH) program provides critical, developmentally-aligned out-of-school time (OST) opportunities to public middle and intermediate public school students at no cost to their families. In school year 2022-23, REACH has provided funding to 42 public and charter middle and intermediate schools, supporting roughly 6,250 students. As interest in the REACH OST program continues to increase, the need far exceeds the current \$500,000. With the proposed increase in REACH funding, there is an opportunity for the 33,000 middle/intermediate school students attending Hawaii's 87 public and charter schools to participate in high-quality, school-based OST activities.

By the 6th grade, educators can predict the likelihood of a student graduating from high school based on dimensions such as school-day attendance, behavior, and academic performance. The investment in high-quality after-school programs like REACH has been shown to improve and enhance school-day student outcomes such as attendance and social and emotional development.

Hawaii's adolescents need educational experiences that address their physical, cognitive, social-emotional, and psychological developmental characteristics in culturally sustaining and

affirming ways. Further, these young adolescents need supportive initiatives and programs that provide developmentally appropriate learning experiences and environments, such as the REACH after-school program that extends learning beyond the school day, when students may be unsupervised.

The Department appreciates the appropriation to expand its after-school programs provided it does not adversely affect the priorities identified in the Department's Hawaii State Board of Education approved budget.
