In consideration of HOUSE BILL 701 RELATING TO POHOIKI BOAT RAMP

House Bill 701 proposes to appropriate funds to dredge the Pohoiki Bay Boat Launch Ramp. The Department of Land and Natural Resources (Department) strongly supports this measure, provided that its passage does not replace or adversely affect the priorities identified in the Executive Budget request, and offers recommendations.

The Department estimates that \$40 million will be required to accomplish dredging of Pohoiki Boat Ramp. The Department has been informed by the United States Federal Emergency Management Agency that a portion of this \$40 million will be reimbursed by federal matching funds, but the amount of federal matching funds has not yet been determined because the project is still under review by the involved federal agencies.

Due to the amount of funding needed for this project, the Department notes that the Legislature may desire to fund the project through the Capital Improvement Project (CIP) budget rather than through a general fund appropriation.

Finally, the Department notes that the appropriation language currently states that the Department of Transportation will receive the funding. This language and CIP funding, if any, should be corrected to state that the Department of Land and Natural Resources will receive the funding.

Aloha, Chair Ichiyama, Vice-Chair Poepoe, and Esteemed Members of the Committee on Water & Land:

I write in strong support of Bill HB701 that appropriates funds to dredge the boat ramp at Pohoiki bay in the Puna District on Hawai'i Island, and further support the findings that removing the volcanic debris and re-opening the Pohoiki boat ramp is vital to the health and well-being of the Puna community of whom I humbly serve and represent as Council Member.

The Pohoiki Boat Ramp was rendered inaccessible as a result of lava debris and black sand accumulating during the 2018 Kīlauea eruption. Prior to the eruption, this boat ramp was one of the most productive fishing grounds in the State, helping with food security and driving our local economy. Since the ramp is buried, our lawai'a must trailer their vessels to Hilo (\sim 30 miles) or Nā'ālehu (\sim 70 miles) to launch and access their fishing spots; this adds substantial time, costs, and inequity to each fishing journey.

I appreciate the State's investment in a contractor to explore ways to re-open the bay. A pathway forward has been identified, but securing State funds to match FEMA dollars is critical to implementing a solution that helps our Puna lawai'a get back into the water - *in Puna*. This will greatly enhance our subsistence lifestyle, commercial fishing operations, revitalize the economy, and boost our ongoing eruption recovery efforts.

Aloha Honorable Chair Ichiyama, Honorable Vice-Chair Poepoe, and members of the Committee on Water and Land:

The County of Hawai'i is grateful for the opportunity to testify in support of HB701, a bill for an act relating the appropriation of funds to dredge the boat ramp at Pohoiki Bay, in the district of Puna. The 2018 Kīlauea eruption changed the landscape of lower Puna and its coastline. One example of this is Pohoiki where a new black sand beach has blocked the district's only boat ramp. This access point to some of the most abundant waters of our State is critical for the lawai'a of Puna and the boating industry overall as they now have to haul their boats at least 30 minutes to Hilo just to get into the water. This doesn't account for the time and costs associated with travel by boat to their waters off Puna, where many have fished for generations.

We strongly support HB701 to appropriate funds to dredge the boat ramp at Pohoiki Bay because of the opportunity it presents. This investment by the State Legislature will be able to leverage the disaster assistance expected from the Federal Emergency Management Agency to the State to restore this critical infrastructure which provides for the livelihoods, subsistence, and cultural practices of our families in Puna. With the restoration of access at the Pohoiki boat ramp, the County stands ready to work with the relevant State departments to establish a properly sited and funded parking facility and boat wash area that has been long overdue to service the lawai'a and protect the environment at Pohoiki.

The County of Hawai'i has worked closely with the Department of Land and Natural Resources – Division of Boating and Ocean Recreation in its work to restore this vital ocean access at Pohoiki. This includes collaboration with lineal descendants, cultural practitioners, and ocean users of the area through the Revitalize Pohoiki planning effort, and a \$3.1 million investment of disaster assistance from the Federal Emergency Management Agency by the County's Department of Parks and Recreation to restore facilities at Isaac Kepo'okalani Hale Beach Park which serves as the gateway to the boat ramp at Pohoiki Bay. In the months following the 2018

Kīlauea eruption the County restored inundated portions of Highway 137 on a temporary basis to provide for immediate road access to Pohoiki once it was safe. The County Department of Public Works is in the process of restoring all lava inundated extents of Highway 137 and Pohoiki Road, including a new road realignment where the two roads meet to ensure safe access to Pohoiki for all users, including large vehicles and boats, for generations to come.

We thank Speaker Saiki and Vice Speaker Ilagan for their leadership in introducing this important bill, and appreciate the time and consideration of the Committee on Water and Land for taking up this measure.

As a lower Puna resident, I support re-establishing a boat ramp along the Puna coastline. We need a boat ramp for the fisherman, food security and coastline safety. Please fund a boat ramp project so we can get the FEMA money associated with re-establishing a boat ramp.

I do have concerns about the proposed plan for where and how to re-establish this boat ramp that is, the "dredge everything" at Pohoiki approach that is popular with the fisherman community. Whether you believe Pele gave Puna a beautiful new black sand beach, or you believe that coastal erosion and sediment transport created the beuatiful new beach, I believe it is a mistake to think that humans can tackle nature to keep things the way they were. Pele won't like it, and neither will the ocean abide by the human goals.

The boat ramp should be located where the community-at-large will accept it, and it makes the most engineering and financial sense. Pohohiki has poor road access. It has no services left after 2018. The coastline was drastically changed by the lava flow. Everything is different since 2018. The ramp should be located where it makes the most sense now, not where Isaac Hale donated land for a boat ramp before. Things move on, including coastlines and fish.

I proposed alternatives, such as blasting a new ramp area in the new state land created by the 1980-90 lava flow between Kaimu and Kalapana, but the fisherman's group has decided it should be back at Pohoiki, and that sems to be the loudest and most recognized voice. So be it. A re-established ramp at Pohoiki is better than no ramp at all.

The studies and reports that have been commissioned were severely disappointing because the engineering firms ignored community input until after the report was prepared. When a public meeting happened to discuss the report, the whole report was thrown out as state players bow to the demands of the fisherman group. The process should have been - get community input about both proposed and unacceptable location ideas, then have an engineering firm prepare a feasibility study and financial assessment of those proposed locations/approaches. The Hawaiian voice is strong in lower Puna. Might as well recognize that reality and listen to it first, then prepare an engineering report that accesses the community ideas. Not the other way around.

One final comment about Hawaii state support for ocean vessel access in general. Hilo's Wailoa Basin is silting in. Already deeper draft boats can only navigate the entrance at greater than 1 foot tides. If no dredging is done at Wailoa, and no Puna ramp is re-established, and the Laupahoehoe boat ramp is not repaired, then fisherman and recreational boaters will have no

boat access on the entire fisheries rich and fertile east Hawaii coast. The real question is why is Hawaii state not more ocean-going boat friendly?

But this bill is not about DOBOR and its problems. It's about the Puna boat ramp, and I support funding it.

My name is Tony Sylva and I have been fishing out of pohoiki since I was a kid. I have 2 daughters Ku'uipo and Kulia they both have been fishing out of pohoiki boat ramp before they could walk.

Pohoiki was like our second home we went almost every day. I normally fish every day rather it was a 2 hour trip or a 4 hour trip. Sometimes I had extended trips that would last for 2 days. On weekends was family day I would take my kids and their cousins out bottom fishing or run to kahena buoy for some ahi or mahi-mahi.

With no pohoiki I have to launch out of Hilo. My 2 hour trips are now 4 days. I could be at the fishing grounds in minutes now it's a minimum 4 hours from Hilo to pohoiki. To get from Hilo to pohoiki you have to cross the treacherous kumakahi point. Kumakahi in my opinion is the second roughest point on the Hawaii island next to opolu point.

My fishing expenses for a single fishing trip used to range from \$120.00-\$250.00. Now my trip is a minimum \$500.00 and can cost up to \$800.00 my maintenance now on my boat quadruple since my trips are so many hours longer. I have made extensive modifications to my boat so it can make the long drive that is required now to make any money fishing from Hilo boat ramp.

I no longer can go on single day trips because it is not affordable I have to take 4 day trips at a time. Now I don't see my girls for days at a time because I have to make my trips count. My daughters don't go out on the boat anymore because I don't trust taking them far out . Hilo doesn't have the fishing grounds like Pohoiki.

I cannot believe that farmers have gone back to farming because there roads have been restored. Most of the community that couldn't access their houses are now at home. Us pohoiki fishermen are just screwed with the state taking the longest possible way to get us a chance at getting back to work out of pohoiki. How much longer will it take to Try Something. More then half of the guys I know who used to fish out of pohoiki have sold their boats because they could not make money out of Hilo boat ramp. Some of those guys boats just couldn't make the long treacherous drive back to the fishing grounds we all know and depend on to survive as fishermen.

Pohoiki boat ramp was not only valuable to us fishermen but also a emergency access if lava crossed the roads and puna has no access to Hilo. In the 2018 eruption that almost happened we got lucky and lava did not cross the main highway. I really hope we the fishermen have a chance at launching out of pohoiki in the next year.

This is the testimony of a geologist who has commented on this issue since 2018 as part of the Puna community. I see the people of Puna driven to the revival and stewardship of the Pohoiki boat ramp and its supporting area, as evidenced by Hawai'i County and the community's investments in Kīlauea Eruption Recovery and Revitalize Pohoiki. Of the 4 major issues this bill addresses, I will comment primarily on the geologic and economic aspects, while duly noting the importance of safety – as the only boat ramp in south Hawai'i between Hilo and Punalu'u, a coastal distance of over 80 miles – and the well-established cultural value and long tradition of Hawaiian fishing out of Pohoiki.

Since the end of the 2018 eruption, we know that the majority of the sand in Pohoiki bay, 94% of its current extent, was deposited by mid-2019. In the three following years, the beach grew only in its central section, expanding in width by up to 20% while showing little change at its northern and southern ends. These rough estimates, generated from Sea Engineering's presented map of surveyed beach crest locations, suggest the sediment accumulation rate is dramatically lower today and could be comparable to rates calculated for other harbors statewide, where maintenance dredging has been established as acceptable.

There are uncertainties due to the situation's uniqueness, but the best way to gain the missing knowledge and benefit the community is to take the first step of informed action to move out as much of the sediment as possible. Perhaps sediment has stopped collecting because the bay is at its capacity, due to the significant drop-off not far offshore. Perhaps erosion of the new lava flows nearby is still producing enough material to refill the bay and hinder the boat ramp, but if so it needs to be much more than was produced by erosion of the pre-2018 lava flows, which were not enough to hinder the boat ramp. These are valid concerns, but in contrast to the accumulation rates, there has been no data available to support them.

Looking further to the lessons given by time, this area previously hosted sand and cobble beaches evident in maps from the 1890s and old photographs from the Lyman Museum Archives. However, much of the nearby Puna coastline has subsided due to movement of Kīlauea's south flank, rapidly during the 1924 seismic crisis and the 1975 Kalapana earthquake and more slowly in between. The net effect over the last more than 130 years has been the natural removal of sand from the area, which was likely produced by the previous large volume eruption to enter the ocean nearby, perhaps in 1840 or 1790. In this context, dredging Pohoiki bay after the 2018 eruption could just be an acceleration of the natural process, with a chance to sustain itself in the long-term.

Economically, an analysis of DLNR's "Sea landings by area fished" data shows Pohoiki was the third most productive fishing area listed for the State through 2017. It brought in an annual average of \$1.3 million in catch when reported from 1997 to 2001 – equivalent to \$2.2 million per year in 2022 after adjusting for inflation. An average of almost 400,000 pounds of fish were landed there every year, a significant contribution to local food sustainability, but by 2019 the catch was reduced to one-third of that amount. Fishermen continue to endure hardship after 4 years, forced to launch from Hilo for longer, costlier trips that also burden their families with less time at home. The need is urgently real, with the prolonged closure already threatening the Puna fishing industry.

The sediment itself is also a resource worth roughly \$50 per ton, which I estimate could add up to a total value of at least \$15 million if put to market, or could save taxpayer money and other local resources if reused in other government projects. Certainly it is not so simple, but the opportunity exists to reduce the project cost in innovative ways.

Do we know enough to take action on Pohoiki? Given the stakes, we have to. The unknowns should have been researched sooner, but there is a path to simultaneously take action and gain knowledge. The alternative to dredge as much of the bay as possible under the existing maintenance permit is the most logical step to restore ocean access to the Pohoiki boat ramp as soon as possible. The less sediment remains in the bay, the less there will be to remobilize towards the boat ramp and its channel, increasing the initial chance of success. More sand may still accumulate, but at that point the new build-up rate could be measured and used to evaluate any further design and action. Perhaps the accumulation rate is low enough to justify periodic maintenance dredging as is common at other State harbors, and the initial action may prove sufficient. The other possibility also exists: that so much sediment is still being generated from the 2018 lavas, that even the most expensive, built-out alternative would prove insufficient. In that case, dredging today and attaining measured rates of build-up would also save us from money ill-spent in the long run. It is clear that the rewards of funding HB701 far outweigh the risks, and in my opinion, presents the most logical step forward and the fruition of years of community work in Puna. I offer this testimony wholeheartedly supporting HB701.

To go all the way from Kalapana to Hilo with my truck and boat, the gas for the truck alone is \$150.

I very rarely fish out of Hilo. I go back to where I was raised on Kalapana side. Just to go trolling on that side now costs hundreds of dollars. To go ika shibi, it costs \$700 or \$800 each trip.

I always go back home because I know I will catch down there. Hardly anyone fishes down there because the ocean is rough. I don't know anything about Hilo, but at home I know all the areas that the fish bite. Down there, I know all the grounds from where our kupuna showed us. I don't know Hilo; I am only guessing when fishing in Hilo. This is why we need our ramp. This is where we know where the fish are. I leave Kalapana, then spend hundreds of dollars driving on the road and the ocean for hours just to get back to Kalapana for fishing.

Every time I go fishing, I have to stay on the sea for two or three days to save money. It is not easy. The ocean is rough, you try to sleep, and then you have to fish all day before the drive back- just because the cost is so high.

The ramp is good where it is at Pohoiki. It has boat parking and the bumpers. All we need is the opening to the ocean. That's all we need is the opening, and then we're all good. I will launch there again. The original depth is good, the top of the original ground can be cleared away and it should be good to use again.
