WHY IS NATURAL GAS SO MPORTANT TO RESTAURANTS?

Costs to retrofit existing structures to convert to electricity will likely be cost prohibitive for smaller operations, and the demand to obtain the needed appliances for commercial kitchens will further strain our supply chain. Restaurant operators with one or two locations would likely be the most adversely affected by a natural gas ban. Further:

- Natural gas appliances provide cost savings for restaurants: Gas ranges typically cost 10-30% less to operate on an ongoing basis.
- Retrofitting existing buildings to handle the electric capacity required by a restaurant is extremely costly for an industry with already tight margins (estimated in the hundreds of thousands by some operators).
- Professional chefs prefer the control of an open flame which greatly affects quality of food served.

- Gas ranges provide ease of use and longer lifespans than comparable electric models.
- Heated outdoor spaces allow restaurants to operate in cold weather, providing better dining experiences and
- additional revenue stream.
 During natural disasters and power outages, many restaurants can safely keep food and drink stored at appropriate temperatures by using natural gas-powered generators, saving money on food losses and providing peace of mind.



BOTTOM LINE

Restaurants are an integral part of the communities they serve. As such, they strive to be good stewards of those communities and the environment. Now, more than ever, restaurants are aware of the importance of reducing their environmental impact and increasing their sustainability practices.

However, banning the use of natural gas in commercial kitchens would have devastating effects on the restaurant industry – hitting local and independent restaurants the hardest. The costs to convert existing building infrastructure to handle the power capacity needed to operate a

commercial kitchen alone would be prohibitive for many locally owned restaurants. Finally, mandating natural gas bans while the industry is still mired in debt accrued during the COVID-19 pandemic, and facing an extended period of record inflation, will only exacerbate these problems.

Members of the Committee:

Here is another bill that in our opinion, is tackling legislation the wrong way. In this case it is an issue near and dear to our core values: sound environmental stewardship.

The passage of this bill would further erode the livelihood of restaurants, as both cooks and owners such as ourselves prefer and require natural gas or propane for specific applications. History has shown that better legislation is to use economic incentives rather than bans and penalties. Restrictions and burdens on businesses only weaken the business sector by raising costs to the consumer. Legislation should encourage economic activity.

For example, if using less fossil fuels is the objective, then encourage businesses through tax credits to the extent feasible, to implement photovoltaic incentives to landlords and business owners. Similarly, a significant reduction in fossil fuels can be made by legislating thru incentives that e.g, encourage people to switch small noisy engines to battery-powered alternatives. Or if you want to encourage electric car usage, ensure the installation of electrical charging points at places where people live, work and shop.

Also, if the goal is to persuade people to not use gas appliances, then ensure that Hawaii is not the most expensive state in which to purchase electricity.

- To the reader; in October 2022, the cost of electricity per KWh in Hawaii was 44.85¢ vs the second most expensive of New Hampshire at 30.44¢. Also, further encourage HECO to pursue more renewable sources.
- Iceland, a volcanic island in the middle of the North Atlantic, supplies all of its citizens with energy from geothermal and hydroelectric sources for 13¢ a KWh, with the only use of fossil fuels for transportation.

Lastly, LNG will be a critical resource for the foreseeable future as the world shifts away from the dirtiest and geopolitically riskiest sources of fossil fuels – coal and oil. We believe it is a known fact that gas is the least bad fossil fuel for pollution and global warming. Therefore gas is likely to reduce (relatively) in price as countries seek to increase supply and develop infrastructure for its transportation. Banning gas appliances at this time, when understanding the global macro trends, would, with hindsight, be seen to be a questionable decision.

Aloha Chair Gabbard, Vice Chair Richards, and members of the committee,

The Chamber of Commerce Hawaii ("The Chamber") **does not support HB 835**, which beginning 1/1/2025, prohibits the installation of gas appliances in new construction within the State.

Hawaii already has the highest electricity rates in the country. With the recent closure of energy projects in the state, the cost of electricity for businesses has gone up significantly, and businesses have been forced to push the costs onto the consumer. Restrictions on natural gas use in new buildings will add to the already increasing costs to do business and overall hurt our economy. Nationally, 76% of restaurants rely on gas cooking equipment. The national residential market sits around 35%. Hawaii users are less than that percentage.

Restrictions on new natural gas hookups are a costly and unnecessary imposition on residents and businesses This ban will contribute to problems of energy reliability and affordability. Natural gas bans concentrate our energy risks on the electric grid - bans on new natural gas hookups push more demand onto the grid, further taxing the system.

This ban will also have a major impact on local jobs. Hawaii Gas employs over 350 residents. Banning gas appliances in the future will negatively impact the stability of these positions.

We believe this policy would do much more harm to our economy than the good it would do to our environment. The EPA does not list gas stoves as significant contributors to indoor air quality or health hazards. And according to the California Air Resources Board (CARB), cooking reduces air quality, no matter what kind of stove is used. Replacing gas stoves with electric stoves would not eliminate air quality concerns and the cost of switching stoves from gas to electric would impose a cost burden on homes and businesses, who are already paying the highest electric rates in the nation.

We ask the committee to hold this measure, and hope to work with the committee in the interim on policies that would help improve the environment and reduce air quality concerns, all while not harming our economy.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 2,000+ businesses. Approximately 80% of our members are small



businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

The Climate Protectors Hawai'i STRONGLY SUPPORTS HB835!

The Hawaii Legislature has declared that we are in a climate emergency! One way to address that emergency and help the State achieve its carbon negative clean economy target as soon as practicable but not later than 2045 is to reduce greenhouse gas emissions. Installing appliances that use electricity instead of gas (whether naphtha synthetic natural gas, renewable natural gas, or natural gas) in new construction would substantially reduce greenhouse gas emissions and help move the State toward achieving its zero emissions clean economy target. Over the past three years, the District of Columbia and various cities and counties in California, Colorado, Maryland, New York, Oregon, and Washington have prohibited the installation of gas burning appliances, such as water heaters, refrigerators, ranges, dishwashers, clothes dryers, air conditioners, decorative fireplaces, and other similar devices in new construction within their cities or counties.

In addition to emitting greenhouse gases, stoves, ovens, and other indoor appliances may harm human health by leaking hazardous air pollutants inside homes even when not in use, including cancer-causing benzene, according to a recent California study. Another recent study found that gas stove pollution causes roughly 12.7 per cent of childhood asthma in the United States, on par with second-hand smoke.

This bill would prohibit the installation of gas appliances in new construction beginning in 2025. It would not affect the use of existing gas appliances or the sale of gas appliances for use in existing homes.

To protect public health and the environment, please hold this bill! Mahalo!

Chair Lowen and Vice Chair Cochran, and Members of the Committee:

FCH Enterprises, Inc., and its most recognized brand, Zippy's Restaurants, would like to express opposition to HB835 which prohibits the installation of gas appliances in new construction within the State.

The vast majority of restaurants across the country, and in Hawaii, rely upon gas to cook your food. Fully 76% of the restaurants in the country use gas and open flames appliances to cook because the ranges are less costly to operate and have far longer lifespans than electric equipment. And, as we have seen before, gas ranges are not affected by electrical outages during times of disasters and power outages. Should a ban on gas be instituted, it's likely to further increase the cost of eating out at Hawaii's restaurants, negatively impacting all Hawaii consumers, as well as decreasing foot traffic, further harming Hawaii's restaurant workers.

While we believe that a zero-emissions energy goal is commendable, the use of gas in restaurants produces nominal emissions and would make little impact to lowering overall emissions. Instead, this bill will serve to harm Hawaii's thousands of restaurants while not achieving the goal of significant emissions reductions – lose-lose all the way around.

Zippy's Restaurants employs nearly 1,300 people statewide and serves a large percentage of the Hawaii's population each month. We are interested in fostering an economic climate that ensures a thriving business community in Hawaii. We oppose this bill because we believe it is not conducive to a positive business environment.

Founded in 1918, the American Gas Association (AGA) educates the public about the importance of natural gas, supports natural gas utilities in their efforts to make their operations safer, more efficient and more environmentally-friendly, and serves as a resource for local, state and federal policymakers when it comes to regulating the natural gas industry. AGA represents more than 200 local energy companies serving more than 74 million customers including approximately 70,0000 homes and businesses across Hawaii.

Thank you for the opportunity to share why nearly 187 million Americans and 5.8 million businesses use natural gas because it is affordable, reliable, safe, and essential to improving our environment. America's natural gas utilities are innovative and committed to reducing greenhouse gas emissions through new and modernized infrastructure and advanced technologies that maintain reliable, resilient, and affordable energy service choices for consumers.

Natural Gas is the Affordable Choice for Hawaii Homes and Businesses

According to the U.S. Department of Energy the direct use of natural gas is 3.4 times more affordable than electricity. On a national average basis, households that use natural gas for heating, cooking and clothes drying save \$1,068 per year compared to homes using electricity for those applications.

Given its geographic isolation and land constraints, Hawaii has significantly higher electricity prices than the rest of the country. Any wholesale effort to ban natural gas appliances would saddle homes and businesses with significantly higher energy costs. Restrictions on natural gas appliances not only increases the cost of new homes and prevents new businesses from opening but also raises costs for existing gas customers.

According to the state's largest electric utility, electricity prices in Hawaii are generally higher than on the U.S. mainland due to the cost of imported oil used to power many of the islands' generators. The fluctuation in the cost of fuel, which makes up roughly 50 percent of a typical bill, is the biggest driver. Efforts to aggressively electrify Hawaii homes and businesses would increase the use of oil for electric generation directly increasing emissions particularly in the near-term.

The Natural Gas Distribution System Offers Unparalleled Reliability & Resilience Attributes

On an energy equivalent basis, the gas system provides 2-3 times the energy as that of the electric sector during peak demand. Overreliance on any one source of energy can jeopardize overall energy system reliability and resilience and ultimately result in greater costs for all consumers. Widespread electrification would likely result in significantly higher peak-day

electric power asset requirements which often takes the form of higher-emitting resources. Pathways utilizing the existing gas distribution solve this problem by preventing the unnecessary overbuild out of the electric system to meet peak demand thereby reducing costs while maintaining reliability.

The natural gas distribution system is an incredibly reliable energy delivery system with unplanned outages affecting only about 1 in 800 natural gas customers per year. By comparison, electric distribution systems have an average of one outage per year per customer. In a 2020 analysis, the Government Accountability Office found that compared to electric power outages, the frequency and scope of outages to natural gas consumers appears relatively limited. Gas interruptions usually did not result in a complete loss of service to affected consumers however the scope of electric outages can be extensive, affecting millions of consumers for days at a time.

Gas Utility Infrastructure is Vital to Achieving Ambitious Emissions Reductions

To achieve lasting, affordable, and reliable deep emissions reductions the existing natural gas distribution infrastructure that Hawaii residents have already invested significantly in must be part of the solution. Hawaii can achieve significant emissions reductions by working with its local utility to accelerate the use of tools available today, including high-efficiency natural gas applications, renewable gases, methane reduction technologies, and enhanced energy efficiency initiatives.

Natural gas utilities are recognized as leaders in the energy industry for their successful history of reducing emissions spending almost \$4.3 million a day on energy efficiency programs. This exceptional record can be traced to gas utilities continuing to make safety their top priority and remaining deeply committed to systematically upgrading infrastructure through risk-based integrity management programs.

Distribution systems owned and operated by local natural gas utilities emit as little as 0.1 percent of produced natural gas emissions according to EPA's most recent Greenhouse Gas Inventory. These annual methane emissions declined 69 percent between 1990 and 2020, even as more than 22 million customers and more than 815,000 miles of pipeline were added to the distribution system over the same period.

Hawai'i Gas is already leading the nation in utilizing advanced fuels by providing its customers with a distribution network that currently accommodates a blend of up to 15% hydrogen. Furthermore, Hawai'i Gas is actively involved working with localities to drive innovative solutions that reduce waste, lower emissions, and save money. Hawai'i Gas has partnered with the City and County of Honolulu's Honouliuli Wastewater Treatment Plant to turn waste into renewable natural gas generating enough energy annually to fuel 6,000 homes. At the same time, this RNG project reduces the need for approximately 15,000 barrels of oil and reduces greenhouse gas emissions by the amount produced by 400 cars annually. Additionally, since 2018, the City and County of Honolulu generated approximately \$1.85 million of revenue by

selling the biogas to Hawai'i Gas. Efforts to phase out natural gas appliances would reduce the potential end use applications for these emerging fuels and discourage continued investment and greater innovation.

There are No Documented Health Hazards Associated with Gas Stoves

There are no documented risks to respiratory health from the proper use of natural gas stoves by government agencies and advisory committees responsible for protecting residential consumer health and safety, including the Federal Interagency Committee on Indoor Air Quality and the Consumer Product Safety Commission.

Proper ventilation when cooking with any energy source is the most important step you can take to mitigate cooking related air quality. Cooking activities by themselves, (e.g., grilling, frying, broiling, baking) are a source of indoor air emissions, including particulate matter. This is why many jurisdictions require kitchen exhausts in all new homes, regardless of energy source, gas or electric.

Conclusion

AGA appreciates and echoes Hawaii's commitment to a more sustainable environment. Thank you for the opportunity to share how the natural gas energy delivery network can help provide a safe, reliable, and affordable energy source well into the future.

Hawai'i Environmental Change Agents' Decarbonization of Buildings Task Force **strongly supports** HB835 because it will reduce our greenhouse gas emissions, improve our sustainability, and reduce health risks.

The Hawai'i Legislature has declared that we are in a climate emergency. It has also set a target to be carbon net negative by 2045. The use of gas, whether natural, propane, or synthetic results in significant greenhouse gas emissions. Because this bill calls for prohibiting the installation of gas appliances in new construction, it will help Hawai'i meet its environmental goals by reducing greenhouse gas emissions.

TESTIMONY IN SUPPORT OF HB 835

Aloha Chair Lowen, Vice Chair Cochran, and Committee members:

Blue Planet Foundation **supports HB 835**, a bill that would phase out the installation of gas appliances in new construction after 2025 to reduce carbon emissions and harmful air pollutants in Hawai'i homes and commercial buildings.

The State of Hawai'i has passed aggressive carbon reduction goals, including a mandate to achieve 100% renewable electricity by 2045 (Act 97 of 2015), and a goal to be carbon-negative by 2045 (Act 15 of 2018). Currently, fossil fuel-based natural gas is not included in the state's mandate to achieve a 100% renewable energy portfolio. Policies like HB 835 would help to align all industries in Hawai'i's collective efforts to reduce carbon emissions and meet our clean energy and climate change goals.

House Bill 835 offers Hawai'i an opportunity to build smarter, healthier, and more resilient infrastructure going forward. As construction begins on new homes, buildings, and infrastructure, all of the blueprints should reflect the same goal: having the ability to fully participate in our 100% carbon-free future. **This means that fossil gas connections or other fossil fuel infrastructure should be phased out in new construction.** The buildings and infrastructure that we invest in today will be with us for decades—it is critical that they have the capacity to be 100% powered by renewable energy and not be saddled with soon-to-beoutdated fossil systems, including natural gas appliances.

Chair Lowen and Vice Chair Cochran and members of the Committee, thank you for the opportunity to share the view points of the home appliance manufacturing industry regarding H.B 835, the potential ban of gas appliances in Hawaii.

AHAM represents manufacturers of major, portable and floor care home appliances, and suppliers to the industry. AHAM's membership includes over 150 companies throughout the world. AHAM members employ tens of thousands of people and produce more than 95% of the household appliances that are shipped for sale within the United States. Appliance manufacturers are heavily engaged in the development of standards for the design of natural gas appliances, participating in building safety codes, and standards proceeding. Consumers in the U.S. are fortunate to have a variety of cooking options available and they can rest easy knowing that all ranges and cooktops, whether gas or electric, meet or exceed approved safety standards and building codes.

AHAM supports cooking choice for consumers, and we also recognize that states and municipalities are working toward climate goals. Each state may have a different plan and appliance manufacturers are focused on how they can supply solutions to whatever direction is chosen. However, a potential ban on gas cooking appliances would remove an affordable and preferred technology used in approximately 40% of homes across the country. Many home and professional chef's value gas cooking for its speed and control. A ban on gas appliances would also potentially remove an affordable energy choice that Hawaii consumers may depend on.

All cooking, regardless of whether it is gas or electric, causes byproducts. AHAM is leading efforts to further improve cooking-related indoor air quality, including revising consensus standards as required. The appliance industry is actively working with regulatory bodies including the U.S. Consumer Product Safety Commission (CPSC) to study natural gas cooking appliances. The impact on indoor air quality from the emissions from cooking products has been studied and considered by standards, regulatory bodies and building codes for decades:

- A recent study of California ventilation system requirements completed by Lawrence Berkeley National Laboratory for the California Energy Commission found that current ventilation requirements were adequate to protect consumer health and safety from a variety of sources, including kitchen sources of airborne contaminants.¹
- CPSC has determined that there is generally a low likelihood of adverse health effects associated with carbon monoxide emissions from properly functioning unvented gas ranges.
- The Environmental Protection Agency (EPA) does not list gas stoves as significant contributors to indoor air quality or health hazards. In fact, EPA recommends using ventilation hoods or downdrafts and states that using a hood with a fan vented to the

outdoors, and properly adjusting burners, greatly reduces exposure to pollutants during cooking.

AHAM continue to develop information and educate consumers about the safety of cooking appliances and ways to reduce cooking emissions including ventilation. As homes have become more tightly constructed, the need has grown for specific steps aimed at improving ventilation. That's why building codes have long required mechanical ventilation and external cooking exhaust in newly constructed more airtight homes for both electric and gas cooking.

The home appliance industry designs products that are as safe as they are useful. AHAM is committed to preserving an environment that allows for choice and innovation in cooking. Bans on gas appliances restrict consumer choice and remove affordable choices that consumers love, such as gas cooking appliances.

Chair Lowen, Vice Chair Cochran, and members of the committee,

Hawaii Gas **strongly** <u>opposes</u> **HB 835**, which, beginning 1/1/2025, prohibits the installation of gas appliances in new construction within the State.

Established in 1904, Hawaii Gas serves over 70,000 customers on all islands through its pipeline and propane delivery services, all of whom depend on the company for sustainable, reliable, and affordable gas for water heating, cooking, drying, and other commercial and industrial applications. The company employs some 350 professionals, over 75% of whom are members of the Teamsters Union, and provides both regulated utility and unregulated operations.

Hawaii Gas distributes a blend of gas that ranges from <u>low-carbon to negative-carbon</u> emissions through approximately 1,100 miles of mostly underground utility pipeline statewide. Our main utility system includes a blend of gas that includes Synthetic Natural Gas (SNG), Renewable Natural Gas (RNG), and Hydrogen. Despite <u>representing less than 1%</u> of the greenhouse gases emitted into Hawaii's atmosphere, we are working diligently to reduce our greenhouse gas emissions by pursuing cost-effective, local, renewable energy projects.

Hawaii Differs from the Mainland In Critically Important Ways

While similar proposals are being considered on the Mainland, it is important to once again note that Hawaii – and thus Hawaii Gas – are quite different than our mainland counterparts. While gas is a major component in home heating on the Mainland, that is not true in Hawaii. Hawaii homes are also simply designed differently, built to accommodate our indoor/outdoor lifestyle in a way that's not typically possible on the Mainland. Hawaii is already tiny in terms of overall natural gas usage ranking last of all 50 states. While other states are focused on shrinking the footprint of the gas utility in their state, gas usage in Hawaii is already tiny due to the warm weather climate. In Hawaii, gas – including SNG, RNG and hydrogen, considered low to negative carbon fuels – represent less than 1% of the state's greenhouse gas emissions. Further, those fuel sources are on the front line of innovative clean fuel options both in Hawaii and around the world.

In Hawaii, gas-powered appliances are also essential to critical services from the Department of Defense to hospitals to hotels to civil defense to homeland security and more – all of which



sustain the state during both normal times and especially times of adversity. Hawaii cannot afford to shut down that critical infrastructure.

Reliability, Affordability, and Sustainability

Thousands of Hawaii residents depend on gas for everyday home use and especially during lifethreatening weather events such as hurricanes, floods, lava flows, and other disasters, when electric power simply isn't reliably available. Power outages during Iniki lasted for weeks and weeks, leaving people desperate for gas to manage basic things like cooking and hot water, and in many cases, powering life-saving devices. During the 2018 floods on Kauai, countless residents report that Hawaii Gas employees were able to re-establish connections quickly, enabling residents to have hot showers, cook and meet their basic needs when they needed it the most.

Other state residents live in areas with minimal or no grid access at all, and this bill will completely eliminate any access to these basic services for those residents. The bill's language specifically makes no exceptions for residents who live in areas with spotty or no electricity, essentially leaving them cold and in the dark. This draconian proposal is devastating to households located in hard to reach, under-served areas that include DHHL homesteaders from across the state (including Molokai and Maui), as well as formerly homeless families who've begun to rebuild their lives as residents of Kahauiki Village on Oahu. Hawaii Gas was a partner in this project which provides backup gas water heater, and gas for cooking. This mix of energy sources provides resiliency for the community to ensure they have reliable energy even through natural emergencies and power grid outages.

These are the people most often forgotten, and they depend on Hawaii Gas for cooking, hot water, and other basic needs. In these areas of the state, the Hawaii Gas trucks are routinely driving their routes, delivering their gas, setting up and trouble-shooting gas cylinders after storms, and talking story with those residents. Hawaii Gas, and especially those drivers, are a lifeline to these families, coming to know them, service them and sustain those working families.

Given its geographic isolation and land constraints, Hawaii has significantly higher electricity prices than the rest of the country and electric rates are twice as much as gas rates¹. Any wholesale attempt to ban gas appliances would saddle homes and businesses with added costs.

Gas appliances in Hawaii – used primarily for cooking, drying, water heating, and commercial uses – are integral to our residents' well-being. The GHG emissions from these appliances is negligible, they provide a critical lifeline during grid instability and in areas without grid access,

and they provide an affordable and sustainable essential service to our neighbors. Eliminating these appliances leaves people vulnerable, under-served, and in many cases, forgotten.

Indoor Air Quality Impact – Facts & Science

It has long been true that indoor air quality, particularly in a tightly closed home, can be impacted by cooking (both gas and electric), typically at levels most scientists believe can be managed with easily administered counter-actions. The EPA does not list gas stoves as significant contributors to indoor air quality or health hazards, and according to the California Air Resources Board (CARB), cooking reduces air quality, no matter what kind of stove is used. Replacing gas stoves with electric stoves would not eliminate air quality concerns. CARB, indoor air quality experts and others have recommended for years that opened windows and the use of an exhaust fan during **any** cooking activity is recommended for better air flow within the house. In Hawaii, our indoor/outdoor lifestyle has been providing that ventilation for decades. CARB recommends using a high-efficiency range hood or exhaust fan, a solution far more practical for most Americans than converting from gas to electric. Additionally, Alexander Hoehn-Saric, the Chair of the Consumer Product Safety Commission, made it clear in his January 11, 2023 statement that "I am not looking to ban gas stoves and the CPSC has no proceeding to do so."

This bill is a great over-reach for an issue already under scientific review and strips Hawaii of one of its most critical assets.

Moving Towards A Clean Energy Future

The state of Hawaii is in the midst of a forward-thinking integrated effort to eliminate fossil fuel in the state's electricity sector by 2045. As our part in that effort, Hawaii Gas is currently in the midst of an Integrated Resource Plan (IRP) regulatory docket. This proceeding, Docket No. 2022-0009, which is comprised of over a dozen subject matter experts, will establish a resource portfolio for Hawaii Gas, which supports further decarbonization of its already very low carbon footprint today (less than 1% of the state's GHG emissions). The purpose of developing this decarbonized resource portfolio is to 1) design a pathway for Hawaii Gas to meet state decarbonization goals and 2) achieve those decarbonization goals in a manner that is economic and equitable for Hawaii Gas customers.

This IRP process is an action plan to determine how a utility will meet energy objectives and customer energy needs consistent with state energy policies and goals, while providing safe and reliable utility service at reasonable cost through the development of Resource Plans and Scenarios of possible futures that provide a broader long-term perspective. Beyond our RNG and SNG innovations already underway, hydrogen offers some of the most innovative and promising steps forward towards that clean energy future. Hydrogen has been identified as a carbon neutral fuel with the most promising applications to decarbonize transportation, aviation, power generation and storage. Hawaii Gas is part of the consortium of partners across government, community, industry, and academia that is submitting a full application for the Regional Clean Hydrogen Hub (H2Hub) program. The consortium concept paper details the



potential for an integrated Hawai'i Pacific Hydrogen Hub that aligns multiple existing, indevelopment, and proposed new hydrogen production pathways to deploy hydrogen across all sectors of Hawai'i's energy ecosystem and economy over the next decade.

Given all of the innovation abound and benefits for Hawaii, banning gas appliances is simply short-sighted. By passing this bill, Hawaii Gas's work to innovate, invest, and propel the state forward to a clean energy future is gutted. Like any business, our sustainability – and our ability to innovate – rests on the company's capacity to manage a healthy bottom line that can fund those efforts, and sustain a healthy and thriving local workforce. By sustaining our pipeline and serving our customers, we are able to invest and pursue new technology, clean energy alternatives and further research and development in this quickly growing and evolving clean energy sector. Without that customer base and pipeline, our innovation is virtually erased.

Hawaii Gas is acutely focused on decarbonizing our fuel source with RNG and Hydrogen, with more innovation forthcoming as referenced in our IRP plan. It is also important to point out that gas appliances are not locked into one source of gas. In fact, today's gas appliances in Hawaii are already able to operate with our current blend of RNG and hydrogen. Gutting our ability to continue our important work in a robust and meaningful way is counter-productive to the state's clean energy future.

Before eliminating gas appliances, perhaps it would be wiser to initiate a study to fully identify and understand what this impact would be. Such a study should be integrated with the PUC's ongoing IRP, which would provide a detailed and robust plan for our future options and best investments.

We urge the committee to defer the measure.

Aloha Chair Lowen, Vice Chair Cochran, and Energy and Environmental Protection Committee members,

I am Co-Founder of the Hawaii chapter of 350.org, the largest international organization dedicated to fighting climate change. 350Hawaii.org is in **strong support of HB835** that, beginning January 1, 2025, prohibits the installation of gas appliances in new construction within the State.

Electric induction cooks as well as gas and is much more energy efficient. Installing appliances that use electricity instead of gas in new construction would substantially reduce greenhouse gas emissions and help the State achieve its zero emissions clean economy target.

Gas for homes in Hawaii has been portrayed to be "reliable, clean, and resilient." However, the truth is, gas is none of these. This characterization is pure greenwashing. In addition to emitting greenhouse gases that warm the planet, gas stoves and other indoor appliances can harm human health by leaking hazardous air pollutants inside homes even when not in use, including cancer-causing benzene. Gas-burning appliances can also trigger asthma, coughing, and potentially increase susceptibility to respiratory infections.

Last month the U.S. Consumer Product Safety Commission (CPSC) Commissioner Richard Trumka Jr. told *Bloomberg News* that gas stoves are "a hidden hazard" and suggested that new ones should be banned. There is substantial research documenting the hazards associated with the air pollution that methane-powered appliances create. A recent study found that 12.7% of childhood asthma cases in the U.S. can be tied to indoor air pollution caused by gas stoves.¹ As such, state and local governments are increasingly looking to turn away from gas in new construction, moves that will improve air quality and public health, and reduce climate pollution. Already, nearly 100 cities and counties across four states—California, Colorado, New

York, and Washington—have adopted policies that restrict the use of gas appliances in buildings in some way, including banning gas hookups in newly contructed buildings.

But its not just pollution in our homes we need to worry about. The methane leaking from gas appliances is polluting the atmosphere and destabilizing our climate system. In fact, gas stoves have been found to be a bigger contributor to the climate crisis than previously believed, producing methane even when not in use. Researchers found that more than $\frac{3}{4}$ of the methane emissions that they measured occurred when gas stoves were switched off. This research recently published in Environmental Science & Technology concluded that the annual methane emissions from gas stoves in the U.S. are equivalent to about half-a-million cars' worth of carbon dioxide.² It must be noted that methane is 86 times more potent than CO2 in warming the planet.

There is no such thing as clean gas — not for our homes, not for our communities, and not for the climate. From the drilling well to the stoves in our kitchens, gas is harming our health and warming the planet. Using electric stoves will cut greenhouse gas emissions and indoor air pollution. If we want to build resilience, we should facilitate efforts towards true clean power and battery storage. There is no good reason to install gas appliances in new construction. We have the technology for safer options, like electric stoves, let's use them.

Aloha Chair Lowen, Vice Chair Cochran and members of the Committee,

Thank you for this opportunity to submit written testimony offering comments on House Bill 835. My name is Marc Inouye, Director of Government and Public Affairs for Par Hawaii. Energy security and energy resilience are important for our state. For more than 50 years, Par Hawaii has produced petroleum-based fuels and is now beginning to explore the production of plant-based renewable fuels using our Kapolei refinery assets.

We recognize the importance of charting a clean energy future for Hawaii and creating more resilience. Gas energy has always been an important part of the state's overall energy mix, ensuring residents and businesses can continue to function in the event of electrical blackouts. This may become increasingly important as a result of climate-induced erratic weather conditions.

We believe every energy provider can help contribute to the Hawaii Clean Energy Initiative targets by 2045. Hawaii Gas has made great progress in developing renewable energy sources such as hydrogen to meet the gas energy needs of our state. Banning the installation of gas appliances in new construction and attempting to electrify another aspect of our lives would discourage further investment in renewable energy sources. HB835 would impede the positive momentum underway in our state and require Hawaii residents and businesses in new construction to be solely dependent upon electricity. This ban would also potentially cut residents off from access to reliable natural gas and green hydrogen. Hawaii needs a diversified base of renewable energy options like biofuels and green hydrogen to improve our energy and economic resilience in the decades leading up to 2045 and beyond.

Finally, while there has been no science-based evidence to show a causal link between gas stoves and health conditions such as asthma, both the Consumer Product Safety Commission and the Public Interest Research Group have stated they would prefer prudent measures to mitigate any health risks, including appropriate mandatory ventilation for indoor use and warning labeling on gas stoves instead of calling for outright bans.

Aloha Committe,

On behalf of Our Revolutions 5,000 members and supporters statewide we stand on strong support of HB835.

Liquified Natural Gas (LNG) emits about as much greenhouse gas (GHG) as coal. <u>Methane from</u> the production of fossil gas makes LNG about as bad a greenhouse gas emitter as coal. The argument from industry has been that gas is about 50% cleaner burning than coal. But a key study industry cites only looked at emissions from burning the two fuels, not at the whole process, including the extraction, refining, and shipping. More recent studies have shown LNG and coal to have closer overall emissions, and <u>LNG sometimes being even more emitting than</u> coal.

In part, this is due to the huge amounts of methane that leak into the atmosphere while making and transporting LNG. Methane is a much more potent GHG than carbon dioxide (CO2), and methane leaks have long been massively under-reported.

Large volumes of methane can be released while <u>fracking</u>, the process of extracting gas from <u>shale rock</u>. Because methane releases are still under-reported, we don't actually know the full extent of how bad LNG really is. Overall, the case that LNG is lower-emitting than coal is dubious at best.

Stanford Carr Development (SCD) is writing to **oppose** HB 835, which proposes to prohibit the installation of gas appliances in new construction within the State.

First and foremost, consumers deserve affordable options. Banning gas restricts a consumer's ability to choose their energy source in an economy where Hawaii is ranked at the bottom of the list in terms of electric energy affordability. In November 2022, Choose Energy, Inc. published the average electric rates of all 50 states where Hawaii ranked 50 – most expensive – with a statewide average rate of 43.91¢ per kilowatt-hour which represents a 26.4% increase over November 2021. Consumers deserve the option for gas as a more affordable choice.

Our affordable rental portfolio relies on gas as a backup source of energy to the solar hot water systems. We also utilize gas to power the commercial clothes dryers, pools, and BBQs.

Policies prohibiting installation of gas appliances will negatively impact affordability. Lowincome communities will bear a disproportionately higher burden as they spend a higher percentage of their budgets on energy bills.

Aloha Chair Lowen, Vice-Chair Cochran, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau opposes HB 835, which prohibits the installation of gas appliances in new construction within the State.

Gas and gas appliances play a critical role in the agricultural industry. The state has set a goal of doubling food production. Without the ability to install gas appliances, the state is going to inhibit the achievement of that important priority goal. Gas is utilized in the farming process as well as in manufacturing value-added products, which provide farmers and the community with new sources of revenue and self-sustainability. Some examples of gas appliances utilized in the agriculture industry include:

- Off-grid generator for power generation
- Backup generators for power, especially for refrigeration to comply with food safety standards.
- Propane-powered refrigerators
- Water heating/boilers/Steam for sterilization, processing, and production
- Coffee roasting
- Heating and dehumidification for controlled growing facilities
- Provide heat for baby chickens

Often, farms have commercial buildings without access to the electric grid. Denying an alternative to diverse energy sources for their operations will undoubtedly put a chilling effect on additional agriculture endeavors.

Additionally, the cost of gas is substantially less than the cost of electricity and with farmers having to manage thin margins to subsist, gas provides an affordable alternative.

Electricity is one of the highest operational costs for the farmer. The strength of Hawai'i's agriculture industry is dependent upon affordable and diverse alternatives.

We ask you to defer this bill.

My name is Kiran Polk, and I am the Executive Director of the Kapolei Chamber of Commerce. The Kapolei Chamber of Commerce is an advocate for businesses in the Kapolei region which includes Waipahu to Ka'ena Point. The Chamber works on behalf of its members and the entire business community to improve the regional and State economic climate and help Kapolei businesses thrive. We are a member-driven, member-supported organization representing the interests of all types of business: small, medium or large, for profit or non-profit businesses or sole proprietorship.

The Kapolei Chamber of Commerce is in <u>strong opposition of HB 835</u>, relating to Gas Appliances which will prohibit the installation of gas appliances in new construction within the State beginning 1/1/2025.

The impact of banning gas appliances in new construction will impact our economy in multiple channels and will ultimately have a rippling effect during a time when we can least afford it. Hawai'i already has the highest electricity rates in the country. Restrictions on natural gas use in newly constructed homes will add to the already increasing costs to live here and force residents to move off island. Our businesses utilizing gas will also be impacted negatively during a time when we are desperately trying to revitalize our economy. Over 300 jobs will also be negatively impacted by the ban.

West O'ahu is the fasted growing region in the State with an anticipated 16,000 additional residences to be constructed in the next 20 years. West O`ahu's growing population of almost 200,000 includes the Wai`anae Coast, `Ewa, and Waipahu. In Kapolei and `Ewa alone households are expected to exceed 56,000 by the year 2035 and over the next 30 years the population in Kapolei and `Ewa will increase by 40 percent and housing by 52 percent.

The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers, and utility companies. One of LURF's missions is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage wellplanned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources and public health and safety.

LURF appreciates the opportunity to provide **comments**, **concerns**, **and <u>opposition</u> to HB 835**.

HB 835. Prohibits the installation of gas appliances in new construction within the State beginning on January 1, 2025.

LURF's Position: We understand the intent of this measure, however, we must respectfully **oppose HB 835**, based on, among other things, the following grounds:

- The banning of gas appliances is inconsistent with Hawaii laws defining "Renewable Energy." Hawaii Revised Statutes (HRS) Section 269-91 defines "Renewable Energy" as energy generated or produced using the following nine (9) sources:
 - (1) Wind;
 - (2) The sun;
 - (3) Falling water;
 - (4) **Biogas**, including landfill and sewage-based digester gas (LURF note: Honouliuli WWTP, Sand Island WWTP, Waimanalo Gulch Landfill, etc.);
 - (5) Geothermal;

(6) Ocean water, currents, and waves, including ocean thermal energy conversion;

- (7) **Biomass**, including biomass crops, agricultural and animal residues and wastes, and municipal solid waste and other solid waste;
- (8) Biofuels; and
- (9) Hydrogen produced from renewable energy sources.

<u>Hawaii law specifically identifies and allows the use of renewable gas</u> for appliances and other renewable energy purposes. (HRS §269-91) This bill would be <u>inconsistent with Hawaii law</u>, because it would ban appliances that are powered by four (4) of the nine (9) sources of Renewable Energy identified by Hawaii law.

- **HB 835 creates** *"winners and losers"*, by promoting only "electricity" and <u>banning appliances that use of four (4) renewable energy resources identified Hawaii</u> <u>law;</u>
- Banning gas appliances will <u>eliminate opportunities for further</u> <u>research, innovation and development of renewable natural gas energy</u> <u>resources identified by State law.</u> Hawaii Gas has current initiatives to decarbonize its fuel source by blending renewable natural gas and hydrogen and has plans to do more research relating to the use of renewable energy fuels (biogas, biomass, biofuels and hydrogen).
- **Gas appliances can be substantially more energy efficient that other available energy alternatives.** Hawaii law recognizes this in HRS §196-5(c)(2). According to data provided by Hawaii Gas, most gas appliances are already <u>incredibly efficient</u> — <u>upwards of 93% or better</u> in some appliances; while in some cases, electricity delivers only 32% of energy used from generation source to the home.
- Eliminating the use of gas appliances in new construction will cause hardships for residents and businesses that live or operate in areas that are served with unreliable electric services or where electricity is not available. This bill is contrary to state laws that specifically recognize that gas appliances are a reasonable alternative use of renewable energy in areas that are served with unreliable electric services or where electricity is not available. (HRS §196-5(d)).
- A prudent alternative: Create a Renewable Natural Gas Working Group to study and make recommendations. Prior to adopting a blanket, one-sizefits all ban on all gas appliances, a joint State, county and Stakeholder Working Group should be established to conduct a study and make recommendations to utilizing all nine (9) renewable energy sources under HRS §269-91.

As a resident of a "rural" community, I believe that we need to have a diversified choice for choosing our own form of energy for our homes. Not all areas in the state have access to the electric grid and/or prefer to be "off-grid" which is a personal freedom that we are entitled to as citizens of the United States. I am for carbon neutrality and renewable energy, but taking away citizen's choices for gas appliances is a step onto a slippery slope. To whom it may concern,

My name is Kristen Murota and am a lifelong resident of Hilo, Hawaii. It brings me much concern that there is a house bill (835) trying to be passed to outlaw the use and installation of gas appliances in new construction within the State. Therefore, I am opposing HB835 which infringes on the right to choose the form of energy one prefers within their households and businesses.

With the use of gas appliances, many families are able to prepare meals, take hot baths, and have dry clothes to name a few. Living in the middle of the Pacific Ocean where there are many rural communities, some families have no other choice but to use gas appliances as they are not able to connect to electrical lines and are solely forced to use gas appliances, generators, and solar power. As great as it would be that we are equipped with sources of solar power, this too can cause problems as we live on an island where sunshine can be scarce and is not a sufficient and reliable source for extended periods of time. There has been on more than one occasion that my residence has been out of electricity due to Hawaiian Electric Companies rolling blackouts for their power conservation efforts. If it weren't for my gas appliances, I would not be able to provide hot meals for my family. With people being forced to be on the electrical grid, this means that conservation tactics will be greater and cause an even bigger strain on an already failing system. While on this subject, my mother is a resident of Hawaiian Paradise Park, and when Hurricane Iselle came and destroyed much of the Puna area restricting their access here on the Big Island, she was able to stay safely in her home with the use of these gas-powered appliances. It only seems fitting that without the proper tools, backup efforts, and a guarantee that there will be no issues with electric energy people should be given the option to choose energy options as they see fit.

Along with households, businesses that rely on naturally gassed energy will also be taking a hit. As a preferred gas stovetop cooker, it is apparent that food cooked on a gas stove has great differences from the same dish cooked on an electric stove top. Cooking times are much faster, and heat is distributed differently as well. My significant other is a small business owner of our small own in Hilo, and his establishment relies on the use of these gas appliances. It is apparent that chefs and cooks tend to prefer gas appliances as the burners and ovens heat up faster and hold temperature better than electric appliances. There is hardly any small or large business that operates solely on electric stovetops. If this were the case and gas hookups were to be banned, the cooking times of these businesses would take a hit and could gradually affect business. This does not also cover the concern of the extra expenses of converting to electric costs. Electricity costs here in Hawaii are significantly higher than anywhere else in the continental United States. Therefore, businesses will also have to factor in another unexpected cost into their financials which can drive up prices and possibly slowly drive them out of business completely.

Finally, a major concern about HB835 is that the passing of this bill will kill hundreds of union jobs. With an already increasing poverty level, it only seems fitting that we take into consideration the struggles that families will face with losing jobs. Many families are forced to live paycheck to paycheck, with both partners needing to find jobs to support themselves and their children in an effort to stay afloat with the rising costs of living. This bill goes much further than trying to have a zero-emissions economy target. Electricity is an energy source however, when the electricity goes out, it leaves cities of large populations out of power for hours, sometimes even days, for HECO to resolve the issue to restore power. Then having to have a significantly large electric bill to top that off, how would that business do with the economy that Hawaii has now days? We will see another mom + pop shop close, sadly. Do we need that? No! The majority of the hotels in Hawaii rely on LPG to provide hot water, heat the pools, dish washing services and commercial kitchens. The number of complaints that will come in, the number of refunds that would have to be issued, the number of non-returned tourists. The list goes on.

As this trickles down, it hits home as it will affect long-term care assistance homes, schools of all sort, small businesses, the hospitals which are the core of Hawaii. If we are for the future, for our people, we need to be innovative and be smart of the energy sources we have. We can't depend solely on ONE energy source and expect that to work 100% of the time because it will not. When something doesn't work, we move on to the next option, for example in this case, when the electricity goes out, we have our LPG appliances to depend on. The number of jobs that could be lost due to this bill is substantial. The homes you will be causing hardship in, the dependable and reliable LPG providers that would have to go out of business because of this. This is not right; it has never been right. The fact that this was even a THOUGHT process, is ignorant.

I have and currently use a gas stove and dryer. The gas dryer allows me to conserve and control how much propane I will use in a month. Cooking on a gas stove uses less energy because it heats up faster than an electric stove or oven. Currently we have been experiencing frequent blackouts because Helco is not able to keep up with the demand of electricity. Notice have been given to communities to conserve energy during peak hours. Removing the option for gas appliances will greatly affect the ability of the citizens to cook food during times of significant weather events. Using propane as a fuel source is much cleaner than the alternative of either burning wood or using gasoline or diesel to operate a generator to power your house/cooking range. Besides the lack of reliability regarding electric stoves; cooking on gas is a much more enjoyable and effective method for those who enjoy cooking. You have more control of temperature by reducing flame size than you do on electric coil stoves. Residual heat is left in the coils which doesn't allow for fine adjustments. There is a reason why restaurants have gas ranges and not electric coil stoves and gas stoves, but are also more expensive, requiring specific cookware, and have the same reliability issues as mentioned before. Gas dryers are also more efficient than electric dryers and are cheaper to operate. They run hotter and dry faster which in turn uses less electricity. Propane refrigerators are also fairly common here for those who live off-grid.

Aloha,

My name is Judith Braaten and I live in Mililani, Hawaii, on Oahu.

I oppose HB 835 for the following reasons:

- I, and most of my friends, love cooking with gas. It heats faster, cooks more evenly and the food just seems to taste better when it's cooked more thoroughly, with less chance of food-borne illnesses. Because it heats faster, it also means spending LESS time in the kitchen and more time with the family.
- Most stove tops in Hawaii have range hoods or exhaust vents, which helps to keep the heat down in the kitchen and focused on the range top. I don't know anyone who cooks with the windows closed, either. This is Hawaii, you know.
- The alleged studies were in Europe regarding UNVENTED gas stoves (no doubt in enclosed rooms). There has been no definitive link found between gas stoves and asthma in children in worldwide studies. This was even admitted by RMI who released the study.
- Here, in Hawaii, we don't have Natural Gas, we have SYNTHETIC and RENEWABLE Natural Gas. It is a manufactured product using waste products from other industries that are manufactured into clean-burning gas. Waste products, I might add, that would otherwise pollute the aina. We are unique in that our methods in our state HELP, not hinder, reduction in global warming, contrary to what the activists say, who have not thoroughly done their research. Campfires have more harmful emissions than synthetic natural gas, but there is no pending ban on campfires.
- The plant used to manufacture the gas, here in Hawaii, already has a low carbon footprint. In fact, the plant uses more carbon than it emits. I understand emission is much lower than 3%. Can you say the same for electric?
- When the electricity goes out, gas is still available (and the electricity, here is NOT reliable, even though electric prices continue to rise. I was told my electric bill would rise about 7%, instead, it shot up 30%, and my usage DECREASED. This is outrageous!) Without electric power, gas customers still have hot water for sanitizing, and stove tops for cooking. Banning gas appliances only increases the load on the electric grid and we can expect even MORE outages. (Solar, while helpful, is not a cure-all, as it rains somewhere in Hawaii every day, making solar not completely reliable without a backup system in place. In many areas of Hawaii, solar is not feasible at all.)

- Everything causes cancer. I am far more worried about the chemicals in GMO foods than the emissions of gas stoves. The rise in illnesses, such as ADHD and autism is no doubt due to the chemicals in the foods we eat, and our poor diet choices, and not related to the type (gas or electric) of the stove we prepare it on.
- Forcing people to replace gas stoves with electric is not financially feasible for most. The added costs and hassles could very well be the tipping point and would mean losing even more qualified people to the mainland.
- Taking away consumer choices on vague studies that have little to no relationship on how we, here in Hawaii, live, is not the answer. Rather, it seems like a push for HECO to obtain a monopoly. Without options, Hawaii is unsustainable.
- In summary, this ban is illogical, expensive and a poor choice for Hawaii and her people.

So many of the Big Island's neighborhoods are built off the elctric grid, a result of decades of corruption and selfish acts at the state level from Honolulu based representatives in our blemished past. You would think the recent lava flows would have alerted our officials to the utter lack of care they have shown to these neighborhoods and residents, but alas they present a bill that would be extremely challenging to comply with for these off-grid neighborhoods. We already have a huge issue with people constructing without permits here, a result of our understaffed building and planning department (no surprise, who can work for \$500/week here and still ends meet,) this bill will only drive MORE unpermitted building in areas that are off-grid, which in turn will limit real property tax income and safety/code regulations. It's compounding the risk on the at-risk (read: no isurance, dangerous building practices, people driven to those communities because of the increase in home prices due to tourism and lack of development for residents, etc.) Addditionally on this topic I would venture to bet any house in any one of these off-grid communities, who are going to be mostly impacted by this bill, are more energy efficient than any home the legislators who wrote this bill live in (probaly 2-3x over.)

Adding the commercial limitations will only further the struggle for small businesses here. We have a huge lack of commercial capacity for small restaurants and limiting propane stoves will only lessen the likelihood a commercial development will include restaurant space. Small restaurants and businesses are the lifeblood of our community, we all know working for wages has it's limits and to stifle small businesses would be to stifle your constituents potential wealth building/ripple effect in the community. Plus, small businesses like restaurants play a huge role in our community connectedness, supporting local farmers, etc.

Lastly, the idea that limiting the use of propane stoves and switching to electric stoves is going to lessen our dependence on fossil fuels is a gimmick. I live less than 100 yards from the power plant in my town and I can hear the diesel generator from my house cranking power out to our homes and businesses DAILY. So, unless the entire grid is going to be replaced with solar, wind, geothermal, hydro or something other than fossil fuel, this bill is a feel good joke that doesn't accomplish it's goals. I'd rather see a bill mandating HELCO switch their power to something renewable or allow a proper buy-back like net metering which actually incentivized homeowners to upgrade to PV instead of the agreement they offer now which incentivises more grid-dependence, more profit for them. Or better yet a competitor in the power industry! We pay 76%

times more than the next most expensive state in the country, and now they are charging us a "green infrastucture fee" so we can pay for them to get current with the times?

I'm sorry this bill is just another stab to the residents of Hawai'i and I can't support it.
