7 The Department is committed to addressing the needs of individuals who live with 8 behavioral health challenges and need necessary treatment when it is in their best interest. 9 Methods to establish authorization to treat are important to ensure the application of those 10 services to those who would benefit from treatment over their objection. The Department 11 supports the availability and effectiveness of court and administrative procedures to obtain 12 authorization to treat over objection, including working with state agencies, the Judiciary, and 13 community partners to improve access and implementation.

We recognize that existing policies are not fully implemented at this time. Successful
 implementation depends on an aligned understanding of laws and policies across professional
 disciplines.

#### **Testimony of Marya Grambs**

#### I am writing in strong support of HB855.

While I write as an individual, I have served as Executive Director of Mental Health America of Hawai'i; I am President of the Board of Directors of Partners in Care's nonprofit arm, and a volunteer with IHS's Women's and Family shelter.

The Assisted Community Treatment law is a vitally important tool in addressing the plight of untreated severe mental illness among those experiencing homelessness. Many people, especially those suffering from psychotic conditions like schizophrenia, suffer from anosognosia, in which they *literally* do not know they are ill, thus they refuse treatment: they lack the capacity to make a judgment in their own best interests. Unable to take care of themselves, they often live in degrading and dangerous circumstances on our streets, victims of physical and sexual assault. We all see these individuals out in the community, and we all know that they are in dire need of help to escape the horrific downward spiral of hospital, jail, and streets. This law, and those governing emergency hospitalization and involuntary treatment, are critical, life-saving interventions, but they are not simple to carry out and their availability as an option is not widely known.

An educational and training effort will assist us, as a state, move towards more compassionately and proactively helping individuals such as these. Each one of these people is somebody's mother, daughter, brother, son; sometimes, it is often only involuntary hospitalization and/or community treatment that will enable them to have a chance to recover. Of course we want to help them, but without tools like ACT and involuntary treatment/hospitalization, we leave them to – literally - die on our streets.

Thank you for the opportunity to submit this testimony in support of these most vulnerable and marginalized members of our society.
