H.B. 939 amends section 235-5.5, Hawaii Revised Statutes (HRS), relating to Individual Housing Accounts (IHA), by increasing the maximum amount of deductible contributions to \$15,000 for single filers, and \$30,000 for joint filers, and the aggregate limitation paid in cash into an IHA to \$200,000 for all taxable years, excluding interest paid or accrued. The bill is effective upon approval and applies to taxable years beginning after December 31, 2023.

The Department is able to administer this bill by the current effective date.
