Thank you for the opportunity to provide testimony in **support of H.B. 962** which exempts Hawaiian language immersion program students from kindergarten assessment requirements.

The Legislature passed Act 46, Session Laws of Hawaii 2020 which mandated a common statewide assessment for all students entering kindergarten with the option for the assessments to be administered in either English or Hawaiian. However, since enactment, stakeholders and educators have identified that while some students entering kindergarten in a Hawaiian language immersion program are fluent in the Hawaiian language due to prior participation in the 'Aha Pūnana Leo Hawaiian language medium early learning and care model, other entering kindergarteners may have minimal or no experience with the Hawaiian language, therefore any assessments conducted in the Hawaiian language for these students will likely be poor solely due to the student's inability to understand the language of the questions. We are hopeful that support from Ka Haka 'Ula O Ke'elikōlani College of Hawaiian Language at the University of Hawaii at Hilo will help with determining appropriate standards and assessment tools.

Chair Woodson, Vice Chair Martin, and members of the Committee:

The State Public Charter School Commission ("Commission") appreciates the opportunity to provide **comments on HB962** which exempts Hawaiian language immersion program students from kindergarten assessment requirements.

While the Commission takes no position on this bill, the Commission does support efforts to develop an appropriate 'Ōlelo Hawai'i for DOE Papahana Kaiapuni and notes that it should not only reflect Hawaiian language education, but should also reflect the language and cultural goals of the Kaiapuni schools. The Commission and the Hawaii Department of Education, Office of Hawaiian Education have encouraged our Hawaiian Immersion schools to participate in the Office of Hawaiian Education's process for developing this assessment. It is essential that the distinct linguistic, cultural, and educational goals of Hawaiian language immersion education are reflected in and considered foundational in the development and administration of the kindergarten entry assessment. The Commission is deeply grateful to the Department and the Office of Hawaiian Education for including our schools in this work.

Additionally, the Commission notes that HRS **§302D-37(b)**ⁱ has already provided the Commission with the authority to waive the requirement for a public charter school to administer the assessment on a case by case basis, of which the Commission is currently working on a process for such a waiver. The Committee might consider affording a similar waiver for DOE Hawaiian Immersion schools as well.

ⁱ §302D-37 Standardized assessment for students entering kindergarten. [Section effective July 1, 2023.] (a) The commission shall adopt the kindergarten entry assessment adopted by the board pursuant to section 302A-1165(a) to assess all charter school students entering kindergarten within the first thirty days of admission into kindergarten.

⁽b) The commission may waive the requirements of the uniform kindergarten entry assessment on a case-by-case basis.

⁽c) The commission shall share the information gathered from public charter schools pursuant to this section with the department, department of human services, and executive office on early learning to the extent not otherwise prohibited by administrative rule or law. [L 2020, c 46, pt of §3; am L 2021, c 210, §9]

Purpose of Bill:	Exempts Hawaiian language immersion program students from kindergarten assessment requirements.

Department's Position:

The Hawaii State Department of Education (Department) respectfully opposes HB 962 concerning the exemption from the Kindergarten Entry Assessment (KEA) in 'ōlelo Hawai'i for Ka Papahana Kaiapuni and offers comments and concerns.

Act 46, Session Laws of Hawaii (SLH) 2020 (Act 46) and Act 210, SLH 2021, amongst other mandates, required the Department to administer a uniform kindergarten entry assessment (KEA) to assess all incoming kindergarten students in English or Hawaiian, as part of a larger goal to expand the capacity, early learning, and availability of public pre-kindergarten. While there is merit for a KEA to collect data for the classroom teacher, the statewide collection of data will enable state agencies to determine early childhood needs to identify the highest priority geographic regions requiring pre-kindergarten programs to meet the needs of under served eligible children.

The purpose of any KEA, in any language, is to assess the development of children in order to determine appropriate instructional supports and enrichments to ensure that all children are successful in the given educational context. The children who enter kindergarten in a Kaiapuni context are all developmentally unique, and it behooves their teachers to find out as much as possible about each child's development in order to adapt the educational program to better support each child.

The Department suggests the development of a KEA for the Kaiapuni context that appropriately and respectfully assesses children developmentally, while also sensitively accounting for the fact that the children are still developing proficiency in 'ōlelo Hawai'i. The Department wishes to rely upon the expertise of the kumu Kaiapuni and the larger Kaiapuni community to develop an assessment that will not negatively impact students at kindergarten entry, while also providing important developmental information to teachers that can be used to guide instruction and intervention.

The Department does understand the intent of HB 962, and wants to stress that it is committed to

upholding and enhancing our dual-language educational system from the very beginning of each child's entry into kindergarten in the Department. The Department acknowledges the unique challenges faced by the Kaiapuni community, and therefore wishes to collaborate with the Kaiapuni schools and teachers to create the most appropriate KEA that will assess children's developmental needs while also honoring their positions as new learners of 'ōlelo Hawai'i.

The Department recommends amending the law to align with HB 842 and provide time to the Department to develop a Hawaiian Language Medium Education Kindergarten Entry Assessment (KEA).

HB 962 - RELATING TO HAWAIIAN LANGUAGE PROGRAMS

Chair Woodson, Vice Chair Marten, and Members of the Committee:

Thank you for the opportunity to submit testimony on HB 962. The University of Hawai'i at Hilo (UH Hilo) urges passage of HB 962 without amendments. HB 962 seeks to exempt Hawaiian language immersion program students from kindergarten assessment requirements.

Among the colleges of UH Hilo is Ka Haka 'Ula O Ke'elikōlani (College), the Hawaiian language college established by statute, HRS §304A-1301. The College has a laboratory school program that includes the majority of preschools and charter schools where students are taught through Hawaiian. A large number of 'ohana in those schools have expressed their desire to have Hawaiian medium kindergartens exempt from any Board of Education and Department of Education developed kindergarten assessment. UH Hilo and the College support the will of those 'ohana as provided for in Sections 2 and 4.

UH Hilo and the College support Sections 3 and 5 regarding kindergarten entry disclosure of languages used in any preschool attended by a child.

UH Hilo and the College also support Section 6. This section provides that for the College's laboratory preschools funded through the Charter School Commission, the College is to take responsibility for improving language and academic outcomes and that appropriate data be collected from those laboratory school programs to be shared with various departments of the state government. With the College taking on the above responsibilities, the laboratory school preschools will be exempt from requirements placed on other preschools funded through the Charter School Commission.

UH Hilo and the College also support Sections 7 and 8, which further clarify the functions of the College and its use of moneys in its trust fund.

We are aware that HB 962 does not include any funding for the functions assigned to it through HB 962. UH Hilo and the College have sufficient resources to carry out the functions assigned to it by HB 962, at present, given the relatively small number of students that would be affected by this bill for the next few years into the future.

Mahalo for this opportunity to testify in strong support of HB 962.

Chair Woodson and Members of the Committee:

The Hawaii State Teachers Association is <u>supports HB 962</u>, relating to Hawaiian Language Programs. This bill Exempts Hawaiian language immersion program students from kindergarten assessment requirements.

It is not only important to consider 'ōlelo Hawai'i, when developing such an assessment, but also the Hawaiian culture in the implementation of such an assessment to ensure the relevance of such an assessment for our keiki in our Hawaiian Immersion schools (Kaiapuni Schools). Many Kindergarten students who enter Hawaiian Immersion Programs may not speak Hawaiian until the end of Kindergarten, so it would be unfair to give this assessment in Hawaiian, but at the same time it would not align with the Hawaiian Immersion program if they had to give this assessment in English either, as it goes against what they do in Hawaiian Immersion schools (Kaiapuni Schools) by speaking only 'ōlelo Hawai'i. It is very impressive that most Kindergarteners in Hawaiian Immersion Programs do speak, understand, and are learning to write in Hawaiian by the end of Kindergarten. We applaud their efforts to bring back 'ōlelo Hawai'i as well as their culture and we want to support them more.

We also strongly urge the DOE to consult our Hawaiian Immersion public schools, including Hawaiian Immersion public charter schools, and their teachers, for their valuable input about this particular assessment. Their input should be in the forefront over anyone else's input.

The Hawaii State Teachers Association asks you to please support this bill.

Aloha Chair Woodson and Vice Chair Marten and members of the committee,

My name is Ka'iulani Laehā, Chief Executive Officer of the 'Aha Pūnana Leo. The 'Aha Pūnana Leo is the only statewide provider of Hawaiian medium early childhood programs and education servicing up to 350 students annually. We stand on 40 years of experience in language revitalization and early childhood related programs. Each year over 90% of our graduates continue into public Hawaiian language medium or immersion programs.

The 'Aha Pūnana Leo strongly supports HB 962.

HB962 and its companion bill is a solution for addressing an imbalanced education system in a way that leads to long term equitable access for generations to come for the goals of Hawaiian language revitalization.

HB962 addresses the discrimination of keiki by exempting kaiapuni schools from the kindergarten entry assessment. The Board of Education action supporting a KEA was made solely to address the compliance of Act 210 for a KEA in either English or Hawaiian. This action was in spite of the department acknowledging that of the approximately 400 kaiapuni keiki **a majority of the children entering into kindergarten in immersion schools do not 'ōlelo Hawai'i**. (Oct.6 SAC board meeting).

There is no purpose for administering KEA to keiki in Hawaiian language medium programs; whether entering into Kaiapuni schools from a Pūnana Leo or otherwise, these assessments will only produce inconsistent data, wrongfully inform instruction, and misinform parents. Ultimately, requiring KEA for Kaiapuni schools, and for teachers of Kaiapuni schools to be trained on administering an assessment that is inappropriate for Hawaiian immersion programs does not in any way benefit our keiki, kumu, 'ohana or kaiaulu nor does it meet the legislative intent of assessing kindergarten readiness. The consensus after discussions at a stakeholder meeting comprised of kumu, administrators of charter schools and DOE programs, OHE, 'Aha Pūnana Leo, and others was that the DOE shall seek to "amend act 210 - permanent exemption from KEA for all Hawaiian language medium and immersion schools"; please refer to the photo below of the working sheet used and reviewed at the November stakeholders meeting. HB 962 provides exemption for papa mālaa'o Hawaiian language medium classrooms from the DOE kindergarten entry assessment in alignment with the feedback from the stakeholder group. Without exemption the DOE will be required to be compliant with legislation that does not provide unique consideration for the Hawaiian language medium programs in order to support the revitalization of our native language.

We are a very fragile system, any added burdens or barriers to entry (such as data that poorly represents the quality of our program discouraging 'ohana to enroll) will negatively impact our efforts.

HB962 includes amendments to HRS 304A-1302 of the state college of Hawaiian language. The college works with us to provide early childhood teacher training, language fluency development, curriculum development, assessments and action research. Together with the public charter Ke Kula 'o Nāwahīokalani'ōpu'u and the college we demonstrate a Hawaiian medium education pathway from infant-toddler through doctoral degree education.

HB 962 includes collecting information on the primary medium of instruction in early learning programs and any other language that was taught in addition to the primary language of instruction. We see this data as useful in understanding Hawai'i's early learning settings and inform our agencies and policy makers of the many providers that are caring and educating our keiki. The information gathered will be useful in developing good policy to support our youngest learners in the variety of settings prior to kindergarten.

Testimony of Dr. Kauanoe Kamanā, Director, Principal Ke Kula 'O Nāwahīokalani'ōpu'u

HB962, RELATING TO EDUCATION STRONGLY SUPPORT

E ka Luna Hoʻomalu Woodson, ka Hope Luna Hoʻomalu Marten a me nā lālā Kōmike Hoʻonaʻauao, Aloha pumehana kākou,

My name is Dr. Kauanoe Kamanā, Director and Principal of Ke Kula 'O Nāwahīokalani'ōpu'u (Nāwahī), a P-12 laboratory school of the Hawaiian Language College, Ka Haka 'Ula o Ke'elikōlani (KH'UOK) at UH-Hilo. Nāwahī has a current enrollment of 646 in its Kea'au campus and two satellite sites in Waimea and Wai'anae. As a Hawaiian language medium school, families choose Nāwahī for its integrity, research history and a nearly 30-year reputation of providing quality education rooted in the Kumu Honua Mauli Ola philosophy and in the use and study of the Hawaiian language.

Ke Kula 'O Nāwahīokalani'opu'u strongly supports HB962

HB962 will exempt kindergarten assessment requirements for Hawaiian language immersion programs, and thereby protect and guard those programs from being negatively impacted by a standardized assessment that is required to align with the English language medium assessment of Johns Hopkins University.

I was invited to give a brief presentation on Nāwahī assessments at the the Office of Hawaiian Education's (OHE) Kaiapuni Stakeholders meeting on the Kindergarten Entry Assessment (KEA) on November 1, 2022. I focused on Nāwahī's use of 'Aha Pūnana Leo (APL) curriculum-based measures (CBM)¹ for over 20 years, and informed the stakeholders of Nāwahī's intent and rationale for opposing Act 210.

Overall stakeholder input and recommendations for next steps included a statement that the DOE should seek legislative action to amend Act 210 for a permanent exemption from KEA requirement for all Hawaiian medium and immersion schools. (See attachment below)

I was shocked that there was no mention by OHE of the stakeholder's request for permanent exemption from KEA or of the rationale relative to that request in its testimony before the

Board of Education on December 15, 2022. This was especially disturbing since Chairperson Voss asked if OHE thought its standing recommendation was "pono", and still nothing was said regarding the exemption from KEA as an agreed upon next step documented at the stakeholders meeting.

HRS 304-A-1302 requires that the DOE collaborate with the Hawaiian Language College and its laboratory school listed in HRS 302H-7, that being Ke Kula 'O Nāwahīokalani'ōpu'u. Prior to my invitation to the stakeholders meeting on November 1st, Nāwahī was not sought out to collaborate and provide expertise on Hawaiian language medium education and assessments. We were not given the opportunity to advise early on in the process, and subsequently called upon after much of the discussion and decision-making had taken place.

Nāwahī is opposed to spending excessive amounts of money on an effort that will work against the fundamental mission and vision of Nāwahī education as a Hawaiian language medium P-13 pathway. The KEA will create inaccurate data, misinform families and misalign with the strategies for success that we've experienced over the past 30 years.

HB962 requires Hawaiian language medium schools and programs the protections given to English language medium schools and programs. HB962 reflects the strategies and practices that have proven successful over the past 40 years of Hawaiian culture and language revitalization including the use of valid and reliable assessments. This year marks the 40th anniversary of the 'APL. Its thirteen preschools around the state have planted the seeds of Hawaiian language medium education and advocated the BOE for establishing follow-up DOE and charter schools programs since 1986. The commitment of families who choose Hawaiian language medium education, comprise the motivation through which we now have three generations of children who have either already graduated or are currently enrolled in Hawaiian language immersion/medium schools and programs.

Nāwahī grew out of 'APL efforts, and builds on the language and knowledge of our kūpuna, preparing new generations for life in a contemporary global society firmy rooted in the Hawaiian worldview. The KEA will fail to provide the kind of data that will best serve the children, families and teachers of Hawaiian Language schools.

TESTIMONY IN SUPPORT OF HB 962 BEFORE THE HOUSE EDUCATION COMMITTEE FEB. 2, 2023 Dr. William H. Wilson

Aloha Chair Woodson Vice Chair Marten and members of the Education Committee,

My name is Dr. William H. Wilson. I strongly support HB 962. It exempts kindergartens taught through Hawaiian from an inappropriate single standardized assessment through Hawaiian discussed in my testimony in opposition to HB 842. Here, I want to address the early childhood features of HB 962, which I also strongly support.

HB962 requires disclosure of the languages used and taught in any preschool a child has attended. This will allow kindergartens, including kindergartens taught through Hawaiian to know if the child had any previous use of Hawaiian. At present a large percentage of children entering Hawaiian medium kindergartens do not speak Hawaiian.

HB962, under Section 6, exempts the laboratory preschools of the Hawaiian language college, as it does special education programs and Title I-funded prekindergartens of the requirements of 302D-39. This is important because Section 6 is based on research in early education through English, including the certification of teachers that is based in methodologies researched as suitable for English. Some preschools using Hawaiian may chose to follow the same regulations as applied to other preschools, which is a choice allowed in Section 6.

We have had considerable success with our laboratory school program (See Attachement). At present all 13 Pūnana Leo Hawaiian medium preschools are laboratory schools of the College, while 3 Hawaiian language charter schools that have Hawaiian medium preschools are also laboratory schools of the college. Those schools all requested the College to include them in its laboratory program. At present there is only one charter with a Hawaiian language medium preschool that is not a laboratory school of the College. There is the option for it to request participation in the program as well as may any future Hawaiian medium charters.

Within Section 6, G (n) certain requirements of laboratory preschools of the Hawaiian labnguage college are placed upon them and the College. Those include annually working with together to improve language and academic outcomes and the collection of data with the Charter School Commission. The College has experience in both of these functions. Through the Pūnana Leo schools and its largest laboratory school Nāwahīokalani'ōpu'u, we have experience working with the Commission relative to exit (not entrance) assessments based on Hawaiian language research done in preschool and have had the assessments judged valid and reliable by the US Department of Education.

HB 962 also includes clarification of the functions of the College and its use of its existing funding. However, HB 962 does not include any addition funding. I do not support additional funding for the above purposes for at least the next few years.

EXPLANATORY NOTES:

- (1) The Native Hawaiian students at Nāwahīokalani'ōpu'u are part of the single largest racial/ethnic group in state HIDOE public and charter schools, where they represent some 26% of all students. Nāwahīokalani'ōpu'u has no racial/ethnic criteria for enrollment, however, non-Native Hawaiian students typically make up no more than 5% of the Nāwahīokalani'ōpu'u enrollment. Most non-Native Hawaiian students at Nāwahīokalani'ōpu'u are, like the Native Hawaiian students, multiracial. Within public and charter schools as a whole Native Hawaiians are a racial/ethnic group with a significant achievement gap.
- (2) Nāwahīokalani'ōpu'u operates as a Hawaiian language medium school (HRS 304H 1-7) designed for students entering school as Hawaiian speakers. HIDOE classifies students as EL if a non-English language such as Hawaiian is their first language, the language most used in their home, or the language most used by the student. However, the HIDOE does not officially record Nāwahīokalani'ōpu'u students as EL with EL services unless they transfer to a state English medium school. Under the Native American provisions of the ESEA definition of EL all Native Hawaiian Nāwahī students would meet the EL definition.
- (3) Nāwahīokalani'ōpu'u is by law is a laboratory school of the Hawaiian language college (HRS 304A 1301-1302). The fall 2021 P-12 enrollment at Nāwahīokalani'ōpu'u was 535 at its Kea'au campus. (Satelite campuses are in Waimea and Wai'anae are not included here.) The Nāwahīokalani'ōpu'u elementary and middle school programs are operated as a charter school and explore ways to better adapt charter schooling to Hawaiian language medium education. The Nāwahīokalani'ōpu'u high school program operates as an off-campus Hawaiian language medium

program of Hilo High School and explores ways to better adapt standard public schooling to Hawaiian language medium education. Funding for its students goes to Hilo High School. At the preschool level, Nāwahīokalani'ōpu'u operates a program that bridges a state charter operated program and the Native Hawaiian non-profit 'Aha Pūnana Leo operated infant-toddler program and language nest preschool exploring ways that such cooperation can benefit students in the state.

- (4) Nāwahīokalani'ōpu'u also serves as a training site for student teachers from the College's Hawaiian language medium teacher education program.
- (5) The Nāwahīokalani'ōpu'u senior class of 30 is part of the larger Hilo High School class of 263.
- (6) The Nāwahīokalani'õpu'u high school program is located on a distinct campus in the Puna District thirty minutes from the Hilo High School campus. Nāwahīokalani'õpu'u students participate with other Hilo High School students in athletics and extracurricular events (e.g., prom, commencement).
- (7) Nāwahīokalani'ōpu'u has consistently outperformed the state average in high school graduation since its first graduation in 1999. That was the first class graduating from a Hawaiian language medium school in over a century. The state of Hawai'i high school graduation rate as an average for students of all races has been 83%-86%, with the rate for Native Hawaiian students at around 79%.
- (8) Nāwahīokalani'ōpu'u has a long history of outperforming the state average in direct enrollment in college. The college going rate directly from high school for Hawai'i public schools as an average of all races is approximately 50%-55%, with the rate for Native Hawaiian students at 35%-44%. Nāwahīokalani'ōpu'u's students have been able to enroll in out-of-state universities as well as the state Hawaiian language college and other state tertiary institutions. Among out-of-state universities from which Nāwahīokalani'ōpu'u students have graduated are Loyolla Marymount, Northern Arizona and Stanford.
- (9) Students who demonstrate readiness for Nāwahīokalani'opu'u's early college program are enrolled in Hawaiian language medium courses that allow completion of one of two certificates offered by the University of Hawai'i at Hilo, either a) the Hawaiian Culture Certificate (19 credits no less than 10 at the 300 level or higher) or b) the Multidisciplary Hawaiian Studies Certificagte (26 credits with no less than 10 at the 300 level or higher).
- (10) Among the sports in which these Nāwahīokalani'ōpu'u seniors have participated are football, girls soccer, boy's soccer, boy's basketball, girl's volleyball, boy's volleyball, girl's softball, track and field, riflery, Hawaiian outrigger canoe paddling, boy's wrestling.
- (11) Hawai'i's requirements for the Seal of Biliteracy include a 3.0 overall high school grade point average, a 3.0 gradepoint average in Language Arts classes in an official state language (English or Hawaiian) and passing a national on-line assessment of another language at the equivalent of ACTFL Intermediate Mid. All Nāwahīokalani'ōpu'u students who have met the grade point requirements for the Seal and who have chosen to take the on-line assessments for the Seal have passed the assessment. Nāwahīokalani'ōpu'u students use a 3.0 gradepoint average in Hawaiian Language Arts as their base and take an on-line assessment in another language (typically English) for the Seal. Since the initiation of the Seal in 2017, Nāwahīokalani'ōpu'u students have comprised a considerable percentage of awardees statewide.
- (12) Hawai'i requirements for an honors certificate include a 3.0 overall gradepoint average, no less than two credits at the AP or college level and completion of one or more distinct courses of study as described at

HB 962 exempts kindergarten students taught through 'ōlelo Hawai'i from a standardized test based on English standards. The education pathway has been a successful strategy in revitalizing 'ōlelo Hawai'i. But, 'ōlelo Hawai'i is still a very endangered language and requires thoughtful planning and diligence, especially in gathering data. Passing this bill will give more time for discussion and determination of the proper path toward language vitality.

As outlined in the bill, the Kaiapuni (Hawaiian Immersion) context has many complexities. In addition, there are other critical longstanding areas to address first. Therefore, I urge you to **PASS HB 962.**
