#### Testimony of MARK B. GLICK, Chief Energy Officer

In SUPPORT of SB 1191, SD2

#### RELATING TO TRANSIT-ORIENTED DEVELOPMENT.

Chairs Hashimoto and Ichiyama, Vice Chairs Aiu and Poepoe, and Members of the Committees, the Hawaii State Energy Office (HSEO) supports SB 1191, SD2, which appropriates funds for statewide planning and coordination for transit-oriented development (TOD) projects identified in the state strategic plan for transit-oriented development. HSEO's comments are guided by its mission to promote energy efficiency, renewable energy, and clean transportation to help achieve a resilient, affordable, and decarbonized clean energy economy.

Ground transportation is responsible for about 25 percent of Hawaii's greenhouse gas emissions,<sup>1</sup> and vehicle miles traveled (VMT), a metric that correlates with GHG emissions from fossil-fueled ground transportation, has increased by over 30% since 2000.<sup>2</sup> For Hawaii to meet its statutory target "to sequester more greenhouse gases than emitted as soon as practicable but no later than 2045", significant reductions in emissions from ground transportation will need to be made in the near to medium term. SB 1191, SD2 will provide funds for fiscal year 2023—2024 to maintain and

enhance capacity to support planning of state and county transit-oriented development projects, which will reduce the energy intensity of the transportation system and associated emissions.

The duties of the Chief Energy Officer per HRS 196-72 to support the clean energy initiative include providing technical assistance to state and county agencies to assess and implement programs related to clean transportation; evaluating, recommending, and participating in the development of programs that encourage clean transportation; and advocating for the State's energy and decarbonization goals at departments to ensure that state energy policies and regulations align with the state strategic goals and are data-driven.

SB 1191, SD2, may be particularly impactful in reducing the energy intensity of the transportation system because it supports the planning and implementation of TOD and smart growth. TOD and smart growth focus on compact development built around a transit station or within easy walking distance (typically a half-mile) of a station and contains a mix of land uses such as housing, offices, shops, restaurants, and entertainment. As a result, it becomes easier for people to meet many of their daily needs by foot, bike, and/or transit, rather than by personal vehicle.<sup>3</sup>

Multiple studies have quantified the relationship between public transportation, land use, and reduction in travel. Studies show that for every additional passenger mile traveled on public transportation, auto travel declines by 1.4 to 9 miles.<sup>4</sup> In other words, in areas served by public transportation, even non-transit users drive less because destinations are closer together. One study used modeling to isolate the effect of public transportation on driving patterns (rather than that effect combined with denser land use creating a need for improved public transportation).<sup>5</sup> That study, conducted by consulting firm ICF and funded through the Transit Cooperative Research Program (TCRP), found that each mile traveled

on U.S. public transportation reduced driving by 1.9 miles.<sup>6</sup> It concluded that public transportation reduces U.S. travel by an estimated 102.2 billion vehicle miles traveled each year, or 3.4% of annual U.S. VMT.<sup>7</sup> Similarly, a study published by the Urban Land Institute found that within areas of compact development, driving is reduced 20% to 40% compared to average U.S. development patterns.<sup>8</sup>

In addition, TOD and smart growth can help lower household transportation costs, boost public transit ridership, spur economic development, and make housing more affordable by reducing developer expenditures on parking and allowing higher-density zoning.<sup>9</sup>

#### in consideration of SB1191, SD2 RELATING TO TRANSIT-ORIENTED DEVELOPMENT.

Chairs Hashimoto and Ichiyama, Vice Chairs Aiu and Poepoe, and Members of the House Committees on Housing and Water and Land:

The Office of Planning and Sustainable Development (OPSD) **strongly supports** and offers the following comments on SB1191, SD2, which would appropriate general funds to the Hawaii Community Development Authority (HCDA) for statewide planning, designing, and constructing of various transit-oriented development projects identified in the state strategic plan for transit-oriented development (TOD).

We support the bill's focus on implementing and expediting TOD-related infrastructure improvements statewide, and appropriating certain funds for design and construction to HCDA. Per past legislative practice, we suggest rather than targeting specific TOD projects for planning funds that a lump-sum be appropriated to OPSD to award as grants for planning, infrastructure feasibility, and environmental studies for projects in the State TOD Strategic Plan. The OPSD has a strong track record of awarding and administering planning grant funds to State and county agencies with the guidance of the Hawai'i Interagency Council for Transit-Oriented Development (TOD Council).

We note that some of the listed projects are CIP budget requests being made by other agencies, such as the Hawaii Housing Finance and Development Corporation, University of Hawai'i, Department of Accounting and General Services, and the Hawai'i Health Systems Corporation. We recommend consideration of appropriation of these CIP budget requests to their respective functional agencies in the budget bill, or in a separate appropriation in this bill. Alternatively, a provison could be added to the bill that allows HCDA to transfer funds to another agency, as needed.

#### In consideration of SENATE BILL 1191, SENATE DRAFT 2 RELATING TO TRANSIT ORIENTED DEVELOPMENT

Senate Bill 1191, Senate Draft 2 proposes to appropriate funds to the Hawaii Community Development Authority (HCDA) for statewide planning, designing and constructing of various transit oriented development projects identified in the State Strategic Plan for transit oriented development (TOD). The Department of Land and Natural Resources (Department) strongly supports this measure.

The Department is currently in the planning process for its East Kapolei TOD project. The East Kapolei TOD Project consists of four parcels adjacent to and/or in close proximity to the Keone'ae Rail Station in East Kapolei which could be impacted by this measure. The Department's long-term objective is to lease the parcels for income generating purposes to support the Department's natural resource management and protection programs through the development of mixed uses including a higher density mixture of affordable and other types of rental housing, commercial, retail, hotel, and medical spaces as well as light industrial uses. The Department recognizes the State's obligation to provide affordable housing to residents in need and notes that Department is already planning on working with the Hawaii Housing Finance and Development Corporation for a multi-family affordable housing project located on the parcel east of Kualakai Parkway. Beyond generating income to support its programs, the Department believes that the proposed project's multiple uses will be a critical economic, employment and residential component of the East Kapolei community.

Thank you for the opportunity to testify on this measure, which appropriates funds to the Hawaii Community Development Authority ("HCDA") for statewide planning, designing, and constructing of various transit-oriented development projects identified in the state strategic plan for transit-oriented development.

The University of Hawai'i ("University") is the landowner near four of the rail stations that are located adjacent to or on three University campuses. The Hawaii Community Development Authority, as the designated expending agency for capital improvement projects authorized in this Act, with the approval of the governor, may delegate to other state agencies the implementation of projects, including the transfer of funds to implement those projects, when it is determined to be advantageous to do so by the Hawaii Community Development Authority as the original expending agency and the agency to which expending authority is to be delegated."

#### In consideration of SB 1191, SD2 Relating to Transit-Oriented Development.

Chairs Hashimoto and Ichiyama, Vice Chairs Aiu and Poepoe, and members of the Committees.

The Hawai'i Community Development Authority ("HCDA") recognizes the extent and scope of the twenty-three projects contained in this bill, and acknowledges the trust placed in HCDA to implement these projects in a timely manner.

HCDA **supports SB 1191, SD 2**, that appropriates unspecified funds to HCDA for statewide planning, designing and construction of various transit-oriented development ("TOD") projects. HCDA, however, respectfully offers observations and suggestions for the consideration of the committees.

Infrastructure is essential to support development across the State and is integral to building vibrant communities.<sup>1</sup> More specifically, a major barrier identified by the Hawaii Interagency Council for Transit-Oriented Development ("TOD Council") to TOD implementation identified by the TOD Council and other stakeholders is the lack of adequate infrastructure in areas designated for TOD development.<sup>2</sup>

Prompted by the opportunities and challenges for redeveloping along a transit corridor, the Legislature:

• Established the TOD Council through Act 130 (SLH 2016) to coordinate effective and efficient TOD planning statewide and to prioritize TOD projects;

• Directed (through Act 130) the TOD Council to develop and implement a strategic plan for TOD, which resulted in the preparation of the *State of Hawaii Strategic Plan for Transit-Oriented Development* (2017, Rev. 2018) that establishes the strategic plan for TOD, including mixed-use and affordable rental housing; and

• Established the Transit-Oriented Development Infrastructure District program, placed under HCDA, through Act 184 (SLH 2022) to facilitate the renewal and redevelopment of areas designated by State and counties for transit-oriented development.

This suggests that the agency framework for transit-oriented development, for planning, prioritization, and implementation is as follows:

- The Office of Planning and Sustainable Development ("OPSD"),
- TOD Council,
- Hawai'i Housing Finance & Development Corporation ("HHFDC"),
- The Hawai'i Community Development Authority, and
- Other State agencies.

The bill describes twenty-three planning and infrastructure development projects statewide, including proposals from the Department of Accounting and General Services ("DAGS"), OPSD, University of Hawai'i-West Oahu ("UHWO"), Hawai'i Health Systems Corporation ("HHSC") and HCDA.

It is HCDA's desire to implement as many of these projects as possible. However, the breadth and scope of these projects suggests that a multi-agency approach may be necessary for implementation, especially given the need to expeditiously plan, design, and construct statewide TOD projects and much-needed infrastructure, statewide. The OPSD, HCDA, HHFDC, UHWO, and DAGS have developed a coordinated approach for implementation. For the committee's consideration, we suggest the following:

• Amending this bill to incorporate an approach that allows the HCDA to review each project in more depth, carry out the projects that HCDA can execute on, and transfer the implementation of other projects to other state agencies as necessary to ensure that projects are completed timely and efficiently, considering timing of the funding, and prioritization. If a project is transferred to another State agency for implementation, HCDA will coordinate the transfer to ensure an orderly transfer. For example, OPSD may be the more appropriate agency to implement the TOD planning projects, since OPSD is the agency tasked with undertaking planning activities (i.e. a "subject-matter agency"). HHFDC, as the agency that originally developed the Villages

of Kapolei, might be better suited for the road rehabilitation project since HHFDC has the background and knowledge of the Villages of Kapolei project (i.e. a "home agency"). Similarly, UHWO may be able to more efficiently implement the TOD infrastructure projects that are situated on university lands (i.e. a "land-owner agency").

• A new section could be inserted after Section 3 of the bill to read as follows:

"SECTION \_\_\_\_. The Hawai'i Community Development Authority, as the designated expending agency for capital improvement projects authorized in this Act, with the approval of the governor, may delegate to other state agencies the implementation of projects, including the transfer of funds to implement those projects, when it is determined to be advantageous to do so by the Hawai'i Community Development Authority as the original expending agency and the agency to which expending authority is to be delegated."

• Utilizing two (2) FTE and vacant positions within the Department of Business, Economic Development, and Tourism to augment HCDA staff's capacity to undertake the TOD infrastructure projects identified as priority projects, and other TOD projects listed in the bill.

#### RESOLUTION

#### SUPPORTING THE APPROPRIATION OF SUFFICIENT FUNDS FOR THE SARATOGA AVENUE ELECTRICAL AND COMMUNICATION INFRASTRUCTURE IMPROVEMENTS

WHEREAS, the current electrical infrastructure in Kalaeloa community development district (KCDD) is owned and managed by the US Navy; and

WHEREAS, the KCDD has struggled with unreliable utilities for years that is an impediment to further community development in the KCDD; and

WHEREAS, the state budget includes an appropriation for an electrical and communications infrastructure corridor to be constructed, with a 12kV underground electrical distribution line built to HECO standards, on Saratoga Avenue from Enterprise Avenue to Hornet Avenue, at a cost of \$12,125,000 (the "Project"); and

WHEREAS the Project will provide reliable power to residents, businesses, and landowners in that downtown area of KCDD; and

WHEREAS, the Project will also support economic growth, including additional housing and commercial development resulting in additional jobs and opportunities; and

BE IT RESOLVED that the Makakilo/Kapolei/Honokai Hale Neighborhood Board No. 34 supports the appropriation of sufficient funds for the Saratoga Avenue Electrical and Communication Infrastructure Improvements; and

The Maui Metropolitan Planning Organization **supports** SB 1191 S.D. 2. This bill will provide the funding that catalyzes public and private investments in healthy communities that are walkable, provide a range of transportation options, affordable housing and a network of connected parks and open spaces all of which bring tremendous benefit to our communities

The County of Maui received approval for the Ka'ahumanu Community Corridor TOD Action Plan by the Hawaii Interagency TOD Council last year. In 2022, after final approval of the West Maui Community Plan update, the County of Maui received funding for the West Maui Community TOD Corridor study of which the primary objective is to implement some of the transportation and housing actions from the community plan update including: better connectivity of sidewalks and multiuse paths, increasing the frequency and availability of transit routes, and locating a transit hub close to affordable housing, commercial centers and schools. The South Maui Community Plan is currently in the review and approval process. Once the Plan update is approved, the South Maui TOD Corridor Study would begin in order to implement the various elements of the Plan update calling for better sidewalk connectivity, a new transit hub and more public transit in close proximity to affordable and work force housing areas.

The Maui experience has shown that these TOD planning efforts result in agencies and stakeholders working together to identify key actions to develop affordable housing, multi-modal transportation options, and economic vitality along the TOD corridor.

#### SB 1192 SD2 Relating to Transit-Oriented Development

The Oahu Metropolitan Planning Organization (OahuMPO) supports Measure SB 1192 SD2.

The OahuMPO is the federally designated Metropolitan Planning Organization (MPO) on the island of Oahu responsible for carrying out a multimodal transportation planning process, including the development of a long-range (25-year horizon) metropolitan transportation plan, referred to as the Oahu Regional Transportation Plan (ORTP) that encourages and promotes a safe and efficient transportation system to serve the mobility needs of people and freight (including walkways, bicycles, and transit), fosters economic growth and development, and takes into consideration resiliency needs, while minimizing fuel consumption and air pollution (<u>23 CFR 450.300</u>).

The purpose of SD 1192 is to appropriate general funds to the Hawaii community development authority for fiscal years 2023-2025 for the planning, designing, and constructing of transitoriented development projects. Currently, these funds are garnered using appropriations and request for funding has consistently exceeded available funds.

The U.S. Federal Transit Administration (FTA) notes that Transit-Oriented Development (TOD) enables the development of "dense, walkable, mixed-use development near transit." This type of development creates connected communities and can support the development of affordable housing leading to more equitable communities. It is imperative to initiate affordable housing as well as increased access to alternative modes of transportation.

We find that SD 1191 SD 2 supports OahuMPO's goals of: 1) promoting economic development through increased improvements to the transportation system, 2) providing a more equitable transportation system, and 3) promoting improved air quality via the expansion of the use of public transit.

The Hawaii Military Affairs Council ("MAC") supports SB 1191, SD2, specifically projects under (7) Kalaeloa electrical undergrounding and (8) Saratoga Avenue electrical upgrade.

The Hawaii Military Affairs Council (MAC) was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

The Kalaeloa Community Development District (KCDD) encompasses approximately 3,700 acres of land within the former Barbers Point Naval Air Station (BPNAS) in Leeward Oahu. To enable redevelopment and advance mixed-use and affordable housing development, the KCDD requires energy reliability, security, and resilience. Since Barbers Point was closed more than 20 years ago, the electrical utilities have not received any systematic upgrades or renewal.

The MAC has worked with the Hawaii Congressional Delegation (CODEL) to authorize the Secretary of the Navy to work with the State of Hawaii to install a new electrical system and then to move the non-Navy customers off the Navy system to the new electrical system. This includes the Army National Guard. An appropriations request has been submitted to the CODEL for their consideration in FY'24.



This will allow more development plans to proceed. For example, the first new residential project to be built in Kalaeloa broke ground since the establishment of the KCDD, and it will be located next to the new Daniel Kahikina Akaka Veteran Affairs Clinic. The construction of the \$120 million VA Clinic is on schedule and is expected to be open in 2024. It will provide specialized health care for 87,000 Hawaii veterans. Much more infrastructure improvements are needed to spur community development in Kalaeloa.

West O'ahu's growing population of almost 200,000 includes the Waianae Coast, Ewa, and Waipahu and Kalaeloa. **Decades ago, the City and County of Honolulu adopted a goal of creating a "Second City" and moving residential and economic growth toward West O'ahu**. The State adopted a similar long-standing policy to redirect growth away from Honolulu and toward Kapolei. To match this dynamic growth the emergence of new job centers in West O'ahu is essential to keep pace with the population growth. In order for planned growth to occur, critical infrastructure is needed surrounding the planned Transit Oriented Development areas in East Kapolei as well as planned development in Kalaeloa.

The planned development in HCDA's 3,700-acre Kalaeloa Master Plan will play a key role in providing these job centers in Kalaeloa. Upgrades to aged infrastructure including bringing electricity down Saratoga Avenue is essential for the development of these job centers and economic development in Kalaeloa.
