Title of Bill:SB 0124 RELATING TO PROHIBITION OF FIREARMS ON<br/>SCHOOL PROPERTY.

**Purpose of Bill:** Prohibits the possession of firearms on school property and school buses and at school-sponsored functions. Exempts certain law enforcement officers and instructors and participants of certain educational or training programs. Establishes that violators are guilty of a class B felony. Requires children enrolled in school who are in violation to be excluded from school attendance for not less than one year. Defines school, school bus, school property, and school-sponsored function.

#### **Department's Position:**

The Hawaii State Department of Education (Department) supports SB 0124.

The Department is committed to providing and/or enhancing a safe and secure learning environment for all students. Allowing firearms on school property would run counter to that commitment.

Hawaii currently has no specific state statute to address firearms on school property. To deter or prosecute a person for carrying a firearm on school property, state officials mainly rely on federal laws, specifically the Gun-Free School Zones Act (GFSZA) of 1990. This act prohibits an individual from knowingly possessing a firearm in, on the grounds of, or within 1,000 feet of a public, parochial, or private school that provides elementary or secondary education. However, it does have drawbacks and exceptions. The GFSZA was passed several decades ago; therefore, it does not apply to all persons licensed by a state to possess or conceal-carry a firearm on school property. SB 124 would strengthen Hawaii's overall stance on firearms because it is framed in a more stringent manner than GFSZA and does not allow for any conceal-carry type of exception.

Aloha e Chair Wakai, Chair Kidani, and members of the Committees:

We are writing in strong support of SB 124, Relating to Prohibition of Firearms on School Property.

This bill will prohibit the possession of firearms on school property and school buses and at schoolsponsored functions; exempt certain law enforcement officers and instructors and participants of certain educational or training programs; establish that violators are guilty of a class B felony; require children enrolled in school who are in violation to be excluded from school attendance for not less than one year; and define school, school bus, school property, and school-sponsored function.

Every single day, more than 110 people in the United States are killed with guns and more than 200 are shot and wounded (Everytown for Gun Safety). And in 2021, the most recent year with full data released, gun deaths reached their highest level in at least 40 years, with 48,830 deaths in that year alone (Giffords Law Center). As you read this testimony, in this very moment, people are dying. Children are dying.

Schools are places of fun, learning, and friendship. Students should not have to go to school in fear that they might not make it home. Parents should not have to worry about their children in a place of education. Kids being murdered in classrooms should not be the norm.

Gun violence has become its own epidemic. But like disease, this sickness can be treated. With strict gun laws and strong enforcement, we can protect our community from senseless gun violence and deaths. We need to take action, and we need to do it now. **Please, help us save lives.** 

Students Demand Action (SDA) is a national organization of high school and college-aged activists committed to ending gun violence. When lawmakers offered thoughts and prayers but little meaningful action after the 2018 mass shooting at Marjory Stoneman Douglas High School in Parkland, Florida, students across the country came together to make our voices heard. SDA

#### Comments:

1) Does this extend to pick up areas for parents who may be legally armed to pick up their children from school? Does this extend to times when the school is not actively being used for student education such as during Orchid Shows, theater performances, or during emergencies when some schools are used as emergency shelters?

2) Does this ban extend to school buses not actively engaged in the transport of children? Does it apply if such buses are being repurposed for use in emergencies such as for evacuation?

I would also like to ask what would happen if a student is known to be carrying a firearm but the administration does nothing about it? This is in reference to an incident I am aware of that took place on a High School campus (As much as I would like to, I will not disclose the School in question to protect those who fear retaliation by Administration and the Student in question).

In this incident, a student stepped forward to staff and said they were robbed at gunpoint by another student of illegal drugs and money. They said several other students were also robbed but refused to come forward due to the illegal nature of what they were robbed of. This student was confronted by security, but managed to escape and flee off campus before a search could be done.

When the student returned, noticeably without his belongings, he was searched and nothing was found, no guns, no drugs, no money. Some other students came forward and admitted they were robbed by the student and had seen the gun. The Administration of this school however did not report the illegal drugs or the presence of a gun on campus to HPD for further investigation. All students involved have not been suspended or expelled and continue to carry the firearm and deal drugs respectively. The student in question has even bragged to others about what he got away with.

If DOE is really concerned with firearms on campuses, why is such an incident allowed to be just swept under the rug? I remember a time when a student would have been suspended with the threat of expulsion for bringing a non-realistic toy gun to school or even talking about having one. To our elected leaders and representatives,

Appreciate the opportunity to share a word of testimony regarding this bill.

I understand the *intent* of this bill is to make schools a safe place for our kids. It is what all of us want.

It goes without saying that students, anyone under 18 yrs of age cannot lawfully possess firearms and should not possess them on school property. That is already written in our laws.

One major concern I have is that if you make schools a gun free zone for adults namely parents, teachers and faculty, you will have the *opposite* affect on creating a safe environment for the kids and rob us parents who are lawfully permitted adults from the ability to protect our kids.

I adamantly oppose having any public place labeled a *gun free zone* because it will only make that place a target for those individuals who what to harm others and prey on the most vulnerable people in our community. I oppose making any public place including parks, malls, public squares, streets, etc a gun free zone, because criminals (potential active shooters) will target those very places. They care nothing about rules or laws. You only invite tragic things like that to happen. Look at the recent shooting in Times Square, a so called gun free zone a story which was just featured in the New York Times. It was critical of the ability of labeling a place a gun freen zone from stopping mass shootings from happening.

The other problem with making this a law is that according NYSRPA v Bruen, it is the burden of the state/county government to justify this bill by finding a historical analogue of a similiar law that was established in 1791 or the founding era of the Constitution up until the ratification of the 14th Amendment in order to pass the constitutionality test. If no such analogue exists, then you cannot create such a law. It will be automatically disqualified and will ultimately be struck down in a court of law. Remeber your oath of office as a public servant that you promised to protect and defend the Constitution of Hawaii and the Constitution of the United States. The Second Amendment is a key part of our Constitution, it is the one God given freedom that protects all other freedoms that we have.

It's great to have law enforcement exempt from being prohibited in the schools but in an active shooter situtaion the best solution would be to have an adult be it an administrator, teacher or

other faculty member who has a firearm to provide immediate protection for the kids. The reason is because the police will not be there in time to stop the threat because it will be over in minutes. With the average wait time for police to show up being 7 min or more, Many lives will be lost before they even get there. That is sad to say, what the current realty is. In fact, there was a recent shooting in Waikiki, the police took more than 15 min to show up. Way to late to make a difference.

I would encourage you to look at what they do in other states who have very strong pro Second Amendment gun laws who have implemented the use of firearms as a part of their school safety program. Places like Florida and Indiana. What they do is have armed school security, and allow their administrators and faculty to be armed if they want to be. These individuals should be provided with proper safety and skills development training to be able to handle themselves in such situations.

In addition they have implemented training to equip teachers and students with the knowlege of what to do in an active shooter situation. They also run drills to show them exactly what to do and where to go. They also put money toward "hardening" soft targets, creating a *safe corner* in each classroom usually behind a impenetrable steel door that can be locked an barricaded from the inside which is out of range of a shooter from outside the classroom where everyone in the class can huddle behind in an active shooter situation to make it much harder for a shooter to cause harm.

The more challenging thing is to make the school inaccessible from the outside for anyone to get on the campus or into the buildings. The reommendation is a single point of entry where an armed guard is placed so the threat can be neutralized before they pose a real danger to the students. Another solution whould to be have armed security making regular rounds around the campus to act as a deterent for anyone wanting to target the school. This definitely is a problem cause most schools are very open and accessible from outsiders to easily walk on campus.

If you want a real solution to prevent a shooter from even trying to attack a school, you are gonna have to allocate some resources to hardening that school to keep any threat from happening.

You may feel like students might *feel* funny seeing armed security on campus walking around but they do that in other countries like Israel who have had to resort to such tactics cause the threat of violence towards schools is real and imminent. It many only seem scary because we are not used to seeing it everyday. Once such a program is implemented, it will become normalized and that uneasy feeling will subside.

i used to feel a bit intimidated with handling guns but as I have participated in training and my knowlege of how to safely handle a firearm has increased, that intimidation and fear has subsided. They are no scarier than handling a kitchen knife or any other tool that could be used as a deadly weapon. It is all about becomeing comfortable through familiarity and repetition. If you personally are intimidated or have feelings of uneasiness, those feelings will go away with proper training and reps. Take a gun safety class and learn how to properly use firearms. You

only fear what you do not fully understand or have fully experienced. Or you can choose to live in ignorance and fear. Its up to you.

Like it or not, the right for lawful individuals to carry in public is not going away, in fact with NYSRPA V Bruen, it will only increase. It is the new normal. But I believe the more lawful people we have carrying in public, the more safe our streets and communities will be from evil people with criminal intent.

The lawful gun owner is not to feared, the criminal who has malicious intent is the one who should be feared above all. Lawful gun owners, understand that with the right to bear arms comes a huge responsibility to be properly trained and equipped to handle themselves in any public shooting scenario. We are honestly the best first responders out there cause when something goes down, we will be the *only* ones on scene equipped to respond rapidly to stop the threat.

The lawful gun owner should not be seen as a liability to soceity but an asset who is ready and able to act appropriately to protect against such threats. They will act appropriately and reasonably in these situations as long as they are trained properly to do so.

Students in grades K-12 are not of legal age to carry a firearm, so this law would only apply to adults.

People trusted by the state to carry concealed are the same people whether on or off school campuses. If the firearm is concealed, no one should have any reason for concern.

A law does not prevent those with criminal intent from bringing guns onto school property. But, if that should happen, the right to bear arms should be afforded so there exists a chance someone is able to meet force with force and prevent mass casualties.

This is particularly important in schools with few to no armed security on campus. Law Enforcement can never arrive in time to prevent mass casualties unless they are already on campus when the shooting starts.

I am Joseph A. Trinidad, Major of the Records and Identification Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports Senate Bill No. 124, Relating to Prohibition of Firearms on School Property.

This bill proposes to prohibit firearms on school property, school buses, and at school-sponsored events. Certain law enforcement and instructors are exempt from this prohibition. Currently, the Supreme Court rulings in District of Columbia v. Heller (2008) and New York State Rifle & Pistol Association Inc. v. Bruen (2022) allow states to designate schools as a sensitive place.

Aligned with school vulnerability assessments, threat response training, and active shooter drills, this bill directly supports keeping our schools and surrounding communities safe.
