Aloha,

Thank you for the opportunity to submit testimony on SB 130. Although I am sympathetic to the concerns that that I believe gave rise to this bill, the current law addresses those concerns, and an amendment is not consistent with the purposes of the UCCJEA.

The existing exception in the UCCJEA permits a state to refuse to enforce a foreign custody decree if the child custody law of the foreign nation violates human rights. That exception seems to cover the concerns raised in the proposed amendment.

This amendment is not tethered to child custody law and as a result may have unintended negative consequences. If we enact it, there is a risk that other nations might refuse to recognize decrees from American states because of religious or cultural differences.

As a uniform law commissioner, I see the benefits of continuity of statutes between the states. Amendments of uniform laws on a state-by-state basis does not promote uniformity of the law.

For these reasons, I ask the Committee to defer this bill.
