Statement of **SCOTT GLENN, Director**

in consideration of SB 140 RELATING TO THE HOUSING SHORTAGE.

Chairs Inouye and Chang, Vice Chairs Elefante and Kanuha, and Members of the Senate Committees on Water and Land and Housing:

The Office of Planning and Sustainable Development (OPSD) offers the following **comments** on SB 140, which amends §225M-2(b), Hawaii Revised Statutes, to give OPSD additional responsibilities related to housing. SB 140 would require OPSD to identify and analyze existing and projected housing needs and identify the quantity of adequate sites for housing, including rental housing, factory-built housing, and emergency shelters, sufficient to meet housing demand for all income levels each year. OPSD believes that data on existing and projected housing needs is already available from other State agencies.

In addition, data from OPSD's State Land Use Review of Districts (January 2022) indicates that there may be sufficient land in the State Urban District for housing. For example, the Review revealed that in 2020, there were 204,187 acres in Urban District statewide and that 68,650 acres of these developable lands were vacant. The Review found that the amount of vacant land may be attributable to a variety of economic and regulatory factors, including infrastructure needs, the overall length and timeframe for development approvals, market considerations, and developers' ability to raise capital. OPSD understands the need to produce housing, but there may be other ways to address these needs, such as investing in infrastructure.

Additionally, OPSD notes that it may not have the staff and other resources necessary to conduct the research required by SB 140.

Aloha Chair Chang, Chair Inouye and Members of the Joint Committees:

My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS[®] ("HAR"), the voice of real estate in Hawai'i and its over 11,000 members. HAR **supports** Senate Bill 140 which requires the Office of Planning and Sustainable Development to identify and analyze existing and projected housing needs and identify adequate sites for housing sufficient to meet housing demands for all income levels each year.

According to the Department of Business Economic Development and Tourism's 2019 report on Housing Demand in Hawai'i, the state needs up to 45,497, housing units to meet demand in Hawai'i by 2030.¹ Ultimately, we have a housing supply problem, and we need creative solutions to build more housing at all price points. As such, having the Office of Planning and Sustainable Development identify and analyze projected housing needs and adequate sites for a variety of housing types and income levels can help with our State's housing challenges now and into the future.

For the foregoing reasons, Hawai'i REALTORS[®] supports this measure. Mahalo for the opportunity to testify.
