SB 164 SD2 – RELATING TO LOAN REPAYMENT FOR HEALTH CARE PROFESSIONALS

Chair Belatti, Vice Chair Takenouchi, and Members of the Committee:

Thank you for the opportunity to present testimony today. The John A. Burns School of Medicine (JABSOM) **strongly supports SB 164, SD2** which seeks funding for the Hawai'i State Loan Repayment Program administered by JABSOM in the amount of \$1,000,000 for fiscal years 2023-2024 and 2024-2025. We request that the measure take effect on July 1, 2023.

Since September 2012, the Hawai'i State Loan Repayment program has been operating successfully, and has supported 76 recipients in exchange for work commitments in underserved geographic practice areas in Hawai'i. Of the loan repayment participants, 80% have remained in Hawai'i to practice, and more than half have remained at the site where they performed their service. As of this date, there are 23 active providers in the Hawai'i State Loan Repayment program with another 9 providers applying for JABSOM'S Innovative Loan Repayment Program, which is also administered by JABSOM and uses non-federal monies to match State funds to support other local healthcare providers who do not meet the federal guidelines but who still work in an area of need.

The Hawai'i State Loan Repayment program leverages public funds and private donations to access matching federal funds through the State Loan Repayment Program of the National Health Service Corps Branch of the United States Department of Health and Human Services. Currently, health care professionals who have benefited from the loan repayment program serve on all islands and in the communities of Waimea, Kīhei, Wai'anae, Hilo, and Wailuku; at health clinics in Kalihi-Pālama and

Kōkua Kalihi Valley; and in public institutional settings at the federal detention center in Honolulu, the Hālawa correctional facility and the Maui County correctional center. Health care professionals who are eligible to participate in the program include physicians, nurse practitioners, psychologists, social workers, and many others.

Many Hawai'i residents are unable to obtain timely and appropriate health care due to shortages of primary and behavioral health care professionals in the State. These shortages not only threaten individual health, but also cumulatively affect the State's health care costs. Areas of Hawai'i that have been designated by the federal government as medically underserved have been most significantly affected by shortages of primary and behavioral health care professionals, such as physicians, nurse practitioners, physician assistants, and psychologists. Social workers, marriage and family therapists, and nurses are also urgently needed in these areas.

In many cases, the increasingly high cost of education for health care professionals binds graduates to a career path designed to repay often exorbitant student loans. These career paths most frequently lead to professional practice in highly specialized practice in urban areas rather than in general practice on the neighbor islands or in underserved areas of O'ahu where the need is greatest. Furthermore, those states with robust primary health care systems have lower costs and improved patient outcomes. Recognizing this correlation, many states have made the policy decision to dedicate public funds to loan repayment programs to help develop a strong primary health care workforce for underserved areas.

An investment of State matching funds would enable JABSOM to draw as much federal money as possible and allow the program to provide loan repayment to more health care professionals in our ongoing efforts to alleviate the health care professional shortages in Hawai'i.

We request a minor, non-substantive amendment to page 2, line 12 by the insertion of the word "Branch" to reflect the correct name of the federal program that underwrites the Hawai'i State Loan Repayment Program:

"National Health Service Corps <u>Branch</u> State Loan Repayment Program of the United States Department of Health and Human Services".

Chair Belatti, Vice Chair Takenouchi, and committee members, thank you for this opportunity to provide testimony on SB 164, SD2, which appropriates funds to the Department of Health for the Hawaii State Loan Repayment Program for Health Care Professionals, provided that the funds are matched on a dollar-for-dollar basis by funds from a private or another public source.

Kaiser Permanente Hawai'i SUPPORTS SB 164, SD2.

Kaiser Permanente Hawai'i is one of the nation's largest not-for-profit health plans, serving 12.6 million members nationwide, and more than 269,000 members in Hawai'i. In Hawai'i, more than 4,200 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and advance practice providers work in our integrated health system to provide our members coordinated care and coverage. Kaiser Permanente Hawai'i has more than 20+ medical facilities, including our award-winning Moanalua Medical Center. We continue to provide high-quality coordinated care for our members and deliver on our commitment to improve the health of our members and the 1.4 million people living in the communities we serve.

Our rural areas continue to be the most underserved populations in Hawaii. Therefore, we appreciate inclusion of areas served by rural health clinics as part of underserved geographic areas. Hawai'i has a shortage of about 776 doctors, and almost all other types of primary care and behavioral healthcare workers. In 2022, approximately 60 physicians were found to have retired, 212 decreased their work hours, and 84 physicians left the state, further contributing to the physician shortage. Without these doctors and other healthcare providers, the people of Hawai'i do not have access to the healthcare they need. The shortage is most acute for those on neighbor islands and underserved areas served by rural health centers. The funding from this loan repayment program, will create opportunities directly in the state to recruit and retain our physician and healthcare workforce.

We ask the committee to PASS SB 164, SD2. Mahalo for the opportunity to testify on this important measure.

Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

HPH writes in SUPPORT of SB 164, SD2 which appropriates funds for the Hawaii State Loan Repayment program administered by the John A. Burns School of Medicine (JABSOM).

The continuation of the Hawaii State Loan Repayment program that supports payments of educational debt for primary care and behavioral health physicians, nurse practitioners, physician assistants, psychologists, social workers, licensed professional counselors, marriage and family therapists and certified nurse midwives who work for non-profit organizations in Health Professions Shortage Areas of Hawaii plays a vital role in addressing the shortage of healthcare professionals in the state. Hawaii has a shortage of almost 800 doctors, and almost all other types of primary care and behavioral healthcare workers. Without these healthcare providers, the people of Hawaii do not have access to the healthcare they need. The shortage is most acute for those on the neighbor islands and those with the least resources. One of the fastest and least expensive methods for recruiting providers is through loan repayment.

JABSOM has successfully administered the program which has supported 76 healthcare providers since the program began in 2012. To date, nearly 2/3 of those providers continue to work in medically underserved communities.

Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality health care for all. We believe that health is about supporting whole-person care.

According to the 2022 Hawai`i Physician Workforce Assessment, Hawai`i has a shortage of almost 800 doctors. Workforce shortages are also seen across the spectrum of healthcare workers. This shortage means that in certain areas, residents are unable to obtain timely and appropriate health care.

AlohaCare is committed to improving access to care, which is why in 2012, AlohaCare and others provided funding for the state loan repayment program created by JABSOM Area Health Education Center. The program has successfully brought more healthcare workers to underserved areas across the state. And an overwhelming majority of the loan repayment recipients continue to practice in our community health centers and are vital to ensuring access to quality healthcare to underserved areas.

We support this measure as a critical and effective way to expand provider capacity and improve access to care for the residents of Hawai`i, especially our rural communities.

Chair Belatti, Vice Chair Takenouchi, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 0164, Senate Draft 2, RELATING TO LOAN REPAYMENT FOR HEALTH CARE PROFESSIONALS.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would appropriate unspecified amounts of general funds for fiscal years 2023-2024, and 2024-2025, for the Hawaii State Loan Repayment Program so long as these funds are matched on a dollar-for-dollar basis by funds from a private or another public source. The funds would be expended by the John A. Burns School Medicine of the University of Hawaii at Manoa, and would take effect on July 1, 2023.

The bill would take effect on December 31, 2050, for discussion purposes.

The State of Hawaii is experiencing a severe shortage of health care professionals in the workforce, especially in rural areas. Recent studies note that the current shortage of physicians is at 20% of the total full-time equivalent positions throughout the State. The shortage is especially severe in the fields of primary care, infectious diseases, colorectal surgery, pathology, general surgery, pulmonology, neurology, neurosurgery, orthopedic surgery, family medicine, cardiothoracic surgery, rheumatology, cardiology, hematology/oncology, and pediatric subspecialties of endocrinology, cardiology, hematology/oncology, and gastroenterology.

This bill would provide the resources to continue a financial incentive that enhances the quality and stock of Hawaii's future healthcare workforce. Accordingly we commend this effort and wish to participate in any and all discussions concerning workforce development.

Currently, Hawaii has a statewide physician shortage of 776 Full Time Equivalents (FTEs), as reported in the UH System Annual Report on Findings from the Hawai'i Physician Workforce Assessment Project. This deficit is 44 FTEs larger than one year ago. Since 2012, support from the Hawaii State Legislature in partnership with JABSOM, HMSA and Queens Medical Center through the State Loan Repayment Program has helped to recruit physicians to practice in Hawaii. HMA is grateful for the continued support of this financial assistance program, particularly for needed recruitment to counties like Hawaii and Maui, where provider shortages are as high as 40%. HMA also supports the expansion of this program to include incentives for psychologists and social workers.

It remains an important priority for Hawaii physicians to sustain quality healthcare in Hawaii and maintain the delivery of vital services to our underserved areas, particularly on the neighbor islands. The Loan Repayment Program must be sustained to support young physician trainees and improve our Hawaii physician workforce that remains critically low.

Thank you for allowing the Hawaii Medical Association to testify in support of this measure.

Hawaii Substance Abuse Coalition supports SB164 SD2

ALOHA CHAIR, VICE CHAIR AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery services.

There is a huge shortage of behavioral health workers, including psychiatrist, psychologists, nurses, and social workers. So much news about it, we hardly need to justify it. However, here is a report from HRSA:

By 2030, we project these changes in demand for behavioral health workers:¹

3% increase in demand for adult psychiatrists (to 39,550)
1% decrease in demand for child & adolescent psychiatrists (to 9,190)
15% increase in demand for nurse practitioners (to 12,050)
8% increase in demand for physician assistants (to 1,670)
5% increase in demand for psychologists (to 95,600)
12% increase in demand for social workers (to 268,750)
9% increase in demand for marriage & family therapists (to 57,970)
15% increase in demand for mental health counselors (to 158,850)
3% increase in demand for school counselors (to 119,140)

This loan matching program would certainly help.

Aloha Chair Au Belatti, Vice Chair Takenouchi, and members of the committee,

Thank you for allowing Hawaii Dental Service (HDS) to submit testimony **SUPPORTING WITH COMMENTS SB164 SD2** – RELATING TO LOAN REPAYMENT FOR HEALTH CARE PROFESSIONALS. HDS is Hawaii's leading dental benefits provider, offering affordable, comprehensive dental plans to more than 1 million residents in Hawaii, Guam and Saipan.

SB164 SD2 appropriates state funds to the loan repayment program for health care professionals and requires matching funds from a private donor or another public source. HDS supports SB164 SD2 to encourage graduates in healthcare professions to commit to careers in underserved geographic practice areas in Hawaii. HDS strongly encourages the committee to amend the bill to extend this benefit to Hawaii dentists and dental hygienists who practice in underserved communities and where there is a shortage of healthcare professionals.

There is a growing realization that oral health is just as important to our overall health and wellbeing as primary and behavioral health. Studies consistently document the connection between oral health and chronic health conditions such as cardiovascular disease, diabetes, and dementia.

Hawaii should recognize oral health care as a medical specialty. Current practices deprive dentists and dental hygienists of being rightfully recognized as healthcare colleagues of equal status to primary and behavioral healthcare professionals, including physicians, nurse practitioners, physician assistants, psychologists, social workers, marriage and family therapists, and registered nurses.

Currently, Hawaii dentists and dental hygienists are excluded from the Hawaii State Loan Repayment Program. This program is only available to other healthcare professionals. HDS strongly believes health equity in our state will be greatly enhanced if funds appropriated to the Hawaii Department of Health for the Hawaii State Loan Repayment Program and administered through the UH John A. Burns School of Medicine could also be extended to dentists and dental hygienists.



HDS proposes amending Section 1 as follows:

SECTION 1. The legislature finds that many Hawaii residents are unable to obtain timely and appropriate health care due to shortages of primary and behavioral health care professionals in the State. These shortages not only threaten individual health, but the entire State's health care system. Areas of Hawaii that have been designated by the federal government as medically underserved have been most significantly affected by shortages of primary and behavioral health care professionals, including physicians, nurse practitioners, physician assistants, <u>dentists, dental hygienists</u>, and psychologists. Social workers, marriage and family therapists, and registered nurses are also urgently needed in these areas.

We strongly urge the committee to **pass SB164 SD2** with the amendments proposed. Mahalo for your consideration.

Currently, Hawaii has a statewide physician shortage of 776 Full Time Equivalents (FTEs), as reported in the UH System Annual Report on Findings from the Hawai'i Physician Workforce Assessment Project. This deficit is 44 FTEs larger than one year ago. Since 2012, support from the Hawaii State Legislature in partnership with JABSOM, HMSA and Queens Medical Center through the State Loan Repayment Program has helped to recruit physicians to practice in Hawaii. HMA is grateful for the continued support of this financial assistance program, particularly for needed recruitment to counties like Hawaii and Maui, where provider shortages are as high as 40%. HMA also supports the expansion of this program to include incentives for psychologists and social workers.

It remains an important priority for Hawaii physicians to sustain quality healthcare in Hawaii and maintain the delivery of vital services to our underserved areas, particularly on the neighbor islands. The Loan Repayment Program must be sustained to support young physician trainees and improve our Hawaii physician workforce that remains critically low.

Queen's appreciates the opportunity to provide testimony in support of SB164 SD2, which appropriates funds for the Hawaii state loan repayment program administered through the John A. The Hawai'i Friends of Civil Rights works to achieve equity, justice, inclusion, uphold civil rights, and eliminate discrimination. We are in STRONG SUPPORT OF S.B.1, S.D.2

Section 1 – Purpose Clause

The Section 1 purpose clause provides clear guidance to courts and policymakers of Hawai'i's strong commitment to protecting individual privacy in deeply personal choices related to reproductive health care decisions. It leads to the inescapable conclusion that the right to abortion is rooted in Hawai'i's constitution, legislative history, and social policies. And it swiftly rejects the reach of <u>Dobbs v. Jackson Women's Health Organization</u>, 142 S.Ct. 2228 (2022) to lawful abortions performed within Hawai'i.

Part I, Section 2 – Advanced Practice Registered Nurses

Section 2 allows advanced practice registered nurses to provide medication or abortion care in the first trimester of pregnancy and eliminates the requirement that these services must be performed in a hospital, clinic, or registered office of the advanced practice registered nurse. The elimination of these restrictions will hopefully expand the availability of reproductive health professionals to rural areas of Hawai'i including Kaua'i, Hawai'i Island, and Lana'i.

Part II and Part III.

Part II provides clear protection for reproductive health care providers against foreign subpoenas, demands to surrender, and summons in matters relating to reproductive health care services which are legal in Hawai'i. It also prohibits state agencies from providing any information or expending resources to assist a foreign state seeking to impose civil or criminal liability upon a person or entity who assists, provides, pays for, or responds to an inquiry about reproductive health care services that are legal in Hawai'i.

Part III protects reproductive health care providers who provide medical, surgical, pharmaceutical, counseling, or referral services from licensure sanctions where the services provided are in accordance with Hawai'i law or would have been in accordance with Hawai'i laws if the actions occurred in Hawai'i.

Collectively, these provisions shield agencies, corporations, non-profits, and individuals by creating a hard border for foreign actors attempting to enforce their reproductive health care laws, judgments, and licensure actions in Hawai'i.

Part IV.

Part IV protects Hawai'i's reproductive healthcare providers against enforcement of foreign judgments for providing abortion-related services consistent with Hawai'i law. As such, it protects providers from liens and asset seizures on real or personal property found or located in Hawai'i.

We urge the passage of S.B.1, S.D.2. It is critical to do all we can to ensure that all persons' reproductive rights – including the right to abortion care – are strengthened to be at least as strong as they were under *Roe v Wade*, and to guarantee that our medical providers can deliver care safely and without fear of overreach from other states.
