TESTIMONY BEFORE THE SENATE COMMITTEE ON EDUCATION

Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association **supports SB 283**, relating to public charter school per-pupil funding. The bill excludes from the charter school per-pupil funding calculation all amounts relating to programs that provide comparable benefits for all public school students regardless of whether the student is a Department of Education school student or a public charter school student.

Adequate funding is a long-standing issue for our public charter schools. Today, amounts received by charter schools fail to keep pace with the cost of providing and quality instruction. Charter schools were expected to receive \$8,745 per-pupil this school year, according to the Charter School Commission quoted in a Civil Beat article in August, most of which is disbursed toward operational expenses, often leaving charters to rely on private donations to fund extra costs including facilities and rent. Charter schools' per-pupil operating funds cover items like salaries, collective bargaining costs, curricula, school supplies, equipment, and utilities. Poorly funded charter schools are sometimes forced to hold classes in unstable temporary structures to the detriment of their students' learning and safety.

This bill will help the committee on weights, when calculating the per-pupil amount for our public charter schools, by asking them not to include amounts relating to programs that provide comparable benefits to students in both the DOE and in public charter schools. This will help our public charter schools with their funding issues.

To provide charter schools with the funds they need to succeed, the Hawaii State Teachers Association asks your committee to **<u>support</u>** this bill.

Dear Honorable Members of the Senate Committee,

My name is Apollo Rygh and I am a student at Connections Public Charter School. If approved, SB283 could drastically impact our funding in a negative way; it could mean fewer teachers and less support for teachers and students. Our school is currently operating on a tight budget and further negative adjustments to per-pupil funding will definitely affect our school.

Connections and other charter schools provide a unique alternative to DOE schools, and a small-school environment for families seeking a personalized and differentiated education for their children.

We are seeking an opportunity to engage in conversations with you and other key legislators to design a new funding formula for charter schools that provides equal access to high quality education for students like me and my peers. SB283 should be amended, with clearer wording and less ambiguity.

Inequality has persisted in what students in our schools receive from state funding and what students in DOE schools receive. The systematic inequality involves numerous line items in the funding formally being allotted to DOE schools, but not charter schools. There is no reasonable justification for this sustained disparity.

While the original law that initiated charter schools in Hawai'i was negotiated with the acknowledgement that charter schools would need to establish their own facilities, the inequities that persist relate to line items that have no relationship to facilities being established.

Students like me who attend public charter schools deserve equal funding, as well as funding for our programs and resources; programs and resources that are available to DOE students.

I hope you consider students enrolled in charter schools and the quality of our education when making your decision on Friday.

Thank you for allowing me to write my testimony in opposition to SB283. My name is Piper Selden, and I am an English teacher at Connections Public Charter School. I teach at the very same school that both of my children attended, both having graduated with honors.

This bill is important to me because there is a real need for public charter schools, and those schools should be fully funded, not kneecapped, which is what SB283 would do to their funding. Please let me tell you a bit about myself, and how I came to be a teacher at a public charter school.

My son should have attended Waiakeawaena Elementary, but they were UNABLE to offer him an inclusive setting for special education. My son is autistic but high functioning. Initially, the team at Waiakeawaena told me that a school counselor had evaluated him and found nothing "wrong" with him. I was told that because he wasn't "retarded" (yes, they used that word) that he didn't need services. This shocked me, having moved from the State of Oregon with a full folder of his medical records showing otherwise. I was told that if he was, in fact, autistic (doubting me), that he would need to be in a fully self-contained classroom. It was that or nothing. So, we chose Connections Public Charter School, where my son was able to have an aide and be in a classroom with his typical peers.

Years later, my daughter was diagnosed with cancer. We had to leave the islands for her treatment. The oncologists at Kapiolani on Oahu couldn't even treat her. We spent a year and ten days away from home at Seattle Children's Hospital. And when we returned to Hawaii, my daughter wanted to join her friend at what they called a "real school." She enrolled at Keaau High School, but that school could not accommodate her medical appointments every three months back to the mainland. So, guess what? We enrolled her back to Connections. We did so because the charter school was willing to work with us so that she could stay in school and do school work when she was on the mainland for treatment. Keaau was unwilling to do that for her.

Here's the deal: Not every child is a cookie cutter typical kid. My son wasn't. He needed a place to thrive, a place that could meet needs that he couldn't get at school in our geographic location. My daughter wasn't a cookie cutter kid either. Some students have unique needs that just are not met at a regular DOE school. And this need for public charter schools that CAN meet those needs is important. It's why I went back to school and earned two master's degrees and a teaching certificate... so that I could contribute to a community of educators dedicated to teaching at-risk youth and those who don't fit the regular model.

I have taught at a DOE school (Waiakea High School), and I've taught at UH Manoa, UH Hilo, and Hawaii Community College. But Connections is my heart-home school because they were able to take care of my children when they were in need. They were able to make accommodations for my children when the DOE schools were either unwilling or unable to do so. And so, I give back to this educational community that made my own children's education a priority. I'm paying it forward for other people's children.

Please don't gut an important educational option for Hawaii's youth. Students in my class are, in fact, at risk. Many come from difficult family situations, and this place is their safe space to learn and become contributing members of society.

One size does not fit all. It is important for you to know this. There are more at-risk students in the State of Hawaii than maybe you know there are, and they need an option like public charter schools to not only learn and grow, but to thrive.

I ask you to oppose SB283 for myself and all of the wonderful, unique keiki in Hawaii. My own and those I teach. Thank you for your time and consideration.

If approved, SB283 could drastically impact our funding in a negative way; it could mean fewer teachers and less support for teachers and students. Our school is currently operating on a tight budget and further negative adjustments to per-pupil funding will definitely affect our school.

Connections and other charter schools provide a unique alternative to DOE schools, and a small-school environment for families seeking a personalized and differentiated education for their children.

My name is Dr. Kēhaulani 'Aipia-Peters, and I am the Governing Board Chair of Ke Kula 'O Nāwahīokalani'ōpu'u Iki, Laboratory Public Charter School. I am providing comments on **SB 283**.

We, the governing board of Nāwahī, are providing comments to SB 283 that "excludes from the charter school per-pupil funding calculation all amounts relating to programs that provide comparable benefits for all public school students regardless of whether the student is a Department of Education school student or a public charter school student".

We have been informed that this bill aims to fix an accounting issue regarding funds that are currently being dispersed to charter schools. Our concern with this bill is the possibility that charter schools and their funding will be negatively impacted. With a per pupil budget that is already strained by providing the necessary funding to maintain a charter school, any decrease in funding will only hinder the progress and advancement of our program and other charter school programs.

If this bill proposes that funding for "comparable programs" be cut from per-pupil funding for charter schools, then we propose allowing charter schools the latitude to choose the option to receive funds rather than receiving the resources for programs that are considered "comparable benefits for all public school students regardless of whether the student is a department school student or a public charter school student". In our experience, currently, the **Hawai'i Department of Education CANNOT provide "comparable services" through the medium of Hawaiian language and through a Hawaiian world perspective**. Providing funding directly to charter schools will allow us to continue to use the resources in a way that will benefit our students, families, staff and communities.
