Thank you for the opportunity to **provide comments on S.B. 306** which requires the Hawaii Administrative Rules to be made available on the Office of the Lieutenant Governor's website.

In the short period that I have been in office, my staff and I have witnessed firsthand that the current system is antiquated and not user-friendly. Similar to the amendments proposed in S.B. 8 which your Committee heard earlier this week, the amendments proposed in this measure requires the full text of all Hawaii Administrative Rules be housed on our website. We fully support the addition of searchability functions and the centralization of administrative rules as these updates will make it easier for the public and community stakeholders to view and understand proposed changes that will impact their lives.

If the Legislature proceeds with these amendments, we respectfully request funding to build and maintain the new website components and one FTE position to oversee the multitude of website updates.

I serve as the President of the State of Hawaii Organization of Police Officers ("SHOPO") and write to you on behalf of our Union in strong support of SB 306. This bill seeks to provide a centralized location and greater accessibility for the public to find an agency's rules and policies used by the agency to discharge its functions.

We support the proposed amendment to amend HRS §91-2 which will require all government agencies subject to HRS §91 to have their rules and policies available at the Office of the Lieutenant Governor.
