1 **Fiscal Implications:** This measure may impact the priorities identified in the Governor's

2 Executive Budget Request for the Department of Health's (Department) appropriations and

3 personnel priorities.

4 **Department Testimony:** The Department strongly supports SB0445 SD2 to deter potential

5 violation of law and to remove any economic benefit gained by violating the law. The potential

6 to face severe financial penalties for violations is much more likely to deter persons from taking

7 actions. This will give the Department greater ability to ensure that any financial benefits of

8 such violations are eliminated. For example, if the Department is limited by the statutes to only

9 assess \$25,000 in fines for a single violation, but the violator gained a greater amount of value by

10 violating, there is an economic benefit to such violations. The last time some of these fines were

11 updated was more than twenty years ago. In the intervening years, there have been many

12 changes to the economy, most notably changes due to inflation, which weakens the financial

13 deterrence of these fines.

The Department also strongly supports the appropriation to fund one full-time equivalent (1.0 FTE) environmental health specialist within the Clean Water Branch (CWB) of the Department. The additional staffing strengthens the Department's ability to implement and enforce environmental law. Current staffing levels for CWB personnel have not increased in nearly two decades. During the same period, the universe of regulated facilities has dramatically increased as has the stress on Hawaii's water resources. The addition of an FTE to the CWB would support the program's ability to identify and reduce threats to Hawaii's surface water
 resources.

Financial deterrence is essential to ensuring that wanton violations to State environmental
law are less likely to occur and that the State is taking a strong stance against any such violators.
The additional staff in the CWB is also necessary to assist in implementing and enforcing the
penalties assessed under the applicable statute as implemented by the CWB. For these reasons,
the Department strongly supports passing this bill.

Hawai'i Reef and Ocean Coalition STRONGLY SUPPORTS SB445 SD2.

The Hawai'i Reef and Ocean Coalition (HIROC) is a group of scientists, educators, filmmakers and environmental advocates who have been working since 2017 to protect Hawaii's coral reefs and ocean.

In order to protect water quality effectively, the Department of Health (DOH) needs to have adequate civil penalties for violations and adequate staffing to enforce. Civil penalties must be large enough to prevent violators from experiencing an economic benefit by violating. The civil penalties for violations have not changed in over twenty years. During that time, inflation has weakened the deterrent value of the civil penalties substantially. Similar federal penalties have automatically increased with inflation to \$59,973. This bill would bring civil penalties in line with those federal penalties.

Current staffing levels within DOH's Clean Water Branch have not increased in nearly two decades. An additional environmental health specialist will strengthen DOH's ability to implement and enforce water pollution laws.

The Hawai'i Reef and Ocean Coalition **STRONGLY SUPPORTS** this bill to enhance enforcement against water pollution in Hawai'i.

The Environmental Caucus has an enrolled membership of more than 7,000 politically active Hawaii voters and we join with our brothers and sisters in all of the groups which strongly support this bill.

In our society people, businesses, and corporations will often ignore environmental laws and protections if they can profit by doing so. The only way to stop this behavior is to make the penalties for violations so costly that they negate any possible financial advantage to violating the laws.
