In consideration of SENATE BILL 735 RELATING TO THE DISPOSITION OF WATER RIGHTS

Senate Bill 735 proposes to exempt the instream use of water for commercial kalo cultivation conducted in a manner consistent with traditional and customary practices of Native Hawaiians from existing process for the disposition of water rights. The Department of Land and Natural Resources (Department) offers the following comments on this measure.

The Department acknowledges that the water leasing process currently in statute imposes burdensome requirements on water lease applicants, especially smaller agricultural users including taro farmers. The Department supports amending Section 171-58, Hawaii Revised Statutes (HRS), to simplify the water leasing process, including providing certain exemptions from regulatory requirements for taro farmers. However, Act 27, Session Laws of Hawaii 2022, was passed specifically to address that purpose, exempting the instream use of water for traditional and customary kalo cultivation practices from the water rights disposition process. The Act received broad support, including from numerous kalo farmers, as an appropriate means to resolve these issues. Therefore, the Department questions why this measure is necessary.

Moreover, the exemption in this measure is far broader than what the Department has proposed in the past. As currently drafted, this measure would allow water used ultimately for commercial purposes to avoid any oversight by the Board of Land and Natural Resources (Board), as well as not having to provide a reservation to the Department of Hawaiian Home Lands nor collaborate with the Department to develop

Rather, the Department believes it is more appropriate to leave the statute as-is or more narrowly exempt commercial kalo cultivation conducted in a manner consistent with traditional and customary practices of Native Hawaiians from the public auction process in Section 171-58, HRS only, and obtain a lease by direct negotiation, subject to review and approval by the Board.

Since Section 171-58, HRS was only amended last year with this new provision for kalo farmers, we would urge at least another year to work with the kalo farmers to implement the existing statute, and if necessary, return to the legislature next year to propose amendments if necessary.

Aloha Chair Inouye, Chair Shimabukuro, and members of the Committees:

The Department of Hawaiian Home Lands (DHHL) submits comments on this measure that exempts the instream use of water for commercial kalo cultivation conducted in a manner consistent with traditional and customary practices of Native Hawaiians from the existing process for the disposition of water rights.

DHHL has been working with the Department of Land and Natural Resources (DLNR) for the past few years on a number of efforts where DLNR is attempting to issue water license or leases under HRS 171-58. These include hydroelectric projects on Hawaii Island and Kauai, and agricultural water on Kauai, Maui and Hawaii Island. DHHL has three significant, distinct interests in all these potential leases:

- 1. A right to have water reserved for its future use from the source;
- 2. Any traditional and customary rights its beneficiaries may have; and
- 3. 30% of the receipts derived from water licenses.

Any exemption from the existing process for the disposition of water rights would directly impact DHHL's interests. In addition, the expansion of this exemption beyond what was enacted last year in Act 27, Session Laws of Hawaii 2022 is of concern especially since the exemption proposed is for commercial kalo cultivation. The measure enacted last year followed beneficiary consultation and was consistent with the Hawaiian Homes Commission action that did not adversely harm DHHL and beneficiaries rights.
