Chair Todd and Members of the Committee:

The Department of the Attorney General (Department) provides the following comments.

The purpose of the bill is to require the Department of Transportation to establish a one-year pilot program to provide subsidies to airlines operating out of Molokai Airport. Section 1 of the bill provides that a subsidy can help the airlines offset the cost of passenger tickets while encouraging other airlines to also provide service at Molokai Airport.

In our previous testimony to the Senate Committee on Ways and Means, we have expressed two concerns with the bill in relation to article VII, section 4, of the Hawai'i Constitution, which provides:

<u>No tax shall be levied or appropriation of public money or property made,</u> <u>nor shall the public credit be used, directly or indirectly, **except for a** <u>**public purpose.**</u> No grant shall be made in violation of Section 4 of Article I of this constitution. <u>No grant of public money or property shall be</u> <u>made except pursuant to **standards provided by law**</u>. (Emphasis added.)</u>

Regarding the constitutional requirement of a public purpose, "determining what constitutes a public purpose is generally a question for the legislature to decide." *State v. Anderson*, 56 Haw. 566, 574, 545 P.2d 1175, 1180-1181 (1976). However, we recommend that the bill include a more definitive finding that the subsidies are for a public purpose. For example, the Committee may wish to consider an explicit finding

such as: "The legislature finds that alleviating costs of air travel, primarily for small communities reliant on air travel for essential services and other needs, is a public purpose; and encouraging additional airlines to provide reliable airline services to and from Molokai to assist the residents who need to travel for essential reasons is a public purpose."

Regarding the constitutional requirement of "standards provided by law," this bill does not include standards by which the Department of Transportation is to subsidize airlines that operate out of Molokai airport. To resolve this constitutional infirmity, the bill should be amended to include the standards and qualifications for making the subsidies in statute (perhaps in chapter 261, Hawaii Revised Statutes), as has been enacted for other administrative grant programs. Examples of such statutory standards and qualifications can be found in part II of chapter 9 and sections 10-17, 210D-11, and 383-128, Hawaii Revised Statutes. We have attached draft standards to this testimony as a sample.

The Department also notes that section 2 of the bill, on page 1, lines 14-17, provides that the airline subsidy pilot program will be for one year. However, the appropriation in section 3 of the bill suggests that the program is for two years. To address this inconsistency, we recommend either making the pilot program for two years at page 1, line 15, or revising the appropriation in section 3, at page 2, lines 6-12, to reflect a one-year appropriation, as follows:

SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2023-2024 [and the same sum or so much thereof as may be necessary for fiscal year 2024-2025] for the purposes of this Act, including the costs of administering the airline subsidy pilot program.

The [sums] sum appropriated shall be expended by the department of transportation for the purposes of this Act.

POSSIBLE STANDARDS FOR THE GRANTS IN THIS BILL

- (1) Any grant shall be used exclusively for the purposes of this program.
- (2) The applicant shall indicate capability to properly use the grant for the purpose of the grant program.
- (3) The applicant shall comply with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, disability, or any other characteristic protected under applicable federal or state law.
- (4) The grant shall not be used for purposes of entertainment or perquisites.
- (5) The applicant shall comply with other requirements as the department of transportation may prescribe.
- (6) All activities undertaken with funds received shall comply with all applicable federal, state, and county statutes and ordinances.
- (7) The applicant shall indemnify and save harmless the State of Hawai'i and its officers, agents, and employees from and against any and all claims arising out of or resulting from activities carried out or projects undertaken with funds provided hereunder, and procure sufficient insurance to provide this indemnification if requested to do so by the department.
- (8) The applicant shall agree to make available to the department all records the applicant may have relating to the grant, to allow state agencies to monitor the applicant's compliance with this section.

SUPPORT FOR SB784 SD1 RELATING TO AIRLINES

The Maui Chamber of Commerce **strongly supports SB784 SD1** which requires the Department of Transportation to establish and implement a one-year Airline Subsidy Pilot Program at Moloka'i Airport to assist airlines in offsetting the costs of operation.

The Chamber notes that since January 2021, only one passenger airline has provided service to the general public out of Moloka'i Airport. While the airline has done its best to accommodate the needs of passengers, including additional routes, flight times, and ordering larger planes, the cost of plane tickets remains prohibitive to many Moloka'i residents who need to travel for essential reasons, including work, medical appointments, and family. To alleviate cost burdens for passengers reliant on air travel to and from Moloka'i, implementing a one-year Airline Subsidy Pilot Program may provide incentives for airlines to service Moloka'i.

We would also note that there is no mention of the Lana'i airport in this measure. While we appreciate the effort and attention on the Moloka'i airport, we feel that the same consideration should be made for Lana'i airport since the residents of Lana'i face very similar issues getting off the island for essential services.

For these reasons we **strongly support SB784 SD1** and would appreciate consideration for adding Lana'i airport in the program.

I support this bill but respectfully ask that if at all possible, residency of Molokai be taken into consideration or travel to provide necessary services not currently available on island as a priority for flight schedules and prices.
