S.B. 823 S.D. 2 RELATING TO MOTOR VEHICLE REGISTRATION

House Committee on Transportation

The Department of Transportation (DOT) **supports** this measure that expands the existing exemptions for marine terminal equipment to be moved between terminals at Hawaii's commercial harbors.

The existing law limits the public roadways upon which the marine terminal equipment may be operated without a valid motor vehicle registration. This measure allows for operational efficiencies in loading, offloading, and otherwise moving cargo. In addition, to promote further efficiencies, DOT has designed and is constructing facilities, including the Kapalama Container Terminal, that will allow cargo to move between terminals without need to travel on state or county roads thereby alleviating congestion on these roads.

STATEMENT OF THE ILWU LOCAL 142 ON S.B. 823 -**RELATING TO MOTOR VEHICLE REGISTRATION**

The ILWU Local 142 strongly supports S.B. 823, SD2, which expands the existing exemptions for marine terminal equipment moving cargo between terminals. The bill provides an exemption for registration renewals and initial registration for flatbed trucks when used as marine terminal equipment moving within and between certain terminals.
