Aloha Chairs Chang and McKelvey:

I write to you in my capacity as the chairperson of the Board of Directors (the Board) of the Hawaii Housing Finance and Development Corporation (HHFDC) in <u>strong</u> <u>opposition</u> to S.B. 871 and urge you to hold this bill in your respective committees. This misguided measure eliminates the HHFDC Board and makes the Executive Director's position one that is appointed by the Governor instead of hired by the board.

Since its inception in 2006, HHFDC has facilitated the development of over 13,700 affordable and workforce units statewide. Our financing programs, which include Low-Income Housing Tax Credits (LIHTCs) and the Rental Housing Revolving Fund (RHRF), have produced more affordable housing in the state than any other program by encouraging public-private partnerships with qualified affordable housing developers and investors. We need to keep this momentum going.

HHFDC has established and enjoyed a reputation as being a highly regarded agency in state government that is focused on results. My own experience on the Board confirms this.

Aloha Chairs Chang and McKelvey:

I write to you in my capacity as the vice chair of the Board of Directors (the Board) of the Hawaii Housing Finance and Development Corporation (HHFDC) in <u>strong opposition</u> to S.B. 871 and urge you to hold this bill in your respective committees. This measure eliminates the HHFDC Board and makes the Executive Director's position one that is appointed by the Governor instead of hired by the Board.

Since its creation in 2006, HHFDC has established and enjoyed a reputation as being one of the best-regarded agencies in State government. My own experience on the Board confirms that this is indeed the case. The agency has demonstrated its ability to actively and responsibly manage significant sums of monies. The legislature, for several years now, has demonstrated its confidence in the board and the present structure by making historic appropriations into HHFDC's financing programs. Last year alone, the legislature infused a record \$300 million (under Act 236) into HHFDC because it believed in the work of the board and the agency to facilitate the delivery of affordable housing.

During that same year, HHFDC was able to quickly implement a provision in that Act to award about \$142 million to RHRF Tier 2 housing projects aimed at housing our gap

# income group. This is a great example of how HHFDC was able to implement a new RHRF Tier 2 program, and award the resources to real housing projects in the same year the funds were appropriated.

I also strongly believe in the need to have all the counties represented at the table when it comes to housing development and financing policies as well as decisions on housing projects within each of the nine board members community areas. We need to ensure that the interests and concerns of all counties are heard, represented and protected. Elimination of the board will stifle neighbor island representation in policy decisions that can impact resource distribution and housing production on an equitable statewide basis.

We urge you to maintain the agency's current structure and hold this bill in committee.

Chair Chang, Chair McKelvey, and Committee Members:

The League has the following comments concerning SB 871.

Because Hawaii Housing Finance and Development Corporation (HHFDC) functions include "management" and "disposition" of property, we suggest you consult the Attorney General about whether SB 871 would comply with Article XI Section 2 of the Hawaii Constitution.

The legislature shall vest in one or more executive boards or commissions powers for the management of natural resources owned or controlled by the State, and such powers of disposition thereof as may be provided by law; but land set aside for public use, other than for a reserve for conservation purposes, need not be placed under the jurisdiction of such a board or commission.

Assuming Article XI Section 2 of the Hawaii Constitution allows the Legislature to replace the HHFDC board with an appointed executive director, we recommend amending SB 871 to require that the HHFDC executive director file a public financial disclosure statement under Section 84-17, Hawaii Revised Statutes.

My name is Brian Black. I am the Executive Director of the Civil Beat Law Center for the Public Interest, a nonprofit organization whose primary mission concerns solutions that promote governmental transparency. Thank you for the opportunity to submit testimony **commenting on the financial disclosure portion of S.B. 871.** 

In 2014, the Legislature determined that the functions performed by the Hawaii Housing Finance and Development Corporation were important enough to justify publishing the financial disclosure statements of the HHFDC board members. 2014 Haw. Sess. Laws Act 230. The Legislature's conclusion in 2014 holds true today.

The proposed replacement of the HHFDC board with an executive director does not change the important nature of the functions performed. It only consolidates that power in the hands of one person. HHFDC performs a critical role that requires publication of financial disclosure statements to permit public scrutiny of conflicts.

The Law Center respectfully requests that the Legislature consider adding the newly created HHFDC executive director to the list of published financial disclosure statements required by HRS § 84-17(d).
