1 **Fiscal Implications:** This measure will impact the priorities identified in the Governor's

2 Executive Budget Request for the Department of Health's (Department) appropriations and

3 personnel priorities.

4 Department Testimony: The Department supports this measure and offers the following
5 comments on SB0964. The Department welcomes the opportunity to participate on a task force
6 with hemp industry stakeholders, and the Department of Agriculture, to gather data and
7 information to respond to a rapidly changing hemp environment.

8 The Department does not agree that hemp processors are overregulated by Chapter 9 328G, Hawaii Revised Statutes, and Chapter 11-37 Hawaii Administrative Rules. These 10 are the only regulations that allow hemp processors to legally process hemp into hemp 11 products that are compliant with contaminant testing and safe for consumer consumption. 12 Additionally, on January 26, 2023, the U.S. Food and Drug Administration (FDA) said that 13 cannabidiol (CBD) products will require a new regulatory pathway and cannot be considered dietary supplements or food additives. FDA highlights potential risks and 14 15 safety concerns around harm to the liver, interactions with certain medications, and effects 16 on the male reproductive system, as well as exposure among children and pregnant people.

- 1 While FDA works with Congress to develop a strategy, hemp processors and hemp
- 2 products will continue to be subject to the Department's regulatory authority.

### SENATE BILL NO. 964 RELATING TO THE ESTABLISHMENT OF A HEMP TASK FORCE

Chairpersons Gabbard and DeCoite and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill 964. This measure establishes a Hawaii Hemp Task Force to inform public policy and identify methods and actions to best support Hawaii agriculture and build a hemp industry to support rural economic development. The Department of Agriculture (DOA) supports this bill and offers comments.

DOA strongly supports Hawaii agriculture and the hemp industry but respectfully does not agree with the statements regarding "overregulation of farming, production," on page 1, lines 15 and 16, and that "Hawaii is the only state in the union where hemp production and farming is heavily regulated at both the state and federal levels," on page 2, lines 2 to 4. DOA does not regulate farming of hemp within the state. The USDA regulates the entire production such as growing, harvesting and other on-farm operations including licensing of Hawaii hemp growers. Monitoring transport of hemp materials (flowers, leaves, viable seeds) and buffer zone restrictions are not part of



USDA regulatory function. These are responsibilities assigned to DOA under Act 14, SLH 2020 as amended by Act 137, SLH 2020, that are necessary to ensure such nonfarming intrastate activities are conducted in a safe, healthy, and appropriate manner. The Department looks forward to working with the hemp farmers as they create a vibrant industry for Hawaii.

The establishment of a hemp industry task force has merit. The inclusion of hemp farmers and producers from each island that includes representatives from the industrial, cannabinoid and food sectors will be important to have input from the hemp industry stakeholders.

The Department looks forward to working with the task force and defers further comment to the Department of Health.

Thank you for the opportunity to submit testimony on this bill, which would establish a Hawaii Hemp Task Force. The Office of Information Practices (OIP) takes no position on the substance of this bill, but **questions the complete exemption of the Hemp Task Force from the Sunshine Law, part I of chapter 92.** 

The bill does not explain why the complete exemption of the Hemp Task Force from the Sunshine Law is necessary. The issues addressed by the group appear to be of interest to not only hemp producers and farmers but also to those interested in the local hemp industry in general, and it does not appear that the task force will be routinely working with confidential or individually identifiable information. In the absence of any justification for exempting this group from the Sunshine Law's requirements, **OIP recommends that the exemption at page 4**, **lines 6-7, be deleted from this bill.** However, if there are reasons not explained in the bill why full compliance with the Sunshine Law would be problematic for this group, **OIP would be happy to work with interested parties on a permitted**  Senate Committees on Agriculture and Environment and on Energy, Economic Development, and Tourism February 15, 2023 Page 2 of 2

### interaction or other partial exception to the Sunshine Law's usual

requirements. OIP also notes that the Sunshine Law is only part I of chapter 92, and the rest of the chapter includes provisions addressing an assortment of topics including quorum, authorized copy charges for government records, and neighborhood boards, so as a technical matter an exemption from the Sunshine Law should be an exemption from part I of chapter 92 rather than from chapter 92 as a whole.

RE: HEMP: SUGGEST AMENDING TO INCLUDE MICROGREENS AND TERPENES AS TASK FORCE MEMBER CATEGORIES AND SUPPORT (SB 964)

I am a local, disabled, diversified farmer growing on family lands, in Kula, purchased with help from a UDSA direct farm mortgage and in Waimanalo as part of a partnership on state lease land. Farming full-time since graduation of UH Mānoa with BBA. I am passionate about growing food and hemp is a superfood especially as a mircogreen.

As a licensed hemp grower under USDA, I have been told by the contact person at the USDA AMS that our farm can develop a plan with USDA to grow and sell mircogreens as other states do (without testing as the production factors don't allow for the time required to form significant cannabinoids and/or the time required to test so rather a system is designed and followed to ensure successful production.)

Offer Amend Section 2 (1) "Shall include hemp producers and farmers from each island proportionate to the total number of United States Department of Agriculture hemp licenses in the State and a representative from each of the fuel, building, general fiber, cannabinoid, ""<u>microgreen"</u> and grain food sectors;"

Could other bills clarify that micro greens can be sold in Hawai'i before this Taskforce is convened? Could a micro greens grower be added to the task force?

Also told by USDA AMS that the state doesn't control growing so the buffer zone aspects of the current law seem to violate both the USDA jurisdiction over growing and the state's Right to Farm Act so although not in this measure. Is there anything to eliminate that buffer provision of the current bill on ag lands? It would increase production and allow for more sustainable crop rotation.

The Taskforce may require odd numbers and the cannabinoid member could be complemented with a terpene member as they are often a similar market that is heavily regulated.

The state movement rules seem confusing in this area of selling the microgreens in the state so believe amending the task force to include a member as microgreens sector as well as any other relief the legislature can offer to clarify legality of instate movement and sales of hemp microgreens would be very helpful. I can provide more information and links to Universities in other states about hemp microgreens. Appreciate your help.
