MANUFACTURING EXTENSION PARTNERSHIP

HTDC celebrates its 20th anniversary as the home for Hawai'i's Manufacturing Extension Partnership (MEP) Center. MEP is a federal program under the Department of Commerce's National Institute of Standards and Technology (NIST). INNOVATE Hawai'i is the official representative of the MEP National Network in Hawai'i.

HCATT

The Hawai'i Center for Advanced Transportation Technologies (HCATT) was established in 1997 by Congress under the Defense Acquisition Research Project Agency.



HCATT continues its partnership with the Air Force Research Laboratory and National Guard Bureau in development the Pacific Energy Assurance Renewables Laboratory (PEARL); a renewable energy microgrid to maintain air and space dominance in the face of climate risks. In FY23, HCATT secured \$7.2M funding to complete the PEARL which is set to begin operations in late FY2023.

HI-CAP Invest

In FY 2023, the HI-CAP Invest program committed \$6.7 million of SSBCI funding to two venture capital funds which invest in local technology and aquaculture startups, Startup Capital Ventures and HATCH Accelerator. The State Small Business Credit Initiative (SSBCI) is a federally funded program administered by HI-CAP Invest to promote technology-based innovation and economic diversification in Hawaii.

Startup Capital Ventures (SCV) is a technology-based venture firm with offices in Menlo Park and Honolulu. Its fund invested in Hawai'i-based Shifted Energy, an EnergyTech startup which provides energy-efficient load balancing of electricity grid networks such as those for Hawaiian Electric.

HATCH is a global aquaculture venture fund with offices at the Natural Energy Laboratory of Hawai'i Authority (NELHA) in Kona, Hawai'i. The Kona-based accelerator program for aquaculture startups is helping to establish NELHA as a premier global aquaculture and ocean technology site for innovation.

Entrepreneurs Sandbox

Starting early in 2023, the Sandbox began experiencing an over abundance of requests to help host in-person events to re-connect community through showcases of innovation, workshops, coworking and various networking opportunities. This year the Sandbox was also fortunate to have hosted many special VIP guests including Congressman Case, Hirono, and SBA Administrator Isabel Guzman.
