# A BILL FOR AN ACT

RELATING TO ADMINISTRATIVE FINES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to update the
 maximum administrative fines allowed for violations of chapters
 relating to standards of conduct and lobbyists.

4 SECTION 2. Section 84-39, Hawaii Revised Statutes, is
5 amended by amending subsection (a) to read as follows:

6 "(a) Where an administrative fine has not been established
7 for a violation of this chapter, any person, including a
8 legislator or employee, who violates this chapter shall be
9 subject to an administrative fine imposed by the state ethics
10 commission that shall not exceed [\$1,000] \$5,000 for each
11 violation. All fines collected under this section shall be
12 deposited in the general fund."

13 SECTION 3. Section 97-7, Hawaii Revised Statutes, is14 amended by amending subsection (a) to read as follows:

15 "(a) Any person or entity that:

16 (1) Negligently fails to file any statement or report
17 required by this chapter;


