RELATING TO STATE PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 66, Session Laws of Hawaii 2023, is amended
2	by amending part II to read as follows:
3	"PART II
4	SECTION 2. [The legislature finds that the United States
5	Department of Energy Regional Clean Hydrogen Hubs program is
6	providing \$7,000,000,000 to establish up to ten regional clean
7	energy hubs across America. As part of a larger \$8,000,000,000
8	hydrogen hub program funded through the Infrastructure
9	Investment and Jobs Act, the Regional Clean Hydrogen Hubs
10	program will be a central driver in helping communities across
11	the country benefit from clean energy investments, good-paying
12	jobs, and improved energy security.
13	The legislature further finds that the United States
14	Department of Energy selected Hawaii as one of thirty-three
15	public-private consortiums to compete for the federal-funding.
16	Proposed as the Hawaii Pacific hydrogen hub, the department of
17	business, economic development, and tourism is leading the
18	consortium-to-leverage \$500,000,000 in private investment for

1	\$500,000,000 in matching funds from the United States Department
2	of Energy that will drive the production, processing, delivery,
3	storage, and end-use of elean hydrogen, including innovative
4	uses in the industrial sector. The State's strategic military
5	position in the Indo-Pacific and its partnerships with the
6	United States-Department of Defense make its proposal unique
7	amongst its competition. The United States Department of
8	Defense is seeking to replace petroleum-based fuels with
9	hydrogen-vehicles and platforms so the United States Department
10	of Defense may become a major customer for the consortium. If
11	fully built and implemented, the Hawaii Pacific hydrogen hub
12	will become a major industry and job center for the State.
13	Accordingly, the purpose of this part is to:
14	(1) Require the department of business, economic
15	development, and tourism to work with the University
16	of Hawaii on workforce development activities that
17	support the development of the Hawaii Pacific hydrogen
18	hub and other related aspects of the State's hydrogen
19	energy_industry;-and
20	(2) Appropriate funds for the Hawaii Pacific hydrogen
21	hub.] Repealed.

1	SECTION 3. [The department of business, economic
2	development, and tourism shall work with the University of
3	Hawaii on workforce development-activities that support the
4	development of the Hawaii Pacific hydrogen hub and other related
5	aspects of the State's hydrogen energy industry.] Repealed.
6	SECTION 4. [There is appropriated out of the general
7	revenues of the State of Hawaii the sum of \$5,500,000 or so much
8	thereof as necessary for fiscal year 2023-2024 and the sum of
9	\$10,000,000 or so much thereof as may be necessary for fiscal
10	year 2024-2025 to develop the Hawaii Pacific hydrogen hub.
11	The sums appropriated shall be expended by the department
12	of business, economic development, and tourism for the purposes
13	of this part.] Repealed."
14	SECTION 2. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 3. This Act shall take effect upon its approval.
