A BILL FOR AN ACT

RELATING TO SPECIAL LICENSE PLATES FOR IRAQ AND AFGHANISTAN WAR VETERANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 249-9.2, Hawaii Revised Statutes, is 2 amended by amending subsections (a) and (b) to read as follows: "(a) In lieu of the number plates contracted on behalf of 4 the counties by the director of finance of the city and county 5 of Honolulu, the director of finance shall provide, for a fee, 6 one set of special number plates upon the receipt of an 7 application together with: 8 (1)Specific proof that the applicant was awarded the 9 Purple Heart by the United States Department of 10 Defense for wounds received in military or naval 11 combat against an armed enemy of the United States; 12 (2)Certification that the applicant is a veteran; 13 (3) Specific proof that the applicant was serving the 14 United States in the military or as a civilian, on Oahu, or offshore at a distance of not more than three 15 16 miles at the time of the December 7, 1941, attack on 17 Pearl Harbor.
