A BILL FOR AN ACT

RELATING TO THE CERTIFICATION OF DOCUMENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The Hawaii Revised Statutes is amended by 1 adding a new chapter to be appropriately designated and to read 2 as follows: 4 "CHAPTER 5 APOSTILLES AND CERTIFICATIONS 6 -1 Definitions. As used in this chapter, unless the 7 context otherwise requires: "Apostille" means a certification issued to authenticate 8 9 documents pursuant to the Hague Treaty. "Hague Treaty" refers to the convention, adopted in the 10 Hague in 1961, that created a simplified form of document 11 certification for countries that joined the convention. 12 "Non-apostille certification" means a certification issued 13 by the lieutenant governor to authenticate a document for a 14 15 country that does not recognize the Hague Treaty. -2 Fee. (a) The office of the lieutenant governor 16 shall charge and collect a fee for each apostille or non-17

- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$12,000 or so much
- 7 thereof as may be necessary for fiscal year 2024-2025 to be
- 8 deposited into the apostilles and certifications special fund
- 9 established pursuant to section -3, Hawaii Revised Statutes.
- 10 SECTION 3. There is appropriated out of the apostilles and
- 11 certifications special fund established pursuant to
- 12 section -3, Hawaii Revised Statutes, the sum of \$12,000 or so
- 13 much thereof as may be necessary for fiscal year 2024-2025 for
- 14 operational and administrative expenses of the apostille and
- 15 certification of document services.
- 16 The sum appropriated shall be expended by the office of the

- 18 SECTION 4. This Act shall take effect on July 1, 2024.
