### A BILL FOR AN ACT

RELATING TO NURSES LICENSED IN ANOTHER JURISDICTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

endorsement to any applicant who has been licensed as 8 perform similar services under a different title, 9 under the laws of another state, territory, or foreign 10 country if the applicant has an unencumbered license 11 and, in the opinion of the board, the applicant meets 12 the requirements for licensed practical nurses in this 13 State at the time of graduation. #### JUSTIFICATION SHEET

DEPARTMENT: Commerce and Consumer Affairs

- TITLE: A BILL FOR AN ACT RELATING TO NURSES LICENSED IN ANOTHER JURISDICTION.
- PURPOSE: To clarify the issuance for a temporary permit for nurses and revise exceptions to the license requirements to allow for a nurse who accompanies a patient to Hawaii temporarily.
- MEANS: Add a new section to chapter 457 and amend sections 457-7(b), 457-8(b), and 457-13, Hawaii Revised Statutes.
- JUSTIFICATION: Historically, there has been a high demand for nurses in the State. The COVID-19 pandemic exacerbated the issue and nearly dwindled the State's nursing workforce to a critical low. The issuance of a temporary permit for nurses to work in this State temporarily will help mitigate the nursing shortage by streamlining the licensure process and recognizing licensure in another jurisdiction. This change would also allow time for the individual nurse to complete the regular licensing process while still being able to practice.

This bill will also allow a nurse who is licensed in another jurisdiction to accompany a patient who requires nursing care without first having to apply for and be issued a license by the Board of Nursing. For example, nurses often accompany patients for organizations such as Make-A-Wish to ensure continuity of care and appropriate care in cases of emergencies.

<u>Impact on the public:</u> Currently, the nursing shortage has reached a critical stage for our healthcare system. The proposed amendments would streamline the issuance of a temporary permit for nurses who could then work in Hawaii's healthcare

facilities and entities so that Hawaii residents can receive the care they need.

Impact on the department and other agencies: The Department of Commerce and Consumer Affairs' Professional and Vocational Licensing Branch may require an additional office assistant to process temporary permits. Interim rulemaking will be needed to establish fees for this permit.
