A BILL FOR AN ACT

RELATING TO ACT 278, SESSION LAWS OF HAWAII 2022.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 26-14.8, Hawaii Revised Statutes, is
2	amended by amending subsection (c) to read as follows:
3	"(c) The department of law enforcement shall be
4	responsible for the formulation and implementation of state
5	policies and objectives for security, criminal law enforcement,
6	and public safety programs and functions, for the service of
7	process, and for the security of state buildings and state
8	land."
9	SECTION 2. Act 278, Session Laws of Hawaii 2022, is
10	amended by amending section 1 to read as follows:
11	"SECTION 1. The purpose of this Act is to:
12	(1) Establish a new department of law enforcement to
13	consolidate and administer the criminal law
14	enforcement and investigations functions of the
15	department of transportation, certain [investigations
16	functions investigator positions of the department of
17	the attorney general, functions of the office of

1		nomeland security, and current law enforcement and
2		investigations functions of the department of public
3		safety;
4	(2)	Rename the department of public safety as the
5		department of corrections and rehabilitation, which
6		will administer the corrections, rehabilitation,
7		reentry, and related functions currently assigned to
8		the department of public safety;
9	(3)	Establish a training center within the department of
10		law enforcement;
11	(4)	Transfer employees, appropriations, records,
12		equipment, leases, contracts, other documents, rules,
13		policies, procedures, guidelines, and other material,
14		as appropriate, to the respective departments; and
15	(5)	Establish positions for the department of law
16		enforcement and the department of corrections and
17		rehabilitation, and appropriate funds for the
18		department of law enforcement.
19	Curr	ently, corrections and certain law enforcement
20	functions	and activities are placed within the department of
21	nublic sa	fety. The legislature finds that the goals and

- 1 functions of corrections and law enforcement are different and
- 2 distinct and separating the functions of corrections and law
- 3 enforcement from the department of public safety into two
- 4 departments would best accomplish the discrete goals and
- 5 objectives of both functions.
- 6 The legislature further finds that state criminal law
- 7 enforcement personnel and functions are currently spread across
- 8 various departments. The department of public safety,
- 9 department of transportation, and department of the attorney
- 10 general all have independent law enforcement officers and
- 11 different law enforcement duties. Because each department
- 12 administers its own law enforcement duties, goals, and
- 13 functions, training and operational standards differ between
- 14 each department. Accordingly, the reorganization of certain
- 15 state law enforcement functions into a single entity would
- 16 provide the highest level of law enforcement service for the
- 17 public, state employees, and state properties. Consolidation of
- 18 certain state criminal law enforcement responsibilities into a
- 19 single state department will centralize state law enforcement
- 20 functions to increase public safety, improve decision making,
- 21 promote accountability, streamline communication, decrease

1	costs, reduc	e duplication of efforts, and provide uniform
2	training and	standards.
3	The goa	ls of the department of law enforcement would
4	include:	
5	(1) Es	tablishing a partnership with the federal Joint
6	Te	rrorism Task Force to protect the State from

8	(2) El	iminating the narcotics epidemic that plagues

16	This Ac	t also establishes a training center within the
17	department c	f law enforcement to provide its law enforcement
18	entities the	highest level of core and continuing education and
19	training. T	The training center will also be made available to
20	federal, sta	te, and county law enforcement agencies upon their

request. The development of a department of law enforcement

21

- 1 training center, where all department of law enforcement
- 2 officers who intend to work on any island of Hawaii must be
- 3 certified, will ensure that all department of law enforcement
- 4 officers meet the standards set by the law enforcement standards
- 5 board established in chapter 139, Hawaii Revised Statutes. The
- 6 center will also ensure that the individuals who earn its
- 7 certification have learned the highest level of core and
- 8 continuing education and training. The center's curriculum will
- 9 be designed to ensure that the individuals trained here have the
- 10 knowledge and skills to protect and serve the public and will be
- 11 held accountable if they do not uphold the standards set by the
- 12 law enforcement standards board.
- 13 The legislature also finds that consolidating adult
- 14 corrections, reentry services, and other related functions into
- 15 a separate department of corrections and rehabilitation will
- 16 allow for the efficient use of resources in administering
- 17 correctional programs and administering and maintaining public
- 18 and private correctional services. The Hawaii correctional
- 19 industries, Hawaii paroling authority, and crime victim
- 20 compensation commission will be administered by the department
- 21 of corrections and rehabilitation.

The legislature intends that patrol officers assigned to 1 the department of law enforcement continue to retain the title 2 3 of deputy sheriffs. During the Kingdom of Hawaii, sheriffs oversaw law enforcement activities on each island under the 4 supervision of a kingdom-wide marshal. From 1905 to 1960, 5 sheriffs protected the public as elected county officials, 6 including Duke Kahanamoku, who was elected Honolulu sheriff from 7 1934 to 1960. Modern-day deputy sheriffs have protected the 8 people of Hawaii for nearly fifty years, beginning in 1963 when 9 10 the legislature created the office of the sheriff within the 11 department of the attorney general. 12 The legislature does not intend to impair or diminish the longstanding authority and responsibility of county police 13 departments to enforce the laws, along with state law 14 enforcement, on state lands within their respective counties. 15 County police departments will continue to have full law 16 17 enforcement authority and responsibility, and in particular will continue to have concurrent jurisdiction with respect to state 18

parks, state buildings, state highways, Hawaiian home lands, and

other state lands and facilities.

- 1 Part II of this Act is to be effective upon approval of
- 2 this Act. Part II establishes a department of law enforcement
- 3 and its director and deputy directors. The department of law
- 4 enforcement will initially be staffed by its director, deputy
- 5 directors, and certain administrative staff. These personnel
- 6 will prepare for the transfer of state law enforcement functions
- 7 and personnel to the department on January 1, 2024.
- 8 Part III of this Act is to be effective on January 1, 2024.
- 9 Part III transfers the law enforcement functions and personnel
- 10 from the department of public safety to the department of law
- 11 enforcement and makes conforming amendments.
- 12 Part IV of this Act is to be effective on January 1, 2024.
- 13 Part IV renames the department of public safety as the
- 14 department of corrections and rehabilitation and the director of
- 15 public safety as the director of corrections and rehabilitation,
- 16 establishes its deputy directors, and makes conforming
- 17 amendments so that the authority and responsibilities of the
- 18 department of corrections and rehabilitation are set forth in
- 19 chapter 353, Hawaii Revised Statutes, while the authority and
- 20 responsibilities of the department of law enforcement are set
- 21 forth in chapter 353C, Hawaii Revised Statutes.

- 1 Part V of this Act is to be effective on January 1, 2024.
- 2 Part V transfers the law enforcement and security functions and
- 3 personnel of the harbors division of the department of
- 4 transportation, [the non-statutorily mandated functions and]
- 5 certain law enforcement personnel of the investigations division
- 6 of the department of the attorney general, and the office of
- 7 homeland security of the department of defense to the department
- 8 of law enforcement.
- 9 Part VI of this Act provides for the retention of civil
- 10 service status and related rights of transferred employees and
- 11 transfers any appropriations, equipment, contracts, leases,
- 12 policies, rules, quidelines, and other items to the respective
- 13 departments as provided in this Act.
- 14 Part VII of this Act is to be effective on July 1, 2022.
- 15 Part VII establishes new positions within the department of law
- 16 enforcement that are required for the department's operations.
- 17 These positions include the director of law enforcement, deputy
- 18 directors, and certain administrative positions that will staff
- 19 the department, as well as new positions that will be required
- 20 when parts III and V take effect on January 1, 2024. Part VII
- 21 also appropriates funds to the department of law enforcement to

- 1 fill certain positions that will be required to prepare the
- 2 department for the transfer of functions, personnel, and assets
- 3 from other departments on January 1, 2024. Part VII further
- 4 requires the department of law enforcement to report to the
- 5 legislature, no later than twenty days prior to the convening of
- 6 the regular session of 2023, the progress made in preparing for
- 7 the transfer of law enforcement functions to the department on
- 8 January 1, 2024.
- 9 Part VIII of this Act is to be effective on January 1,
- 10 2024. Part VIII establishes new positions within the department
- 11 of corrections and rehabilitation that will be required for the
- 12 operation of the department when parts III and IV take effect on
- 13 January 1, 2024."
- 14 SECTION 3. Act 278, Session Laws of Hawaii 2022, is
- 15 amended by amending section 7 to read as follows:
- 16 "SECTION 7. Chapter 353C, Hawaii Revised Statutes, is
- 17 amended by adding a new section to be appropriately designated
- 18 and to read as follows:
- 19 "§353C- Statewide law enforcement training center; law
- 20 enforcement complex. There is established within the department
- 21 a department of law enforcement training center. The center

- 1 shall provide training and administer certification requirements
- 2 of all state department of law enforcement personnel who
- 3 exercise police powers in the State, and be available for all
- 4 county law enforcement agencies [-] and other state law
- 5 enforcement personnel who exercise police powers in the State.
- 6 Such training shall conform to uniform statewide standards set
- 7 by the law enforcement standards board pursuant to chapter 139.
- 8 The center shall operate and maintain such facilities as are
- 9 necessary to conduct training and certification under this
- 10 section. A new law enforcement complex at the [Mililani
- 11 technology park,] first responder technology campus, Oahu, is
- 12 also established, to be administered by the department of law
- 13 enforcement for multi-purpose law enforcement use to consolidate
- 14 and support:
- 15 (1) The respective headquarters and administrative
- 16 services of the affected functions involved;
- 17 (2) Training; and
- 18 (3) Related support services and facilities,
- 19 as required by law for the department of law enforcement to
- 20 operate and function.""

Amends Act 278, Session Laws of Hawaii 2022, to modify the transfer of the personnel and functions of the department of the attorney general to the department of law enforcement, clarify that Act 278 does not amend or abrogate the attorney general's status as the chief legal and law enforcement officer of the State, specify that the statewide law enforcement training complex will be located at the first responder technology campus rather than the Mililani technology park, and transfer the responsibility and management of certain private security contracts from the department of law enforcement to the department of defense, department of health, and department of human services for their respective facilities.
