#### A BILL FOR AN ACT

RELATING TO SCHOOL PSYCHOLOGY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

I	PART I
2	SECTION 1. The legislature finds that properly licensed
3	school psychologists provide effective services to help children
4	and youth succeed academically, socially, behaviorally, and
5	emotionally by providing direct educational and mental health
6	services for children and youth, as well as working with
7	parents, educators, and other professionals to create supportive
8	learning and social environments for all children.
9	Hawaii is the only state without certification or licensure
10	for school psychologists. Without licensing, the State cannot
11	ensure that functioning school psychologists are properly
12	qualified and delivering appropriate services. In addition, the
13	State's failure to properly license school psychologists means
14	that, by law, the State is unable to seek reimbursements from
15	the federal medicaid program for the use of school psychologists
16	in an educational setting. Consequently, it is necessary to
17	establish a licensure program to ensure the employment of

- 1 qualified school psychologists and to allow schools using school
- 2 psychologists to properly seek available federal medicaid funds.
- 3 The legislature further finds that a proper licensing
- 4 program requires establishing meaningful criteria and guidelines
- 5 for the licensure of school psychologists. The National
- 6 Association of School Psychologists' Standards for the
- 7 Credentialing of School Psychologists provides a model upon
- 8 which these guidelines may in part be based. The National
- 9 Association of School Psychologists' Standards provide a set of
- 10 national standards that can serve to regulate the credentialing
- 11 of school psychologists. School psychologists who hold a
- 12 National Association of School Psychologists credential have met
- 13 these national standards.
- 14 The legislature also finds that accredited school
- 15 psychologists should be licensed by, and registered with, the
- 16 board of psychology to ensure the delivery of quality services
- 17 to students and the community. The legislature additionally
- 18 finds that school psychologists and the practice of school
- 19 psychology should be subject to regulation and control to
- 20 protect the public from the unqualified practice of school

1	psycholog	y and unprofessional conduct by persons licensed to
2	practice	school psychology.
3	Acco	rdingly, the purpose of this Act is to:
4	(1)	Establish the recommended criteria for the licensure
5		of school psychologists, including graduate
6		coursework, practice, and internship requirements
7		based in part on the National Association of School
8		Psychologists' Standards;
9	(2)	Amend the composition of the board of psychology to
10		include two school psychologists; and
11	(3)	Require all persons practicing under the title of
12		"school psychologist" in the State to obtain a school
13		psychologist license with the board of psychology by
14		July 1, 2025.
15		PART II
16	SECT	ION 2. Chapter 465, Hawaii Revised Statutes, is
17	amended b	y adding a new part to be appropriately designated and
18	to read a	s follows:
19		"PART . SCHOOL PSYCHOLOGISTS
20	§465	- Findings and declaration of necessity. It is the
21	intent of	the legislature to establish standards for the

- 1 licensing of school psychologists to address the present and
- 2 critical need for ensuring that individuals requiring the
- 3 services of a licensed school psychologist receive appropriate
- 4 services by highly qualified and licensed professionals. The
- 5 special state interest for creating this part is recognized,
- 6 notwithstanding the requirements of section 26H-6.
- 7 **§465- Definitions.** As used in this part:
- 8 "Accredited educational institution" means a university or
- 9 college accredited by the Western Association of Schools and
- 10 Colleges or a comparable regional body.
- 11 "Approved private school" means any educational institution
- 12 that is licensed or accredited by the Hawaii Association of
- 13 Independent Schools.
- 14 "Developmental center" means any facility that offers
- 15 developmentally appropriate psychological, educational, social,
- 16 adaptive, language, or motor skills training or
- 17 psychoeducational and multidisciplinary diagnostic services to
- 18 special needs children or developmentally disabled adults.
- 19 "Practice of school psychology" means the application of
- 20 principles, methods, and procedures of measurement, prediction,
- 21 evaluation, testing, counseling, consultation, and instruction

- 1 related to, and consistent with, the national standards
- 2 articulated by the most current Model for Comprehensive and
- 3 Integrated School Psychological Services, as published by the
- 4 National Association of School Psychologists or its successor,
- 5 in a school setting. "Practice of school psychology" does not
- 6 include private practice.
- 7 "School psychologist" means a person licensed by the board
- 8 who engages in the practice of school psychology consistent with
- 9 the national standards articulated by the most current Model for
- 10 Comprehensive and Integrated School Psychological Services as
- 11 published by the National Association of School Psychologists or
- 12 its successor. "School psychologist" includes a school
- 13 psychologist-doctorate and a school psychologist-specialist.
- "School setting" means any school or educational
- 15 institution where children and students from birth to college
- 16 are eligible to be enrolled, including but not limited to an
- 17 educational or intermediate educational unit, special education
- 18 program, university or college, early intervention program,
- 19 developmental center, and approved private school.
- 20 §465- School psychologists; regulation; qualifications.
- 21 (a) Notwithstanding any other law, school psychologists in the

6		school psychologist in Hawaii as of July 1, 2023, an
7		out-of-state license or credential that has been
8		expired for no more than ten years from July 1, 2023,
9		shall also be accepted.
10	(c)	Before any applicant shall be eligible for licensure
11	under this	s part, the applicant shall file an application in a
12	form presc	cribed by the board and pay an application fee and all
13	other appl	icable fees.
14	§465-	Fees; disposition. (a) Upon application for a
15	new licens	se and at each biennial renewal, each applicant shall
16	pay a lice	ense fee of \$ and a compliance resolution
17	fund fee c	of \$ . Application fees paid pursuant to this
18	part shall	not be refundable. Fees collected pursuant to this
19	section sh	hall be deposited into the compliance resolution fund
20	establishe	ed pursuant to section 26-9(o).

- 1 (b) Every school psychologist holding a license under this
- 2 part shall renew the license with the board no later than
- 3 June 30 of each even-numbered year. Every school psychologist
- 4 shall pay a renewal fee and comply with the continuing education
- 5 requirements provided in rules adopted by the board pursuant to
- 6 chapter 91.
- 7 (c) A school psychologist shall meet the continuing
- 8 education requirements by obtaining twenty-five credit hours
- 9 accredited by the National Association of School Psychologists
- 10 annually, as provided in the board's rules. To determine
- 11 compliance, the board may conduct a random audit. A school
- 12 psychologist selected for audit shall be notified by the board.
- 13 Within sixty days of notification, the school psychologist shall
- 14 provide to the board documentation to verify compliance with the
- 15 continuing education requirements.
- (d) Failure to renew, pay the renewal fee, or provide
- 17 documentation of compliance in the case of an audit shall
- 18 constitute a forfeiture of license, which may be restored only
- 19 upon the submission of written application therefor, payment to
- 20 the board of a restoration fee, and, in the case of audited
- 21 school psychologists, documentation of compliance.

- 1 §465- Description of services. (a) A person practices
- 2 as a school psychologist if the person delivers services to
- 3 children and students from birth through college who are
- 4 eligible to be enrolled in educational and intermediate
- 5 educational units, special education programs, universities and
- 6 colleges, early intervention programs, developmental centers,
- 7 and approved private schools. School psychologists are limited
- 8 to practicing within these settings, and licensure shall not
- 9 allow for private practice.
- 10 (b) Services delivered pursuant to this section are
- 11 articulated under the domains of the National Association of
- 12 School Psychologists' Model for Comprehensive and Integrated
- 13 School Psychological Services, as may be amended, which
- 14 represents the National Association of School Psychologists'
- 15 official policy regarding the delivery of school psychological
- 16 services and the ethical standards developed and published by
- 17 the National Association of School Psychologists.
- 18 §465- Practice of school psychology; license required.
- 19 (a) Beginning on July 1, 2025, no person shall engage in the
- 20 practice of school psychology or represent, announce, or
- 21 advertise oneself, publicly or privately, as a "licensed school

- 1 psychologist" or "school psychologist" or affix any other words,
- 2 letters, abbreviations, or insignia to the person's name
- 3 indicating or implying that the person is engaged in the
- 4 practice of school psychology, without having first obtained a
- 5 license as provided in this part; provided that all school
- 6 psychologists employed by the department of education shall be
- 7 licensed under this part by July 1, 2025.
- 8 (b) A person who is a student in an accredited school
- 9 psychology program may use a title of "school psychology intern"
- 10 or "school psychology practicum student" that indicates the
- 11 person's training status; provided that the person shall not
- 12 identify the person's self as a "licensed school psychologist"
- 13 or "school psychologist" or imply that the person is licensed to
- 14 practice school psychology.
- 15 (c) Any person who violates this section shall be subject
- 16 to a fine of not more than \$1,000 for each separate offense.
- 17 Each day of each violation shall constitute a separate offense.
- 18 §465- Advising the board of psychology. The board
- 19 shall receive advice and review proposals from the Hawaii
- 20 Association of School Psychologists regarding issues relating to
- 21 school psychologists and the practice of school psychology.

1	§465·	Grounds for refusal to renew, reinstate, or
2	restore a	license and for denial, revocation, suspension, or
3	condition	of licenses. (a) In addition to other acts or
4	conditions	s provided by law, the board may refuse to renew,
5	reinstate	, or restore, and may deny, revoke, suspend, or
6	condition	in any manner any license for any one or more of the

19		psychology through fraud, misrepresentation, or
20		deceit;

(3)	Alding and abetting an unlicensed person to directly
	or indirectly perform activities requiring a license;
(6)	Engaging in professional misconduct, incompetence,
	gross negligence, or manifest incapacity in the
	practice of school psychology;
(7)	Engaging in conduct or practice contrary to recognized
	standards of ethics for the practice of school
	psychology;
(8)	Violating any condition or limitation imposed on a
	license for the practice of school psychology by the
	board;
(9)	Engaging in the practice of school psychology in a
	manner that causes injury to one or more members of
	the public;
(10)	Failing to comply with, observe, or adhere to any law
	in a manner such that the board deems the applicant or
	holder to be an unfit or improper person to hold a
	license;
(11)	Revocation, suspension, or other disciplinary action
	by another state or federal agency against a licensee

1		or applicant for any reason provided by the licensing
2		laws or this section;
3	(12)	Criminal conviction, whether by nolo contendere or
4		otherwise, of a penal crime directly related to the

6		psychology, notwithstanding any statutory provision to
7		the contrary;
8	(13)	Failing to report to the board, in writing, any
9		disciplinary decision issued against the licensee or
10		the applicant in another jurisdiction within thirty
11		days after the disciplinary decision is issued;
12	(14)	Employing, using, or attempting to employ or use at
13		any time any person not licensed under this chapter
14		where licensure is required; or
15	(15)	Violating this part, chapter 436B, or any rule or
16		order of the board.
17	(b)	Any licensee or applicant who violates this section
18	may also	be fined not less than \$100 and not more than \$1,000.
19	§ <b>4</b> 65	- Exemption. This part is not intended to restrict
20	the pract	ice of other licensed or credentialed practitioners
21	practicin	a within their own recognized scopes of practice in

- educational settings. This part shall not apply to any personworking within the scope of practice or duties of another
- 3 licensed profession that overlaps with the practice of school
- 4 psychology; provided that the person does not use the title
- 5 "school psychologist" or "licensed school psychologist"."

- 7 amended by designating sections 465-1 to 465-15 as part I and
- 8 inserting a title before section 465-1 to read as follows:

- 10 SECTION 4. Section 465-3, Hawaii Revised Statutes, is
- 11 amended by amending subsection (a) to read as follows:

- (5) Any person who is a member of another profession
  licensed under the laws of this jurisdiction to render
  or advertise services, including psychotherapy, within
  the scope of practice as defined in the statutes or
  rules regulating the person's professional practice;
  provided that, notwithstanding section 465-1, the
  person does not represent the person's self to be a
  psychologist or does not represent that the person is
  licensed to practice psychology;
- (6) Any person who is a member of a mental health profession not requiring licensure; provided that the person functions only within the person's professional capacities; and provided further that the person does not represent the person to be a psychologist, or the person's services as psychological;
- (7) Any person who is a duly recognized member of the clergy; provided that the person functions only within the person's capacities as a member of the clergy; and provided further that the person does not represent

1		the person to be a psychologist, or the person's
2		services as psychological;
3	(8)	Any psychologist employed by the United States
4		Department of Defense, while engaged in the discharge
5		of the psychologist's official duty and providing
6		direct telehealth support or services, as defined in
7		section 431:10A-116.3, to neighbor island
8		beneficiaries within a Hawaii National Guard armory on
9		the island of Kauai, Hawaii, Molokai, or Maui;
10		provided that the psychologist employed by the United
11		States Department of Defense is credentialed by

15	SECT	ION 5. Section 465-4, Hawaii Revised Statutes, is
16	amended t	o read as follows:

19	consistin	g of [seven] <u>nine</u> members. There shall be five members
20	represent	ing varied specialties of the profession, each of whom
21	shall be	licensed to practice psychology under this chapter and

- 1 have a minimum of five years of post-doctoral professional
- 2 experience, two members who are licensed to practice school
- 3 psychology under part , and two lay members from the
- 4 community at large[-]; provided that, of the initial licensed
- 5 school psychologist appointees, one shall be appointed for a
- 6 three-year term. A lay member shall not be a psychologist, an
- 7 applicant, or former applicant for licensure as a psychologist."

- 9 SECTION 6. Section 26H-4, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "\$26H-4 Repeal dates for newly enacted professional and
- 12 vocational regulatory programs. (a) Any professional or
- 13 vocational regulatory program enacted after January 1, 1994, and
- 14 listed in this section shall be repealed as specified in this
- 15 section. The auditor shall perform an evaluation of the
- 16 program, pursuant to section 26H-5, prior to its repeal date.
- 17 (b) Chapter 466L (appraisal management companies) shall be
- 18 repealed on June 30, 2023.
- 19 (c) Chapter 457J (midwives) shall be repealed on
- **20** June 30, 2025.

- 1 (d) Part of chapter 465 (school psychologists) shall
- 2 be repealed on June 30, 2030."
- 3 PART IV
- 4 SECTION 7. This Act does not affect rights and duties that
- 5 matured, penalties that were incurred, and proceedings that were
- 6 begun before its effective date.
- 7 SECTION 8. If any provision of this Act, or the
- 8 application thereof to any person or circumstance, is held
- 9 invalid, the invalidity does not affect other provisions or
- 10 applications of the Act that can be given effect without the
- 11 invalid provision or application, and to this end the provisions
- 12 of this Act are severable.
- SECTION 9. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 10. This Act shall take effect on June 30, 3000.

School Psychologists; Licensure; Board of Psychology; Composition; Requirements

#### Description:

Establishes licensure requirements for school psychologists to be administered by the board of psychology. Requires all school psychologists to be licensed by 7/1/2025. Increases the composition of the board of psychology to include two school psychologists. Effective 6/30/3000. (HD1)
