A BILL FOR AN ACT

RELATING TO THE SEEKING OF ASSISTANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that women and
- 2 marginalized persons in the sex trade are often reluctant to
- 3 disclose their victimization to legal authorities and medical
- 4 providers. As a result, they are often revictimized,
- 5 significantly triggered, and misdirected to believe that they
- 6 cannot be served and that they are criminals. Most of these
- 7 individuals are not able to safely disclose their situations
- 8 without fear of violent retaliation from their trafficker or
- 9 buyer.
- 10 The legislature further finds that it is important to
- 11 recognize that the participation of women and marginalized
- 12 persons in the sex trade should not bar their access to
- 13 resources, safety, and compassion. Therefore, the purpose of
- 14 this Act is to provide protections to individuals involved in
- 15 the sex trade from the consequences under criminal law of
- 16 disclosing their engagement or being identified as engaging in

- prostitution while in the course of seeking medical or law
 enforcement assistance.
- 3 SECTION 2. Chapter 712, Hawaii Revised Statutes, is
- 4 amended by adding a new section to part I to be appropriately
- 5 designated and to read as follows:
- 6 "§712- Seeking of medical or law enforcement
- 7 assistance; protections. (a) No person who would be subject to
- 8 prosecution under section 712-1200 who, in good faith, seeks
- 9 medical assistance or law enforcement assistance for the
- 10 person's self or another person, or who is the subject of such a
- 11 good faith request, shall:
- 12 (1) Be cited, arrested, charged, prosecuted, or convicted;
- 13 (2) Have the person's property subject to civil
- forfeiture; or
- 15 (3) Otherwise be penalized pursuant to section 712-1200,
- 16 if the evidence for the citation, arrest, charge, prosecution,
- 17 conviction, forfeiture, or penalty was gained as a result of the
- 18 seeking of medical assistance or seeking of law enforcement
- 19 assistance, including while the person is experiencing a
- 20 substance-related crisis or witnessing another person's
- 21 experiencing a substance-related crisis.

21		of law enforcement assistance.

- 1 "Substance" means alcohol, any drug on schedules I through
- 2 IV of chapter 329, or any substance that includes in its
- 3 composition volatile organic solvents."
- 4 SECTION 3. This Act does not affect rights and duties that
- 5 matured, penalties that were incurred, and proceedings that were
- 6 begun before its effective date.
- 7 SECTION 4. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.
