## A BILL FOR AN ACT

RELATING TO EARLY INTERVENTION SERVICES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. (a) There is established within the department
 of health for administrative purposes an early intervention
 services working group. The working group shall:

4	(1)	Study and recommend ways to assist and support deaf
5		and hard of hearing children, including best practices
6		in early intervention services and education; and
7	(2)	Develop strategies to implement those recommendations.
8	(b)	The working group shall consist of the following
9	members:	
10	(1)	A representative of the family health services
11		division of the department of health, who shall be
12		appointed by the director of health;
13	(2)	A representative of the early intervention section of
14		the department of health, who shall be appointed by
15		the director of health;

1	(3)	A representative of the department of human services,
2		who shall be appointed by the director of human
3		services;
4	(4)	A representative of the university of Hawaii, who
5		shall be appointed by the president of the university
6		of Hawaii;
7	(5)	A representative of the department of education, who
8		shall be appointed by the superintendent of education;
9	(6)	The chairperson of the senate standing committee on
10		health and human services;
11	(7)	The chairperson of the house of representatives
12		standing committee on health and homelessness;
13	(8)	The director of the executive office on early
14		learning, or the director's designee;
15	(9)	A representative of an entity that provides services
16		to deaf or hard of hearing children, who shall be
17		invited to participate by the governor; and
18	(10)	A parent of a deaf or hard of hearing child under five
19		years old who receives or has received early
20		intervention services, who shall be invited to
21		participate by the governor.

The working group may invite other persons to participate
 on the working group.

3 (c) The working group shall select a chairperson from4 among its members.

5 (d) The members of the working group shall not be subject
6 to chapter 84, Hawaii Revised Statutes, solely based on their
7 participation on the working group.

8 (e) Members of the working group shall serve without
9 compensation but shall be reimbursed for reasonable expenses,
10 including travel expenses, necessary for the performance of
11 their duties.

12 (f) The department of health shall provide administrative13 support to the working group.

(g) The working group shall submit a report of its
findings and recommendations, including any proposed
legislation, to the legislature no later than twenty days prior
to the convening of the regular session of 2024.

SECTION 2. There is appropriated out of the general
 revenues of the State of Hawaii the sum of \$ or so
 much thereof as may be necessary for fiscal year 2023-2024 for
 expenses of the early intervention services working group.
