A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1		PART I
2	SECT	ION 1. The legislature finds that there is great
3	demand fo	r high quality mental health practitioners in the
4	State, pa	rticularly in the aftermath of the coronavirus disease
5	2019 pand	emic. The purpose of this Act is to expand access to
6	high qual	ity mental health services by:
7	(1)	Establishing provisional or associate-level licensure
8		requirements and insurance reimbursement allowances
9		for marriage and family therapists, mental health
10		counselors, and psychologists in training;
11	(2)	Requiring psychologist license applicants to possess a
12		doctoral degree and complete certain supervised
13		experience requirements before sitting for the
14		licensing examination; and
15	(3)	Authorizing insurance reimbursements for services
16		provided by a supervised social work intern in certain
17		circumstances.

2	SECTION 2. Chapter 451J, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated

13		and family therapist pursuant to section 451J-7(3);

15		therapist is in good standing with the department; and		
16	(4)	Has passed the National Marriage and Family Therapy
