# A BILL FOR AN ACT

RELATING TO WATER CONSERVATION.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that conserving Hawaii's 2 finite water resources is essential to ensure the health of the State's fresh water supply. In response to the recent fuel 3 4 spills at Red Hill, the city and county of Honolulu's board of 5 water supply shut down one of Oahu's largest water sources, the 6 Halawa shaft, which subsequently led to calls for water 7 conservation on Oahu. Other counties, in response to equipment 8 breakdowns, drought, and other circumstances, have also had to 9 implement calls for water conservation multiple times in recent 10 years.

11 The legislature also finds that residential irrigation is a 12 major source of water use and, frequently, wasteful misuse. 13 When water conservation measures are in effect, reducing or 14 ceasing irrigation is always one of the first things residents 15 are asked to do because using less water for irrigation has a 16 large impact for a relatively small sacrifice. The legislature 17 further finds that the practice of maintaining landscaping that

is not suited to the local climate requires more labor, money,
 time, and water than landscape installations that are
 drought-resistant, less water-intensive, and more suited to the
 local conditions.

5 Therefore, the purpose of this Act is to appropriate moneys 6 to the city and county of Honolulu board of water supply to 7 create a pilot program that incentivizes residential homeowners 8 in certain dry areas to replace water-intensive landscaping with 9 alternatives that reduce water use.

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal year 2024-2025 for the city and county of Honolulu board of water supply to establish an irrigation water use reduction pilot program to provide:

17 (1) Incentives to residential homeowners in dry areas of
18 Oahu that were previously served by the Aiea and
19 Halawa wells who replace existing landscaping and
20 irrigation with alternatives that lower water use;
21 provided that preference may be given to alternatives

1 that include native species and support pollinators; 2 and

3 (2) Outreach services and education to the public
4 concerning landscaping and irrigation alternatives
5 that reduce water use;

6 provided further that no moneys appropriated shall be expended 7 unless a forty per cent match is provided by the city and county 8 of Honolulu; provided further that the rebate amount shall be 9 determined by the city and county of Honolulu board of water 10 supply but shall not be more than \$1,500 per project; provided 11 further that for a residential homeowner to qualify for the 12 rebate under the irrigation water use reduction pilot program, 13 the city and county of Honolulu board of water supply shall 14 verify that the residential homeowner experienced a reduction in 15 water use by at least thirty per cent and the replacement of 16 landscaping or irrigation was performed by a licensed landscape 17 contractor in good standing with the department of commerce and 18 consumer affairs.

19 The sums appropriated shall be expended by the city and 20 county of Honolulu board of water supply for the purposes of 21 this Act.
