A BILL FOR AN ACT

RELATING TO CHILD WELFARE SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The purpose of this Act is to:
2	(1)	Establish the Malama Ohana working group to seek,
3		design, and recommend transformative changes to the
4		State's existing child welfare system;
5	(2)	Appropriate funds to the department of human services
6		to increase the procurement of contracted services to
7		provide additional support and resources to families
8		receiving benefits from the State's adoption
9		assistance and permanency assistance programs; and
10	(3)	Appropriate funds to the office of wellness and
11		resilience for the working group.
12	SECT	ION 2. (a) There is established within the office of
13	wellness	and resilience for administrative purposes a Malama
14	Ohana wor	king group to seek, design, and recommend
15	transform	ative changes to the State's existing child welfare
16	system.	

ı	(d)	The Malama Ohana working group shall consist of the
2	following	:
3	(1)	The executive director of the office of wellness and
4		resilience, or the director's designee;
5	(2)	The chief executive officer of the office of Hawaiian
6		affairs, or the chief executive officer's designee;
7	(3)	Two investigators, case managers, or their assistants,
8		from the department of human services' child welfare
9		services branch, as designated by the branch
10		administrator; and
11	(4)	The chairperson of the trauma-informed care task force
12		established within the department of health for
13		administrative purposes pursuant to Act 209, Session
14		Laws of Hawaii 2021, or the chairperson's designee;
15	(c)	The Malama Ohana working group shall invite the
16	following	representatives to join the working group:
17	(1)	The executive director of Effective Planning and
18		Innovative Communication, Inc., doing business as EPIC
19		'Ohana, or the executive director's designee, who shall
20		be requested to serve as co-chair of the working
21		group;

1	(2)	The chief executive officer of Hale Kipa, Inc., or the
2		chief executive's designee, who shall be requested to
3		serve as co-chair of the working group;
4	(3)	Four members of Nā Kama a Hāloa;
5	(4)	Two members from each of the following constituencies,
6		as identified by Nā Kama a Hāloa:
7		(A) Former foster youth;
8		(B) Birth parents who were involved in the child
9		welfare system, specifically with the department
10		of human services' child welfare services branch;
11		(C) Licensed resource caregivers; and
12		(D) Kinship resource caregivers;
13	(5)	The chief executive officer of Kamehameha Schools, or
14		the chief executive officer's designee; and
15	(6)	The chief executive officer of Lili'uokalani Trust, or
16		the chief executive officer's designee.
17	(d)	The Malama Ohana working group shall develop
18	recommend	ations to establish a child welfare system that is
19	trauma-in	formed, sustains a community-based partnership, and
20	responsiv	e to the needs of children and families in the child

1	welfare s	ystem and among the larger community. In carrying out
2	its purpo:	se, the working group shall:
3	(1)	Conduct listening sessions throughout the State and
4		with affected constituencies;
5	(2)	Conduct meetings to brainstorm and develop concepts
6		for recommendations;
7	(3)	Develop recommendations on ways to better coordinate
8		and improve the protection and well-being of children
9		and families in the child welfare system;
10	(4)	Identify training and best practices, assessment
11		criteria, and ways to sustain an effective workforce
12		within the department of human services' child welfare
13		services branch;
14	(5)	Identify training and best practices, assessment
15		criteria, and ways to sustain an effective workforce
16		within the larger circle of community agencies serving
17		the child welfare system;
18	(6)	Identify best practices, including Native Hawaiian
19		cultural practices, for providing assistance to
20		children and youth who were involved in the child
21		welfare system and their families;

1	(/)	Identity other cultural practices that build wellness
2		and resilience in communities and improve
3		collaboration between communities and the child
4		welfare services branch; and
5	(8)	Collaborate with the trauma-informed care task force,
6		and where appropriate, conduct joint listening
7		sessions or design sessions for the purpose of
8		reforming the child welfare system.
9	(e)	Members of the Malama Ohana working group shall serve
10	without c	ompensation but shall be reimbursed for reasonable
11	expenses	necessary for the performance of their duties,
12	including	travel expenses. No member of the working group shall
13	be subjec	t to chapter 84, Hawaii Revised Statutes, solely
14	because o	f the member's participation in the working group.
15	(f)	The office of wellness and resilience may contract
16	with an a	dministrative facilitator to provide necessary support
17	for the M	alama Ohana working group in carrying out its
18	activitie	s, including preparation of the report required
19	pursuant	to subsection (g), without regard to chapter 103D,
20	Hawaii Re	vised Statutes

1 The Malama Ohana working group shall submit a report 2 of its findings and recommendations, including any proposed 3 legislation, to the legislature no later than twenty days prior 4 to the convening of the regular session of 2025. 5 The Malama Ohana working group shall cease to exist on July 1, 2025. 6 7 SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 8 much thereof as may be necessary for fiscal year 2023-2024 and 9 10 the same sum or so much thereof as may be necessary for fiscal 11 year 2024-2025 for the procurement of contracted services to 12 provide additional support and resources to families receiving 13 benefits from the State's adoption assistance program and 14 permanency assistance program, for the purposes of assisting 15 with family strengthening and the maintenance of a safe home environment for adopted children; provided that: 16 17 (1)shall be expended for the development and 18 maintenance of necessary information technology 19 systems, including the establishment of two full time

equivalent (2.0 FTE) positions;

1	(2)	\$ shall be expended to increase compensation
2		to fill vacancies and retain employees in existing
3		child welfare services branch investigator, case
4		manager, and social worker positions; provided that
5		any increase in compensation shall be subject to
6		collective bargaining with the objective of
7		expeditiously filling all vacancies;
8	(3)	\$ shall be expended for the department of
9		human services to contract with a third party for
10		enhanced permanency support services, including
11		additional training for resource caregivers, wellness
12		visits within a year of adoption or guardianship of
13		children formerly in foster care, respite care, and
14		enhanced supportive services to assist with family
15		strengthening and maintenance of a safe home
16		environment for adopted children; and
17	(4)	\$ shall be expended for the establishment of
18		one full time equivalent (1.0 FTE) planner or project
19		specialist position to administer and monitor
20		additional service contracts and assist with
21		additional service coordination.

- 1 The sums appropriated shall be expended by the department
- 2 of human services for the purposes of this Act.
- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2023-2024 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2024-2025 for the Malama Ohana working group established
- 8 pursuant to section 2 of this Act, including for the office of
- 9 wellness and resilience to contract with an administrative
- 10 facilitator to provide necessary support for the working group
- 11 in carrying out its activities.
- 12 The sums appropriated shall be expended by the office of
- 13 the governor for the purposes of this Act.
- 14 SECTION 5. This Act shall take effect on July 30, 3000;
- 15 provided that section 3 of this Act shall take effect on July 1,
