

A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Kapaa public
- 2 housing project, located in Kapaa, Kauai, was first occupied in
- 3 1966 and is owned and managed by the Hawaii public housing
- 4 authority. The Hawaii public housing authority has determined
- 5 that, at fifty-seven years old, the project is at the end of its
- 6 useful life and that it would be cost prohibitive to
- 7 rehabilitate the eighteen single-story duplexes, which consist
- 8 of thirty-six public housing units ranging from one, two, three,
- 9 or four-bedroom units. Moreover, the Hawaii public housing
- 10 authority has determined that the 4.33 acre site has the
- 11 potential to accommodate between eighty and one hundred fourteen
- 12 units.
- 13 The legislature further finds that the county of Kauai
- 14 department of water and wastewater division of the county of
- 15 Kauai department of public works confirmed that there is
- 16 adequate water and wastewater infrastructure to accommodate one
- 17 hundred fourteen housing units. Due to the close proximity to

- 1 the Bryan J. Baptiste sports complex, Kapaa middle school,
- 2 historic Kapaa town, and Kauai bus transit station, this project
- 3 is consistent with smart growth policies in the Kauai general
- 4 plan.
- 5 The purpose of this Act is to appropriate funds to plan and
- 6 develop up to one hundred fourteen units of affordable housing
- 7 at the Kapaa public housing project in Kapaa, Kauai. The
- 8 proposed project would include the development of thirty-six
- 9 replacement public housing units, and up to seventy-eight
- 10 additional housing units comprised of a mix of supportive
- 11 housing, affordable housing, and workforce housing.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$2,000,000 or so much
- 14 thereof as may be necessary for fiscal year 2023-2024 and the
- 15 same sum or so much thereof as may be necessary for fiscal year
- 16 2024-2025 for the planning and design of up to one hundred
- 17 fourteen housing units at the Kapaa public housing project site
- 18 in Kapaa, Kauai, including the development of thirty-six
- 19 replacement public housing units, and up to seventy-eight
- 20 additional housing units comprised of a mix of supportive
- 21 housing, affordable housing, and workforce housing.

- 1 The sums appropriated shall be expended by the Hawaii
- 2 public housing authority for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2023.
