

A BILL FOR AN ACT

RELATING TO VALUE-ADDED PRODUCTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that establishing a food
- 2 and product innovation network is critical to meeting the
- 3 State's agricultural and economic diversification goals. The
- 4 network will allow businesses in the State to capitalize
- 5 globally on the "made in Hawaii" brand, create world-class
- 6 products, and scale up production by providing the businesses
- 7 with access to a diverse suite of manufacturing equipment and
- 8 industry expertise.
- Accordingly, the purpose of this Act is to establish a
- 10 statewide network of open-access food and value-added product
- 11 development facilities to enable businesses to scale up new
- 12 products from research and development to manufacturing and
- 13 commercialization.
- 14 SECTION 2. Chapter 163D, Hawaii Revised Statutes, is
- 15 amended by adding a new section to be appropriately designated
- 16 and to read as follows:

4	food and	product innovation network shall be to allow businesses

7	and scale up production by providing the businesses with access

10	(b)	Partner members of the food and product innovation	
11	network s	hall include:	
12	(1)	The department of education food and product	
13		innovation center in Kekaha, on the island of Kauai;	
14	(2)	The foreign-trade zone facility in Hilo, on the island	
15		of Hawaii;	
16	(3)	The university of Hawaii Maui college food innovation	
17		center, on the island of Maui; and	
18	(4)	The university of Hawaii Leeward community college	
19		value-added product development center in Wahiawa, on	
20		the island of Oahu.	
21	(c)	The food and product innovation network shall:	

1	<u>(1)</u>	Offer a range of resources within the wider network to
2		support innovation and business development, including
3		courses and events relating to food and value-added
4		product development, entrepreneurship, marketing,
5		branding, business management, workforce development,
6		intellectual property protection, and other topics;
7	(2)	Provide new product development support from
8		early-stage trials to commercialization by
9		establishing a network of facilities with equipment of
10		various scales, providing expert advice, and offering
11		resources tailored to the regional economies;
12	(3)	Provide low-risk commercial production with
13		appropriate certifications for exporting products and
14		selling products locally;
15	(4)	Provide recommendations on process optimization by
16		offering advice and networking, identifying and
17		testing equipment, planning trials, and analyzing
18		results;
19	<u>(5)</u>	Increase exports by securing facilities and developing
20		compliance programs for off-shore markets; provided
21		that each county shall have no more than two food and



1		product innovation network facilities that produce
2		products labeled "made in Hawaii", "produced in
3		Hawaii", or "processed in Hawaii" pursuant to
4		section 486-119;
5	<u>(6)</u>	Develop entrepreneurs to grow the State's economy; and
6	<u>(7)</u>	Prepare businesses to scale up and to achieve
7		autonomous business success and sustainability.
8	<u>(d)</u>	No later than twenty days prior to the convening of
9	each regu	lar session, the food and product innovation network
10	shall sub	mit a report to the legislature including:
11	(1)	A description of the food and product innovation
12		network's activities and progress in the preceding
13		year, including the activities and progress of primary
14		members and partner members, in response to the
15		directives established pursuant to subsection (c);
16	(2)	An assessment of any progress Hawaii has made in
17		growing the State's agriculture industry, food
18		industry, and related industries, and in meeting the
19		State's food security goals; and
20	(3)	Any proposed legislation."



1 SECTION 3. Section 163D-2, Hawaii Revised Statutes, is 2 amended by adding two new definitions to be appropriately 3 inserted and to read as follows: 4 ""Partner member" means an open-access food and value-added 5 product development facility that is part of the food and 6 product innovation network but is not managed or operated by the 7 corporation. 8 "Primary member" means an open-access food and value-added 9 product development facility that is part of the food and 10 product innovation network and is managed and operated by the 11 corporation." 12 SECTION 4. Section 163D-4, Hawaii Revised Statutes, is 13 amended by amending subsection (b) to read as follows: 14 "(b) The corporation shall [develop,]: 15 (1) Develop, promote, assist, and market agricultural 16 products for local consumption, and shall promote and 17 assist in commercial export of agricultural 18 products[-]; and 19 (2) Oversee the food and product innovation network 20 pursuant to section 163D- ; provided that the

1		responsibilities and operations of each partner member
2		shall remain with the partner member."
3	SECT	ION 5. There is appropriated out of the general
4	revenues	of the State of Hawaii the sum of \$ or so
5	much ther	eof as may be necessary for fiscal year 2023-2024 and
6	the same	sum or so much thereof as may be necessary for fiscal
7	year 2024	-2025 for the food and product innovation network
8	establish	ed pursuant to this Act, including:
9	(1)	\$ for a food and product innovation facility
10		on the island of Molokai; provided that the facility
11		shall utilize axis deer for producing food and
12		value-added products, including leather and
13		pharmaceuticals; and
14	(2)	\$ for a food and product innovation
15		facility on the island of Oahu.
16	The	sums appropriated shall be expended by the agribusiness
17	developme	ent corporation for the purposes of this Act.
18	SECI	'ION 6. Statutory material to be repealed is bracketed
19	and stric	ken. New statutory material is underscored.

1 SECTION 7. This Act shall take effect on July 1, 2023.
