A BILL FOR AN ACT

RELATING TO HEALTHCARE PRECEPTORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a shortage 2 of health care providers in the State, particularly primary care 3 providers, which will be exacerbated by the projected retirement of current physicians, advanced practice registered nurses, 4 5 pharmacists, and other healthcare workers. Further, although 6 students are interested in pursuing careers in Hawaii's health 7 care service industry, in-state educational institutions are 8 constrained by the lack of clinical education sites in the State 9 and the limited supply of qualified preceptors. One way to encourage the participation of preceptors is to offer an income 10 tax credit for health care professionals who serve as 11 12 preceptors.

13 The purpose of the existing healthcare preceptor income tax 14 credit established under section 235-110.25, Hawaii Revised 15 Statutes, is to incentivize volunteer preceptors to offer 16 professional instruction, training, and supervision to students 17 and residents seeking careers as health care providers in the

State. During the implementation of the tax credit, many 1 providers trained eligible students, but only a small subset met 2 3 the eligibility requirements due to the primary care qualifying 4 criterion for the preceptor.

Thus, the legislature recognizes that programs training 5 physicians, advanced practice registered nurses, pharmacists, 6 7 and physician assistants in primary care also require training 8 from specialty preceptors who support primary care, in addition 9 to training from primary care providers. The legislature 10 further recognizes that the healthcare workforce has shortages that extend beyond the current professions included in the tax 11 12 credit whose workforce expansion is also limited by available preceptors, including social workers, physician assistants, and 13 14 registered dieticians. The legislature also finds that the definition of "volunteer-based supervised clinical training 15 rotation" may be clarified to facilitate the preceptor credit 16 17 assurance committee's implementation of the tax credit.

Therefore, the purpose of this Act is to: 18 19 Amend the definitions of "preceptor" and "volunteer-(1) based supervised clinical training rotation" to

17 "Eligible student" means an advanced practice registered
18 nurse student, medical student, [or] pharmacy student, physician

20 who is enrolled in an academic program.

"Medical student" means an individual participating in a 1 nationally accredited academic program leading to the medical 2 doctor or doctor of osteopathy degree. "Medical student" 3 includes graduates from nationally accredited academic programs 4 who have continued their training, in the role of resident or 5 6 fellow, to obtain the additional qualifications needed for 7 medical licensure, pursuant to chapter 453, or specialty certification. 8

"Nationally accredited" means holding an institutional 9 accreditation by name to offer post-secondary medical primary 10 care education. Accreditation for medical students shall be 11 12 offered by the Liaison Committee on Medical Education or American Osteopathic Association Commission on Osteopathic 13 College Accreditation. Accreditation for advanced practice 14 15 registered nurse students shall be offered by the Commission on Collegiate Nursing Education. Accreditation for pharmacy 16 17 students shall be offered by the Accreditation Council for 18 Pharmacy Education. Accreditation for physician assistant students shall be offered by the Accreditation Review Commission 19 on Education for the Physician Assistant, Inc. Accreditation 20 21 for social work students shall be offered by the Council on

8 "Physician assistant student" means an individual 9 participating in an academic program that is nationally 10 accredited for the education of physician assistants to become a 11 nationally certified and licensed physician assistant pursuant 12 to section 453-5.3. 13 "Preceptor" means a physician [or], osteopathic physician, or physician assistant, licensed pursuant to chapter $453[_{7}]$; an 14 15 advanced practice registered nurse, licensed pursuant to chapter 457[,]; licensed dietician, licensed pursuant to 448B; social 16 17 worker, licensed pursuant to chapter 467E; or a pharmacist, licensed pursuant to chapter 461, who is a resident of Hawaii 18 19 [and who], maintains a professional [primary care] practice in

20 [this] the State[-], and whose specialty supports the

21 development and training of an eligible student in primary care.

"Primary care" means the principal point of continuing care for patients provided by a healthcare provider, including health promotion, disease prevention, health maintenance, counseling, patient education, diagnosis and treatment of acute and chronic illnesses, and coordination of other specialist care that the patient may need.

7 <u>"Social work student" means an individual participating in</u>
8 an academic program that is nationally accredited for the
9 training of individuals to become a social worker licensed
10 pursuant to chapter 467E.

"Volunteer-based supervised clinical training rotation" 11 12 means [an-uncompensated] a period of supervised clinical 13 training [of] to an eligible student that totals at least eighty 14 hours of supervisory time annually, in which a preceptor 15 provides personalized instruction, training, and supervision to 16 an eligible student to enable the eligible student to obtain an 17 eligible professional degree or training certificate [-]; provided that, while a preceptor may be compensated for 18

19 providing standard clinical services, the preceptor shall be:
