

A BILL FOR AN ACT

RELATING TO PUBLIC SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the youth vaping
- 2 epidemic is the result of evolved tobacco products. The
- 3 legislature further finds that the existing statutory
- 4 prohibition on tobacco in public schools may be narrowly
- 5 construed to not account for the growing sector of new
- 6 electronic smoking devices that deliver nicotine to youth.
- 7 While the United States Food and Drug Administration has
- 8 classified vapes and electronic cigarettes as tobacco products,
- 9 the existing statutory prohibition is vague as to whether the
- 10 prohibition extends to such devices.
- 11 The legislature additionally finds that the existing
- 12 statutory prohibition on tobacco in public schools extends only
- 13 to the use of tobacco, not the possession. This oversight
- 14 allows students to be in possession of tobacco without being in
- 15 violation of the existing statutory prohibition. Such a result
- 16 is incongruous with the intent of prohibiting youth from
- 17 accessing tobacco, as evidenced by the provision prohibiting the

- 1 possession of tobacco products and electronic smoking devices
- 2 under the Hawaii Penal Code.
- Accordingly, the purpose of this Act is to update and
- 4 expand the statutory prohibition on the use of the tobacco at
- 5 public schools to be a prohibition on the possession and use of
- 6 tobacco products and electronic smoking devices.
- 7 SECTION 2. Section 302A-102, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "§302A-102 [Smoking] Tobacco products and electronic
- 10 smoking devices prohibited. (a) All public schools within the
- 11 State, from kindergarten through grade twelve, shall prohibit
- 12 the possession and use of tobacco products and electronic
- 13 smoking devices at public schools or at public school functions.
- 14 (b) For purposes of this section:
- "Electronic smoking device" has the same meaning as defined
- 16 in section 712-1258.
- "Tobacco product" has the same meaning as defined in
- 18 section 712-1258."
- 19 SECTION 3. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.
- 21 SECTION 4. This Act shall take effect on July 1, 2023.
