#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTI	ON 1. Chapter 711, Hawaii Revised Statutes, is

4	" <u>§711</u>	- Loitering in or obstructing school-zoned
5	property;	radius. (1) A person commits the offense of
6	loitering	in or obstructing school-zoned property if during
7	school hou	rs, the person:
8	<u>(a)</u>	Loiters in any school-zoned property; or
9	<u>(b)</u>	Intentionally or knowingly stands, sits, or lies on a
10		school-zoned property in a manner that obstructs
11		access to or use of a building, walkway, public
12		passage, road, highway, sidewalk, or structure on a
13		school-zoned property.
14	(2)	The prohibitions in subsection (1) shall not apply to:
15	<u>(a)</u>	Any student enrolled at the school within the
16		school-zoned property;

1	<u>(b)</u>	Any person transporting a student attending the school
2		or schools within the school-zone property;
3	<u>(c)</u>	Any person standing, sitting, or lying due to a
4		medical emergency;
5	<u>(d)</u>	Any person who, as a result of a disability, is
6		utilizing a wheelchair or other, similar wheeled chair
7		device to move about within two hundred feet from a
8		<pre>school;</pre>
9	<u>(e)</u>	Any person standing, sitting, or lying for the purpose
10		of engaging in an expressive activity;
11	<u>(f)</u>	Any person standing or sitting while attending or
12		viewing any festival, performance, rally,
13		demonstration, or similar event conducted on a
14		sidewalk or nearby area pursuant to a permit issued by
15		the appropriate authority;
16	<u>(g)</u>	Any person engaged in a maintenance, repair, or
17		construction activity on behalf of a governmental
18		entity or a public utility;
19	<u>(h)</u>	Any child who is sitting or lying in a baby carriage,
20		stroller, carrier, or similar device, to move about

2		there by a public agency;
3	<u>(j)</u>	Any person standing or sitting in line to receive
4		goods or services; or
5	<u>(k)</u>	Any person engaging in an authorized activity pursuant
6		to a permit issued by the appropriate authority.
7	(3)	No person shall be deemed to have violated this
8	section u	nless the person engages in conduct prohibited by this
9	<u>section a</u>	fter being notified by a law enforcement officer that
10	the condu	ct violates this section.
11	(4)	For purposes of this section:
12	<u>"Exp</u>	ressive activity" means speech or conduct, the
13	principal	object of which is the expression, dissemination, or

1	"School hours" means Monday through Friday from 7:00 a.m.
2	until 4:00 p.m., excluding days when classes are not in session.
3	"School-zoned property" means any public school property or
4	any public property within a two-hundred-foot radius of a public
5	school property.
6	(5) Loitering in or obstructing school-zoned property is a
7	petty misdemeanor."
8	SECTION 2. This Act does not affect rights and duties that
9	matured, penalties that were incurred, and proceedings that were
10	begun before its effective date.
11	SECTION 3. New statutory material is underscored.
12	SECTION 4. This Act shall take effect on January 1, 2025.
