# A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII PROMISE PROGRAM.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the cost of
- 2 attendance remains a significant barrier for many of Hawaii's
- 3 residents pursuing higher education.
- 4 In the 2021-2022 academic year, 5,590 students from the
- 5 Manoa, Hilo, and West Oahu four-year campuses experienced a gap
- 6 between the direct cost of their education and what was provided
- 7 by scholarships or grants. For these three universities, unmet
- 8 need totaled \$14,112,400. These students averaged a gap of
- 9 \$2,524.58 that could not cover the entirety of the costs
- 10 associated with tuition, fees, books, supplies, and
- 11 transportation.
- 12 In 2017, the university of Hawaii implemented the Hawaii
- 13 promise program, which provides need-based awards intended to be
- 14 applied toward the unmet need of qualified students enrolled at
- 15 any community college campus of the university of Hawaii.
- 16 Awards are contingent upon funding. Amounts are determined by
- 17 the individual student's Free Application for Federal Student

- 1 Aid information. Evidence from the early implementation of the
- 2 Hawaii promise program demonstrates that students who receive
- 3 the funding earned more credits and continued toward graduation
- 4 at a higher rate than students who did not receive the funding.
- 5 Even though financial aid provided by federal Pell grants,
- 6 university of Hawaii and private scholarships, the GI Bill for
- 7 service members and veterans, and employers covers much of the
- 8 cost for need-based students, cost is still a barrier for
- 9 certain need-based students, especially those who do not qualify
- 10 for the Hawaii promise program because they are enrolled at one
- 11 of the university of Hawaii's four-year campuses.
- 12 The legislature further finds that an educated labor force
- 13 and engaged citizenry are essential in today's global,
- 14 knowledge-based economy. Thus, increasing the number of
- 15 students who enroll and earn degrees, particularly those from
- 16 underserved regions and populations, to prepare them for success
- 17 in the workforce and their communities is a matter of statewide
- 18 concern. However, according to the most recent data available,
- 19 only forty-eight per cent of Hawaii's working-age adults have a
- 20 postsecondary degree.

- 3 [\(\frac{(d)}{}\)] (e) To maintain a scholarship under this section, a
- 4 student shall meet the requirements of subsection (b) (4) [-] or
- 5 (c) (4), as applicable.
- 6 [<del>(e)</del>] (f) As used in this section, "direct cost" means any
- 7 cost directly related to a student's education, including
- 8 tuition; educational fees; and the costs of books, supplies, and
- 9 transportation between the student's dwelling and the student's
- 10 campus."
- 11 SECTION 3. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2024-2025 to
- 14 carry out the purposes of this Act, including the provision of
- 15 scholarships.
- 16 The sum appropriated shall be expended by the university of
- 17 Hawaii for the purposes of this Act.
- 18 SECTION 4. In accordance with section 9 of article VII of
- 19 the Hawaii State Constitution and sections 37-91 and 37-93,
- 20 Hawaii Revised Statutes, the legislature has determined that the
- 21 appropriations contained in H.B. No. , will cause the state

- 1 general fund expenditure ceiling for fiscal year 2024-2025 to be
- 2 exceeded by \$ or per cent. In addition, the
- 3 appropriation contained in this Act will cause the general fund
- 4 expenditure ceiling for fiscal year 2024-2025 to be further
- 5 exceeded by \$ or per cent. The combined total
- 6 amount of general fund appropriations contained in only these
- 7 two Acts will cause the state general fund expenditure ceiling
- **8** for fiscal year 2024-2025 to be exceeded by
- 9 \$ or per cent. The reasons for exceeding the
- 10 general fund expenditure ceiling are that:
- 11 (1) The appropriation made in this Act is necessary to
- serve the public interest; and
- 13 (2) The appropriation made in this Act meets the needs

- 15 SECTION 5. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 6. This Act shall take effect on July 1, 3000.
