12 The purpose of this Act is to relieve from the burden of 13 filing annual reports and paying the corresponding annual \$50 14 filing fee those individual homeowners whose development 15 consists of not more than two units, one in which the developer 16 resides and one for which the initial sale of the other unit has 17 been completed.
