# A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that repricing is the 2 reassignment of an existing class from one pay range to another 3 without a change in duties when it has been found that the class 4 is not in proper internal alignment with other classes in the 5 same bargaining unit. Act 253, Session Laws of Hawaii 2000, 6 repealed chapter 77, Hawaii Revised Statutes, regarding the 7 state compensation law, and with it, the public employee 8 compensation appeals board that heard and made decisions on 9 repricing requests. In its place, the Act established the 10 repricing processes in section 89-9, Hawaii Revised Statutes, in 11 which the exclusive representative may negotiate the repricing 12 of classes. If repricing is not negotiated, a five-year 13 periodic repricing review is conducted by each jurisdiction. 14 The purpose of this Act is to require the department of 15 human resources development to:

16 17 (1) Conduct a study to review the repricing processes in section 89-9, Hawaii Revised Statutes; and

1 (2)Submit a report to the legislature prior to the convening of the regular session of 2024. 2 3 SECTION 2. The department of human resources (a) 4 development shall conduct a study to review the repricing 5 processes in section 89-9, Hawaii Revised Statutes. 6 (b) The study shall review the various repricing 7 mechanisms available in section 89-9, Hawaii Revised Statutes, to determine if existing repricing review processes are adequate 8 9 and appropriate. In conducting the review, the department of 10 human resources development shall consider a process that best 11 ensures equal pay for equal work as mandated in section 76-1, 12 Hawaii Revised Statutes, and maintains a consistent system to 13 evaluate repricing requests so that the employer can comply with 14 federal and state laws that prohibit discrimination in 15 employment. 16 (C) The department of human resources development shall 17 invite the following organizations to participate in the study: 18 (1) Representatives from each of the counties, Hawaii 19 health systems corporation, judiciary, and department
