BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 329, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§329- Tableting and encapsulating machines; sale;
5	possession. (a) Except as provided in subsection (b), it is
6	unlawful for any person to possess, purchase, deliver, sell, or
7	possess with intent to sell a tableting machine or encapsulating
8	machine if the person knows, or reasonably should know, that it
9	will be used to manufacture, compound, convert, produce,
10	process, prepare, or otherwise introduce into the human body a
11	controlled substance in violation of this chapter.
12	(b) This section shall not apply to:
13	(1) Any pharmacist or other authorized person who sells or
14	furnishes a substance upon the prescription of a
15	physician, dentist, podiatrist, or veterinarian;
16	(2) Any physician, dentist, podiatrist, or veterinarian
17	who administers or furnishes a substance to patients;

2		who sells, transfers, or otherwise furnishes a
3		substance to a licensed pharmacist, physician,

6		the State who is subject to the reporting requirements
7		of section 329-63 and who sells, transfers, receives,

11	(C)	For the purposes of this section, "encapsulating
12	machine"	and "tableting machine" shall mean any manual,

15	semisolid	material to produce coherent solid contents."
