A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that, under current
2	practices, solid waste may soon exceed landfill capacity in all
3	the State's counties. The State must, where feasible, reduce
4	waste production and conserve resources by reusing and refilling
5	packaging materials, diverting organic materials, and recycling.
6	Additional resources, facilities, and services will be needed to
7	achieve resource conservation and waste reduction targets and
8	reduce the counties' costs for waste management. Although most
9	packaging waste in Hawaii is handled in a linear manner, where
10	it is used and disposed of after a single use, the State needs a
11	more circular system where resources are reused and not wasted.
12	The legislature further finds that several other states
13	have adopted or are considering legislation to require producers
14	of packaging to take on some of the responsibility and bear some
15	of the costs of reducing and managing packaging materials and

State and county governments, packaging producers, and the 2 community need to work together with stakeholders to reduce the amount of waste produced in Hawaii and ensure that services are 3 available to reclaim and recycle products when they reach the 4 5 end of their useful life. 6 The purpose of this Act is to require and appropriate funds 7 for the department of health to conduct a statewide needs 8 assessment and establish an advisory council with relevant 9 stakeholders to determine what would be needed to transition to 10 a more circular system with less waste generation, more reuse, 11 and the necessary infrastructure to sort and locally process 12 recyclable materials through an extended producer responsibility 13 program for packaging materials and paper products. 14 SECTION 2. (a) The department of health shall conduct a 15 statewide needs assessment to determine what will be needed to 16 transition to a more circular system with less waste generation, 17 more reuse, and improved collection and local processing of 18 materials through an extended producer responsibility program 19 for packaging materials and paper products. The assessment 20 shall be conducted by the department in consultation with the 21 following stakeholders:

1	(1)	Each county department responsible for waste
2		management;
3	(2)	Global and national producer responsibility
4		organizations, including producer responsibility
5		organizations actively working on reusable packaging
6		systems;
7	(3)	Producers of packaging materials and paper products;
8	(4)	Refuse and recycling collection and processing service
9		providers;
10	(5)	Compost facility operators;
11	(6)	Retailers, including restaurants; wholesalers; and
12		distributors;
13	(7)	Organizations and community groups involved with waste
14		management and waste reduction;
15	(8)	Organizations or community groups representing the
16		native Hawaiian community;
17	(9)	Environmental justice organizations; and
18	(10)	Environmental and human health scientists;
19	provided	that additional stakeholders may be included as the
20	departmer	nt deems necessary and relevant.

1	(d)	The department shall convene an advisory council to
2	review th	e draft needs assessment and propose recommendations
3	throughou	t the assessment process. The department shall also
4	hold a pu	blic hearing to obtain comments on a draft needs
5	assessmen	t plan. The advisory council shall include:
6	(1)	One representative from each county department
7		responsible for waste management;
8	(2)	One representative from a national producer or
9		producer trade association;
10	(3)	One representative from a Hawaii based producer or
11		producer association;
12	(3)	Two representatives who are experts or operators of
13		reuse, refill, or circular economy systems;
14	(4)	One representative from a Hawaii based refuse service
15		provider;
16	(5)	One representative from a Hawaii based recycling
17		collection and processing service provider;
18	(6)	One representative from a Hawaii based retailer,
19		including restaurants; wholesaler; or distributor;
20	(7)	Two representatives from Hawaii based organizations
21		and community groups involved with waste management;

1	(8)	One representative from the native Hawaiian community
2		or environmental justice community; and
3	(9)	One representative who is an environmental or human
4		health scientist.
5	(c)	The needs assessment shall detail the resources
6	required i	in each county to reduce as much as feasible the
7	packaging	materials waste and paper products that the county
8	sends to a	a landfill or power plant that burns municipal solid
9	waste. Ac	dditionally, the needs assessment shall consider the
10	following:	
11	(1)	Waste and recycling characterizations, including
12		baseline studies of what is in the waste stream, what
13		is being recycled, what is being composted, and how
14		these vary across local jurisdictions;
15	(2)	Existing collection infrastructure, including:
16		(A) What materials are being collected and the
17		processes and procedures for collection;
18		(B) Who currently has access to refuse, recycling,
19		and composting collection services;
20		(C) How collection services are arranged and funded;
21		and

1		(D) Improvements in services needed;
2	(3)	Processing and materials recovery facility
3		infrastructure, including:
4		(A) How collected materials are currently being
5		processed and marketed;
6		(B) Whether the sorting technology is up to date;
7		(C) Whether there is sufficient capacity to process
8		the volume of materials;
9		(D) Opportunities and infrastructure needed for more
10		local processing of materials; and
11		(E) Costs to implement infrastructure improvements;
12	(4)	Markets, including the state of markets for recovered
13	·	materials and finished compost;
14	(5)	Education, including the effectiveness of the existing
15		outreach in educating residents;
16	(6)	Levels of contamination in collected packaging
17		materials and organics for composting;
18	(7)	The impact of the composition of packaging materials
19		on the reuse, recyclability, and compostability of
20		packaging materials;

(0)	An evaluation of now extended producer responsibility
	program laws are designed and working in other states
	and countries;
(9)	An evaluation of an appropriate definition of
	"producer" for an extended producer responsibility
	program in Hawaii;
(10)	Equity and environmental justice, including:
	(A) Consideration for how the existing system is
	operating and how extended producer
	responsibility could increase equity; and
	(B) An assessment of equity issues in education
	efforts;
(11)	Economic impact, including estimates in job
	development from increased reuse, recycling, and
	composting;
(12)	Environmental benefits from reduction and reuse and
	local versus off-island materials processing;
(13)	How extended producer responsibility can promote
	upstream improvement such as source reduction,
	packaging redesign and optimization, reduction of
	packaging materials that are harmful to human health

1		or the environment, and reuse and refill practices,
2		including:
3		(A) Identifying opportunities for source reduction,
4		reuse, and refill in packaging systems; and
5		(B) Cost and infrastructure needs to implement these
6		systems; and
7	(14)	Suggested diversion targets and timeline using
8		baseline data from the needs assessment to determine
9		the resources, infrastructure, educational program,
10		and other initiatives needed to reach conservative,
11		moderate, and aggressive waste reduction goal
12		scenarios.
13	(d)	The department of health shall complete and submit the
14	needs ass	essment, including any proposed legislation, to the
15	legislatu	re by December 31, 2026.
16	(e)	For the purposes of this section:
17	"Pac	kaging materials" includes materials used for the
18	containme	nt, protection, or serving of products, including but
19	not limit	ed to paper, paperboard, cardboard, plastics, glass, or
20	metal, or	a mixture of any of these materials. "Packaging

- 1 materials" excludes beverage containers included under the
- 2 Hawaii deposit beverage container program.
- 3 "Paper products" includes printed materials such as office
- 4 paper, magazines, newspaper, and junk mail. "Paper products"
- 5 does not include literary, text, and reference bound books.
- 6 "Producer" means an entity that sells packaging materials
- 7 into the market and can include a brand owner, licensee, or
- 8 first importer.
- 9 "Refill" means employing packaging materials that consumers
- 10 reuse.
- "Reuse" means the return of or to return packaging
- 12 materials to the economic stream for use in the same kind of
- 13 application intended for the original packaging without changing
- 14 the original composition of the package, the identity of the
- 15 product, or the components thereof.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2024-2025 for
- 19 the department of health to conduct a statewide needs
- 20 assessment, pursuant to section 2 of this Act, to inform the

- 1 future establishment of an extended producer responsibility
- 2 program.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 4. In accordance with section 9 of article VII of
- 6 the Hawaii State Constitution and sections 37-91 and 37-93,
- 7 Hawaii Revised Statutes, the legislature has determined that the
- 8 appropriations contained in H.B. No. , will cause the state
- 9 general fund expenditure ceiling for fiscal year 2024-2025 to be
- 10 exceeded by \$ or per cent. In addition, the
- 11 appropriation contained in this Act will cause the general fund
- 12 expenditure ceiling for fiscal year 2024-2025 to be further
- 13 exceeded by \$ or per cent. The combined total
- 14 amount of general fund appropriations contained in only these
- 15 two Acts will cause the state general fund expenditure ceiling
- 16 for fiscal year 2024-2025 to be exceeded by
- 17 \$ or per cent. The reasons for exceeding the
- 18 general fund expenditure ceiling are that:
- 19 (1) The appropriation made in this Act is necessary to
- serve the public interest; and

- (2) The appropriation made in this Act meets the needs
 addressed by this Act.
- 3 SECTION 5. This Act shall take effect on July 1, 3000.
